Independent Auditor's Report

Opinion

We have audited the financial statements of Leanin' Tree Employee Stock Ownership Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets (deficit) available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets (deficit) available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management's estimates are based on an independent appraisal using management projections and market data. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Note 1 - Plan Description

The following description of Leanin' Tree Employee Stock Ownership Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

Dream Ranch Holdings Co. (the "Company") established the Plan effective January 1, 2021. The Plan operates as a leveraged employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986 (IRC), as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by the plan administrator appointed by the Company, and an independent third party is the Plan's trustee.

In December 2021, the Plan purchased shares of company common stock using the proceeds of a note payable (see Note 6) and holds the common stock in a trust established under the Plan. As the Plan makes debt payments, an appropriate percentage of stock will be allocated to eligible employees' accounts in accordance with applicable regulations under the IRC.

The borrowing is collateralized by the unallocated shares of stock and is guaranteed by the Company. The lender has no rights against shares of the stock once they are allocated to participants in accordance with the terms of the ESOP. Accordingly, the statement of net assets (deficit) available for benefits as of December 31, 2024 and 2023 and the statement of changes in net assets (deficit) available for benefits for the year ended December 31, 2024 present separately the assets and liabilities and changes therein pertaining to accounts of participants with vested rights in allocated common stock (allocated) and common stock not yet allocated to participants (unallocated).

The Plan covers all eligible employees of the Company. Employees are eligible to participate in the Plan if they have completed one year of service and have attained the age of 18 years or older. A year of service for the purpose of eligibility is a consecutive 12-month period during which the employee has 1,000 or more hours of service. Leased employees, collective bargaining employees, and nonresident aliens are not eligible to participate in the Plan.

Contributions

The Company is obligated to make contributions in cash to the Plan, which, when aggregated with the Plan's dividends (if any) and interest earnings, equal the amounts necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loan. Employee contributions are not permitted.

Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the trustee prior to the time that such rights are to be exercised. The trustee is permitted to vote any allocated share for which instructions have not been given by a participant. The trustee is required, however, to vote any unallocated shares on behalf of the collective best interest of plan participants and beneficiaries.

Put Option

Under federal income tax regulations, employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Note 1 - Plan Description (Continued)

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each plan year with an allocation of shares of company common stock released by the trustee from the unallocated account and forfeitures of terminated participants' nonvested accounts. Employees must have 1,000 hours during the plan year and be employed on the last day of the plan year to share in the allocation of contributions. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation. Allocations are based on a participant's eligible compensation relative to total eligible compensation. Plan earnings and losses are allocated to each participant's account based on the ratio of the participant's account balance.

Forfeitures

At December 31, 2024 and 2023, there were no balances in the forfeited nonvested account, as all forfeitures are used in the same year they are forfeited. Forfeited accounts are used to reduce employer contributions or allocated to eligible participants. During the year ended December 31, 2024, forfeited nonvested balances totaling \$2,028 were allocated to eligible participants. Allocations are based on a participant's eligible compensation relative to the total eligible compensation of the Plan for the year.

Vesting

The Company's discretionary contributions, if any, vest according to the following schedule:

Participants are 100 percent vested in their account balances upon death, disability, or achieving normal retirement age (age 65) while employed by the Company.

Payment of Benefits

Participants may elect to receive a distribution in the amount equal to the value of their interest, as defined in the plan document, upon retirement, termination of employment, death, or disability. If a participant's distribution is for normal retirement, disability, or death, the participant's distribution is made as soon as administratively feasible after the close of the plan year. If the participant's distribution is for a reason other than death, disability, or retirement, the participant may elect to begin to receive a distribution commencing by the end of the sixth plan year following the date of termination.

If the participant's account balance is less than \$5,000, a distribution will occur after the plan year in which the employee terminates. In the event of a distribution greater than \$1,000 to a participant without the participant's consent, the plan administrator will pay the distribution in a direct rollover to an individual retirement plan designated by the plan administrator unless otherwise directed by the participant.

Note 1 - Plan Description (Continued)

Distributions under the Plan can be made with cash, shares of company common stock, or a combination of company common stock and cash at the discretion of the plan administrator. Distributions made upon retirement or termination of employment are made substantially equal annual installments over five years if the vested account balance is equal to or less than \$1,380,000. For vested balances over \$1,380,000, the Company may extend the payment for an additional year over the five years for every \$275,000 over the \$1,380,000, up to an additional five years. Distributions made in the event of death or disability are made by the last day of the plan year following the plan year in which the participant terminated due to death or disability.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investments in company common stock into investments that are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their accounts. Diversification is offered to each eligible participant over a 6-year period. In each of the first 5 years, a participant may diversify up to 25 percent of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. The election to diversify is made subsequent to year end based upon the shares of employer stock in the participant's account at year end. During 2024, there were no participants eligible for diversification.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts. Upon termination of the plan, the ESOP committee directs the trustee to pay all liabilities and expenses of the ESOP and to sell shares of financed company common stock held as collateral to the extent it determines such sale will be necessary in order to repay the loan. Subsequently, the interest of each participant will be distributed to such participant or his or her beneficiary at the time prescribed by the plan terms and the IRC.

Party-in-interest Transactions

The Plan invests in company common stock and has indebtedness with or guaranteed by the Company. These are related party and party-in-interest transactions.

Risks and Uncertainties

The Plan's investments consist primarily of company common stock, which is exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the Plan's investment in the company common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the company common stock will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Note 2 - Summary of Significant Accounting Policies

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. The most significant assumptions and estimates relate to the valuation of company common stock. Application of these assumptions requires the exercise of judgment as to future uncertainties and, as a result, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 10, 2025, which is the date the financial statements were available to be issued.

Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset. Significant Level 3 inputs included expected future cash flows, a terminal value, discount rates using the weighted-average cost of capital, and market multiples based on market model methods.

The fair value of company common stock held in the Plan is valued at estimated fair value based on an independent appraisal. The appraisal was based upon a combination of the market and income valuation techniques consistent with prior years. The appraiser took into account historical and projected cash flow and net income; discount rates; return on assets; return on equity; market comparables; and estimated fair value of company assets and liabilities, including certain discounts.

The fair value of interest-bearing cash is based on its outstanding balance.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

There were no unfunded commitments or redemption restrictions on the investments described above.

Note 5 - Tax Status

The Plan has received a determination letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for tax-exempt treatment under the applicable section of the Internal Revenue Code. Accordingly, no provision for income taxes has been made in the accompanying financial statements.

Note 6 - Note Payable - Company

In December 2021, the Plan entered into a \$7,000,000 term loan agreement with the Company in exchange for 1,000,000 shares of company common stock to be repaid over a period of 25 years. The proceeds of the loan were used to purchase company common stock. Unallocated shares are collateral for the loan. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is the number of shares held as collateral multiplied by the ratio of the current year's payments, divided by the total of the current year's payments, plus all future years' principal and interest payments. This resulted in 36,783 shares being released and allocated for the plan year ended December 31, 2024.

The balance due on the note payable as of December 31, 2024 and 2023 was \$5,392,561 and \$5,599,977, respectively. The loan agreement bears interest at 1.90 percent and provides for the loan to mature on December 31, 2045. Minimum principal payments on this loan to maturity are as follows:
