Note 1 - Plan Description

The following description of the Toshiba America, Inc. 401(k) Savings Plan (the Plan) is provided for general information only. Participants should refer to the plan document for more detailed information.

General

The Plan is a defined contribution plan covering all eligible employees of Toshiba America, Inc. (the Company and plan administrator) and participating employers (collectively, the Employers). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was adopted by the Company on January 1, 1994, and has been amended and restated from time to time. T. Rowe Price Trust Company (T. Rowe Price) serves as the Plan's trustee.

Eligibility and Contributions

Eligible employees, as defined, may enter the Plan on the later of their date of hire or attainment of 21 years of age. The Plan includes a savings feature designed to permit employees and the Employers to contribute to the Plan, as allowable under Section 401(k) of the Internal Revenue Code (IRC). Participants may also make rollover contributions to the Plan from other qualified plans and certain other qualified sources as defined in the plan document.

Employee contributions are made to the Plan on a pre-tax or Roth basis by electing to defer up to the lesser of 75% of the employee's compensation or the dollar limit established on an annual basis by the Internal Revenue Service (IRS). Employees who have reached age 50 by the close of the plan year are eligible to make catch-up contributions in accordance with the IRC.

Upon meeting the eligibility requirements, employees automatically begin deferring 6% of their compensation for each payroll period, unless an affirmative election not to contribute or to contribute at a different percentage is made by the employee. The contributions are pre-tax deferrals unless the employee affirmatively designates that any portion or all of the contributions be treated as Roth contributions. On July 1st of each year, the automatic deferral percentage increases by 1% each year up to a maximum of 15%, unless otherwise instructed by the employee.

Employers make matching contributions to all eligible participants in an amount equal to 100% of the participants' deferrals. The limit of matching contributions as a percentage of compensation is determined on an employer-by-employer basis, but in no circumstance may exceed 6% of the participant's compensation. The Plan provides for an annual true-up matching contribution for participants who are employed as an eligible employee at any point during the last payroll period of the plan year. For the year ended December 31, 2024, the Employers made true-up contributions of approximately \$205,000.

The Employers of the Plan may elect to make non-elective contributions on an employer-by-employer basis. For the year ended December 31, 2024, the Employers did not make any non-elective contributions.

Vesting

Participants are fully vested in their employee contributions and earnings thereon at all times. With the exception of certain grandfathered employer contributions and earnings thereon as further described in the plan document, participants are always 100% vested in contributions made by the Employers and earnings thereon.

Forfeitures

Forfeitures are to be used either to pay administrative expenses of the Plan or to reduce future contributions made by the Employers. At December 31, 2024 and 2023, the forfeiture balance was \$1,309 and \$1,055, respectively. For the year ended December 31, 2024, no forfeitures were utilized to pay administrative expenses or to reduce contributions made by the Employers.

Participant Accounts

Separate accounts are maintained for each participant. Upon enrollment in the Plan, a participant may direct the investment of his or her account balance. Participants may change their investment options at any time.

Investment earnings and losses are allocated daily to participant accounts in the same ratio as the participant's investment in each fund bears to the total of all participants' investments in each fund.

Notes Receivable from Participants

Notes receivable from participants are loans to participants secured by the vested portion of their accounts as prescribed in the plan document. The loans bear interest at rates similar to the rates available at commercial lending institutions and are determined by the plan administrator. The loans are repaid through payroll deductions. Loans may not exceed the lesser of \$50,000 reduced by the highest outstanding loan balance during the preceding 12 months or 50% of the participant's vested balance. Loan terms are limited to five years unless for the purchase of a principal residence. Loans for the purchase of a principal residence are limited to terms of 10 years. Participants may only have one loan outstanding at a time.

Benefit Payments

Distributions may be made to participants upon termination of employment with all Employers, disability, retirement, or death. In-service distributions are allowed for participants who have reached the age of 59½, upon demonstration of financial need as well as for other permitted reasons as outlined in the plan document. If a participant's vested account balance was greater than \$5,000, the participant could choose to leave their vested balance in the Plan and defer distribution until a future date. For participants who terminate with a vested account balance of less than \$5,000, T. Rowe Price will make a direct rollover into an individual retirement account. Upon withdrawal from the Plan or termination of employment, participants may be subject to tax on contributions and income earned.

Note 2 - Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP). Accounting principles followed by the Plan and methods of applying those principles are summarized below:

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes realized gains or losses on investments sold during the year as well as unrealized gains or losses on the investments held at the end of the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as the notes are collateralized by the participants' account balances. Interest income is recorded on the accrual basis. In general, notes receivable from participants are considered in default in the calendar quarter following the quarter in which no payment is made. Defaulted loans are accounted for as distributions based upon the terms of the plan document when a distributable event has occurred.

Benefit Payments

Benefits paid to participants or their beneficiaries are recorded when paid.

Administrative Expenses

Administrative expenses are paid by the Plan unless paid by the Employers at their discretion.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Risks and Uncertainties

The Plan provides for investments in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investments will occur in the near term and may impact participant account balances and the amounts reported in the financial statements.

Subsequent Events

The plan administrator evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 10, 2025, which is the date the financial statements were available to be issued. See Note 9.

Note 3 - Information Certified by the Plan's Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator has obtained certifications from T. Rowe Price as of December 31, 2024 and 2023 and for the year ended December 31, 2024, that all of the information provided is complete and accurate. Information included in the accompanying financial statements, the notes to the financial statements and the supplemental schedule of assets (held at end of year) regarding investments, notes receivable from participants, investment income and interest income on notes receivable from participants is presented solely in reliance upon these certifications.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements, the accompanying notes to the financial statements, and the supplemental schedule of assets (held at the end of year).

Note 4 - Fair Value Measurements

GAAP provides a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: These investments are valued based upon their quoted market prices.

Common/Collective Trust Funds: These investments are valued at their net asset value (NAV) as reported by the issuer based on quoted market prices of the underlying investments, when available, net of certain expenses. The NAV is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the investment will be sold for an amount different than the reported NAV.

Note 5 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the plan document to discontinue contributions made by the Employers and to terminate the Plan subject to the provisions of ERISA. In the event of a complete termination of the Plan, participants shall be fully vested in all amounts allocated to their accounts, and such amounts will be distributed.

Note 6 - Federal Income Tax

The Plan received a determination letter from the IRS dated May 18, 2012, stating that it was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving its IRS letter; however, the plan administrator believes that the Plan continues to be designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and to recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Party-in-Interest Transactions

Certain investments of the Plan are issued by T. Rowe Price or an affiliate, and therefore, these transactions qualify as party-in-interest transactions. These transactions are covered by an exemption from the "prohibited transaction" provisions of ERISA and the IRC.

Note 8 - Nonexempt Prohibited Transactions

As reported on supplemental Schedule H, Line 4a - Schedule of Delinquent Participant Contributions for the year ended December 31, 2024, there were \$106,686 of participant contributions and participant loan repayments relating to the 2024 plan year that were not remitted to the Plan within the time frame specified by the DOL's Regulation 29 CFR 2510.3-102, thus constituting a nonexempt prohibited transaction between the Plan and the Company. The participant contributions totaling \$98,788 and participant loan repayments totaling \$7,898 were remitted to the Plan prior to December 31, 2024. Management is in the process of calculating lost earnings relating to these untimely remittances and will remit them to the Plan as soon as administratively possible.

Note 9 - Subsequent Event

Effective April 1, 2025, Charles Schwab Trust Bank (Schwab) replaced T. Rowe Price as the Plan's trustee. In conjunction with the change, all of the Plan's assets were transferred to Schwab.
