1. Description of Plan

The following description of the Intercept Pharma 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Intercept Pharmaceuticals, Inc. (the "Company", "Employer" or "Plan Sponsor"). An employee becomes eligible to participate in the Plan on the first day of the month coincident with or following obtaining 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

In November of 2023, Alfasigma S.p.A., through its wholly owned subsidiary Interstellar Acquisition Inc., completed its acquisition of the Plan Sponsor. As a result of the transaction, the common stock of the Plan Sponsor has ceased to be traded on the NASDAQ.

Contributions

Participants may elect to have a percentage deducted from their eligible compensation on a pre-tax or after-tax (Roth) basis. A participant may elect to increase, decrease or suspend deductions according to procedures established by the Company. There is an annual limit as to the amount that can be deducted from compensation that is determined by the Internal Revenue Code ("IRC"). Participants may also contribute rollover contributions.

The Company may make discretionary matching contributions on behalf of those eligible participants who have made "salary deferral contributions and are employed on December 31st". The matching contribution will be an amount equal to a percentage of a participant's salary deferrals. For the year ended December 31, 2024, the Employer elected to make a discretionary matching contribution to the Plan equal to 100% of a participant's elective deferrals not to exceed 5% of eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Employer's contribution and Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments are participant directed.

Vesting

A participant in the Plan always has a fully vested interest in the value of his or her salary deferral contributions, rollover accounts, and earnings and losses thereon. A participant is fully vested in Employer matching contributions after one year of service. Participants with under one year of service are not vested.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$174,391 and \$205,567. Forfeitures are used to reduce Plan expenses or future Employer contributions. During 2024, \$199,876 of forfeitures were used to reduce Employer contributions and no forfeitures were used to reduce Plan expenses.

Payment of Benefits

Benefits are paid upon retirement (age 65), death, disability, or termination of employment. Upon termination of service, a participant may elect to receive a lump-sum amount equal to the vested value of the participant's account or an installment payment to be distributed under an option of the participant's choice, or a combination of both.

Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, cannot exceed the amount required to relieve the financial need.

Notes Receivable from Participants

The Plan offers a loan feature whereby a participant (borrower) may borrow a minimum amount of \$1,000 up to a maximum amount of 50% of his or her vested account balance or \$50,000 (whichever is less). Loans are collateralized by the balance in the participant's account and bear interest as determined at the time of loan origination. Principal and interest are paid ratably through payroll deductions. The loan must be repaid within a five-year period. A participant may not have more than one loan outstanding at any one time.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accounts of the Plan are maintained, and the accompanying financial statements have been prepared, on the modified cash basis; investment income is recognized when received and disbursements are recognized when made, except for investments which are reflected at fair value or contract value. Accordingly, the financial statements are not intended to present the net assets available for benefits and changes in net assets available for benefits of the Plan in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

The preparation of financial statements requires the plan administrator to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, all of the Plan's investments, that were valued at fair value, were valued using level 2 inputs.

Investment Valuation and Income Recognition

All of the Plan's investments are stated at fair value except for the guaranteed investment contract, which is stated at contract value. Separate accounts are stated at fair value and are reported at the value reported to the Plan by the insurance company, which represents the approximate fair value of the underlying investments comprising the accounts. The guaranteed investment contract is stated at contract value, which represents contributions plus credited interest less participant withdrawals and fees.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded when received. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded when a distributable event occurs.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 1, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in value of investments, interest income, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America (“Empower”), a qualified institution.

4. Insurance Company General Account

The Empower Annuity Insurance Company of America General Account (the “Account”) is a fully benefit-responsive investment option provided through a group annuity contract. Under the terms of the group annuity contract, a crediting interest rate is reset every quarter, semi-annual or annual basis and is based on the contract with Employer. Participants may direct permitted withdrawals and/or transfers of all or a portion of their account balances at contract value. While the group annuity contract is active, the Account is subject to competing fund transfer restrictions on participant-initiated transfers. Upon termination of the group annuity contract, if the Employer chooses a book value payout for termination, participant transfer restrictions may apply until the money is paid to the next provider.

Because the Account is benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Account.

Credit risk is the risk that an issuer or other counterparty to an investment will not fulfill its obligations. The credit risk of the trustee, Empower, is evaluated by nationally recognized statistical rating agencies. Empower’s financial ratings from these agencies are as follows: Moody’s Investors Service (Aa3 as of August 1, 2025), A.M. Best (A+ as of August 1, 2025), Standard and Poor’s (AA as of August 1, 2025), and Fitch Ratings (AA as of August 1, 2025).

5. Separate Accounts

The Plan offers separate accounts which have different investment objectives, investment policies, and risks. Each separate account invests in independently managed mutual funds, some of which invest in mutual funds managed by an affiliate of the Plan’s trustee. The name of each separate account corresponds to the name of the underlying fund in which it invests. The Plan’s separate accounts include various asset classes which are: index funds, growth funds, total return funds, opportunity funds, equity funds, real estate securities funds, value funds, high yield funds, and target retirement date funds.

6. Tax Status

The Company has adopted an approved volume submitter plan document which received an Internal Revenue Service (“IRS”) advisory letter dated November 14, 2022. The Company believes the Plan is designed and currently being operated in accordance with applicable sections of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

7. Party-in-Interest Transactions

All of the Plan’s investments are managed by Empower or an affiliate of Empower. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
