**Note 1 – Plan Description**

The following brief description of the Schanock Packerland Associates 401(k) Retirement Savings Plan (Plan) is provided for general information purposes only. Participants should refer to the plan document for more complete information of the Plan's provisions.

**General**

The Plan is a defined contribution pension plan covering substantially all employees of Schanock Packerland Associates, LLC, Schanochrist Foods, Inc., Schanock Enterprises, LLC, Schanock Howard, LLC, Schanock McSeymour, LLC, Schanock Airport, LLC, Schanock McPulaski, LLC, Schanock on Main, LLC, Schanock in Shawano, LLC, Schanock Investments and Allouez Restaurant Associates, LLC (Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The administrative committee is responsible for oversight of the Plan and for determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

Employees become eligible to participate in the Plan after completing twelve months of service and having attained age 21. The Plan entry dates are the first day of the first month and of the seventh month of the Plan year. To be eligible for Company contributions, the employee must be employed on the last day of the Plan year.

**Contributions**

Employee contributions are limited to thresholds set by the Internal Revenue Code. Participants may elect to contribute pretax or after tax amounts from their compensation. Participants who have obtained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Employees become eligible for discretionary Company contributions after completing twelve months of service with at least 1,000 hours and having attained age 21. Annually, the Company's discretionary contribution amount is determined based on the profitability of the Company. For the year ended December 31, 2024, the discretionary match was 100% of participant deferrals up to 2%.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, an allocation of the Company's discretionary contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in their voluntary contributions, rollover contributions, and all Company contributions received plus actual earnings on these contributions.

**Payment of Benefits**

On termination of service due to death, disability or retirement, a participant (or beneficiary) may elect to receive an amount equal to the value of the participant's interest in his or her account in either a lump-sum amount or in installment payments over a period not to extend beyond the participant's life expectancy. However, if the value of the benefit is less than \$5,000, a lump-sum distribution will be made regardless of whether or not an election has been made.

Participants that terminate employment prior to normal retirement age with account balances are not required to receive lump-sum distribution of such amount if the balance is over \$5,000. The participant has the right to defer distribution to at least normal retirement age. If the value of the benefit is under \$5,000, a lump-sum distribution will be made within a reasonable time frame after termination.

**Note 2 – Summary of Significant Accounting Policies**

The Plan's significant accounting policies consistently applied in the preparation of the accompanying financial statements follows:

**Basis of Accounting and Use of Estimates**

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest Income is recorded on the accrual basis. Dividends are recorded on the ex-dividend dates. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments. Fees related to the administration of payment of benefits are charged directly to the participant's account and are included in administrative expenses.

**Subsequent Events**

Subsequent events were evaluated through October 3, 2025, which is the date the financial statements were available to be issued.

**Note 3 – Tax Status of Plan**

The Plan adopted a Prototype Non-standardized Profit Sharing Plan with a cash or deferral arrangement. The prototype plan received a favorable determination letter from the Internal Revenue Service (IRS) dated June 30, 2020. As such, the Plan qualifies under Section 401(a) of the Internal Revenue Code (IRC) and, therefore, is not subject to tax under present income tax laws.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 4 – Related Party and Party-In-Interest Transactions**

Included in administrative fees are fees paid to the custodian by the Plan for the investment management and recordkeeping services for the year ended December 31, 2024.

**Note 5 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**Note 6 – Certified Investments**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Mid-Atlantic Trust Company.

**Note 7 – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1      Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.
  
- Level 2      Significant other observable inputs other than level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
  
- Level 3      Unobservable inputs that are significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**Note 7 – Fair Value Measurements (Continued)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trust Fund:* Valued at the net asset value (NAV) of units held by the trust at the end of the day of valuation based upon the market value of the underlying investments. The NAV readily determinable fair value was used since it was determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Thus, the trustee values these as level 2 investments. The trust has the ability to redeem its underlying investments at NAV at the valuation date.
