Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Seibels Employees' Profit Sharing and Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets as of December 31, 2024 (in liquidation) and 2023 (ongoing) and the related statement of changes in net assets (in liquidation) for the year ended December 31, 2024 and the related notes to the financial statements.

Emphasis of Matter

As discussed in Note 6 to the financial statements, the plan sponsor terminated the Plan effective December 31, 2024, and management determined that liquidation is imminent. As a result, the Plan changed its basis of accounting from the going concern basis of accounting used in presenting the December 31, 2023 financial statements to the liquidation basis of accounting used in presenting the December 31, 2024 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or that may become due to such participants.

Note 1 - Plan Description

The following description of Seibels Employees' Profit Sharing and Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Seibels Services Group, Inc. (the "Company") who are age 18 or older. Participants are automatically enrolled in the Plan as soon as administratively feasible after meeting the eligibility requirements above. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

As outlined in Note 6, the Company elected to terminate the Plan effective December 31, 2024 in connection with the dissolution and liquidation of the Company. Accordingly, the descriptions below are provisions of the Plan prior to termination. All contributions to the Plan were suspended effective December 31, 2024. Subsequent to year end, the Plan's assets were liquidated and distributed to participants.

Contributions

The Plan provides for employee salary deferral contributions up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Eligible employees are automatically enrolled in the Plan at a deferral rate of 4 percent of eligible compensation. An employee can avoid the automatic contribution by providing written notice indicating a preferred amount. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan provided for required safe harbor employer matching contributions of 100 percent of the participant's contribution, not to exceed 4 percent of the employee's deferred compensation. Effective May 18, 2024, the Plan was amended to remove the required safe harbor employer matching contribution. The Plan also allows for discretionary matching and profit-sharing contributions. During 2024, the Company did not contribute any discretionary matching or profit-sharing contributions.

Participant Notes Receivable

Participants may borrow from their accounts subject to certain maximum and minimum amounts prescribed in the Plan and in the Internal Revenue Code. Notes receivable bear interest at a market rate.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants are immediately 100 percent vested in employee salary, rollover contributions, the Company's safe harbor employer matching contributions, and any income or loss thereon. Vesting in the Company's discretionary matching and profit-sharing contribution portion of their accounts, plus actual earnings, is based on years of service. Participants vest in the discretionary matching and profit-sharing contributions made by the Company 33 percent after one year of service, an additional 33 percent after two years of service, and an additional 33 percent after three years of service, at which point they are 100 percent vested.

Note 1 - Plan Description (Continued)

During 2024 and 2023, the Company had a reduction in its workforce. If a partial termination has occurred, the terminated employees would become fully vested in their account balances at the time of their termination.

In connection with the Plan's imminent termination, all participants became 100 percent vested effective December 31, 2024.

Benefit Payments

Distributions are payable upon retirement, death, disability, termination of employment, or attainment of 59½ years of age in the form of a lump-sum amount equal to the vested balance of a participant's account.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited account balances totaled \$8,577 and \$5,709, respectively.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Bank of America, N.A. or its affiliates. Bank of America, N.A. is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances. See Note 6 for additional information.

Revenue Sharing

The Plan has a revenue-sharing agreement where participants receive a credit against their expenses for investing in the trustee's investment options. During the year ended December 31, 2024, the Plan received \$14,824 in revenue credits from the trustee, which is included in net realized and unrealized gains on investments on the statement of changes in net assets in liquidation. During the year ended December 31, 2024, expenses of \$34,272 were paid out of the revenue-sharing account. The balance of the revenue-sharing account was approximately \$49,000 and \$68,400 at December 31, 2024 and 2023, respectively, and is included within one of the Plan's money market funds.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

As discussed in Note 6 to the financial statements, the plan sponsor terminated the Plan effective December 31, 2024. As a result, the Plan changed its basis of accounting for periods subsequent to December 31, 2024 from the going concern basis to the liquidation basis.

Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process, and liabilities are measured using the accrual basis of accounting and would include any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process.

Note 2 - Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Plan and the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 8, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Bank of America, N.A. (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year (in liquidation) are based solely on information certified by the Trustee.

Note 4 - Tax Status

The Plan adopted a preapproved plan. The preapproved plan has received a favorable opinion letter from the IRS indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

Mutual Funds

Mutual funds are valued at quoted prices reported in active markets.

Money Market Funds

The money market funds are valued at the outstanding balance, which is the best estimate of fair value.

Common/Collective Trust Fund

The common/collective trust fund is valued at net asset value per share or its equivalent of the fund, which is based on the fair value of the fund's underlying net assets. There are no redemption restrictions or unfunded commitments on this investment.
