Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Hypower, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Hypower, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTE 1. DESCRIPTION OF PLAN

The following description of the Hypower, LLC 401(k) Plan (the Plan) provides only general information. For more complete information, participants should refer to the Plan instrument, a copy of which is on file in the office of the Plan sponsor.

General

The Plan was established effective January 1, 1997, for all eligible employees of Hypower, LLC (the Company and Plan sponsor). The Plan has been amended throughout the years to comply with tax legislation and was most recently restated effective January 1, 2023. The Plan is a defined contribution 401(k) savings plan. The Plan provides for contributions under salary deferral agreements pursuant to section 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The board of directors and Plan administrator are responsible for the oversight of the Plan and determine the appropriateness of the Plan's investment offerings and monitor investment performance.

Eligibility

Employees of the Company and its participating affiliates are eligible to participate in the Plan on the first day of the calendar month coincident with or next following the date of attaining age 21. Leased employees and non-resident aliens are excluded as well as employees covered by a collective bargaining agreement if retirement benefits were the subject of good faith bargaining, and if the collective bargaining agreement does not provide for participation in this Plan.

Funding

Participants may contribute up to 100% of pretax annual eligible compensation as defined in the Plan. According to Internal Revenue Service (IRS) rules, the deferral may not exceed \$23,000 in 2024 and \$22,500 in 2023, respectively. Participants who have reached at least age 50 may contribute an additional \$7,500 during 2024 and 2023. Eligible participants may also contribute amounts representing distributions from other qualified benefit or contribution plans.

The employer matches 100% of the participant contribution not to exceed 3% of compensation, plus 50% of the amount of the matched participant's contributions that exceed 3% of compensation but that do not exceed 5% of compensation.

Additionally, the employer may make non-elective contributions for the benefit of such participants determined at the discretion of the Company. In order to share in the allocation of any non-elective contributions, participants are required to have completed at least 500 hours of service and be employed by the employer on the last day of the Plan year.

NOTE 1. DESCRIPTION OF THE PLAN (Continued)

Participant Accounts

Each participant's account is credited with 1) participant contributions; 2) the employers' matching contribution; and 3) a ratable portion of investment gain or loss, net of Plan expenses. Each participant's account is charged with any distributions made to that participant.

Vesting

Participants are immediately vested in all salary deferral contributions, rollover contributions, and the Plan Sponsor's safe harbor and discretionary profit-sharing contributions, plus actual earnings thereon.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions to be allocated among a selection of securities provided by the Plan (see Note 3).

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, subject to 20% withholding for income taxes, or as direct rollover to an individual retirement account or another employer's tax qualified plan. The Plan administrator may permit a participant to take partial distributions or installment distributions solely to the extent necessary to satisfy the IRS rules. A participant who terminates employment with a vested account balance exceeding \$5,000 may receive a distribution of his/her vested account balance within a reasonable period following the date the participant terminates employment. A participant who terminates employment with a vested account balance that does not exceed \$5,000 will receive a single lump-sum distribution without the election or request of the participant. The Plan also allows for in-service distributions of participants deferrals, upon attaining age 59 ½.

For participants who die before their account balance distribution, their entire balance must be distributed by December 31 of the calendar year containing the fifth anniversary of their death.

Forfeitures

Forfeitures may be used to restore other forfeitures, reduce future employer contributions, reallocate as employer contributions, or to pay Plan expenses. The forfeiture balance available for use were \$7,387 and \$4,129 as of December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, \$1,082 in forfeitures were used to pay Plan expenses.

Termination

Although there is no intent to do so, the Plan document provides for termination of the Plan subject to the provisions of the agreement and ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared using the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (see Note 3). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants (see Note 4 for discussion of fair value measurements).

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Concentration of Credit Risk

Financial instruments, which potentially expose the Plan to concentrations of credit risks, as defined by GAAP, consist primarily of contributions receivable and investments. The Plan invests in pooled separate account, which, inherent in the fair market value determination, include the risk factor of credit worthiness for each individual underlying security.

NOTE 3. INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN

Voya Retirement Insurance and Annuity Company (Voya) held the Plan's investments as of December 31, 2024 and 2023. The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the information reflected on the supplementary schedule Form 5500 - Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024.

Allocations among the underlying investments are participant directed. The accounts are credited with earnings on the underlying investments (principally pooled separate accounts and a guaranteed investment contract) and charged for Plan withdrawals and administrative expenses.

During the year ended December 31, 2024, the Plan's underlying pooled separate accounts and guaranteed investments contract (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$1,989,641. This was reported as net appreciation in fair value of investments in the statement of changes in net assets available for benefits.

NOTE 4. FAIR VALUE MEASUREMENTS

GAAP provides a framework for measuring fair value, expands disclosures about fair value measurements, and establishes a fair value hierarchy, which prioritizes the inputs used in measuring fair value summarized as follows:

Level 1: Inputs using the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for investments measured at fair value. There has been no change in the methodology used as of December 31, 2024.

Pooled Separate Account: Valued at the net asset value (NAV) or equivalent based on units of the pooled separate account. The NAV, as provided by Voya, is used as the practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the pooled separate account less its liabilities. This practical expedient is not used when it is determined to be probable that the pooled separate account will sell the investment for an amount different than the reported NAV.

The method described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of the future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

* In accordance with fair value measurement guidance, certain investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the amounts presented as investments in the Statements of Net assets Available for Benefit.

The Plan evaluates the significance of various inputs to assess the appropriate classification of the Plan's investments within the fair value hierarchy. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. Transfers between levels are evaluated for their significance based upon the nature of the investments and size of the transfer relative to the net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no transfers between levels within the fair value hierarchy.

NOTE 5. GUARANTEED INVESTMENT CONTRACT

The Plan holds an investment contract with Voya. The assets are invested in an account that is fully benefit-responsive and is reported as Voya Fixed Account Fund in the Plan's accounting records.

Contract value represents contributions made, less withdrawals and administrative expenses, plus interest credited. Net deposits invested in the Voya Fixed Account Fund become part of Voya's general account, and there are no particular segregated or identifiable assets ascribed to the Plan's investment. Net deposits and interest credited become liabilities against Voya on the Plan's behalf. Daily liquidity is available for participant contributions and withdrawals at contract value regardless of market conditions. Contract value is guaranteed by the full faith and credit of Voya; there are no wrap contracts supporting the liquidity of the fund. The account is neither a mutual fund nor a bank product. Voya's obligations are not insured by the FDIC or any other federal government agency. As of December 31, 2024 and 2023, the balance of the investment contract was \$1,278,129 and \$1,128,892, respectively. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Crediting rates for the Plan's Voya Fixed Account Fund are set by Voya using a process similar to that used by banks or other insurance companies for similar products. Such interest rates are reviewed on a periodic basis. The declared rate for 2024 was 1.50%, expressed as an annual effective yield.

Certain events may limit the ability of the Plan to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total Plan termination, retirement incentive programs, and the liberalization of Plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply. The Plan Sponsor may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected. If the Plan Sponsor views the occurrence of any of these events as probable as of the measurement date, details about market value adjustments or other withdrawal restrictions can be obtained through the Plan's account manager. Under no event may Voya terminate the contract and settle at an amount different from contract value.

NOTE 6. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Voya, which is the record-keeper and custodian for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Voya amounted to \$18,915 for the year ended December 31, 2024. The Plan Sponsor also paid certain administrative expenses of the Plan.

NOTE 7. RELATED PARTIES

Hypower, LLC is the Plan's employer and sponsor. They absorb virtually all administrative expenses of the Plan.

NOTE 8. INCOME TAX STATUS

The Plan is exempt from Federal income taxes under Internal Revenue Code (IRC) and, therefore, no provision for Federal income taxes has been made. In addition, the Plan is required to operate in conformity with the IRC to maintain the tax-exempt status. Management believes that the Plan is being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Management believes that no such positions have been taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management believes that the Plan is no longer subject to such audits for tax periods prior to 2021.

NOTE 9. SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for the Plan through August 21, 2025, the date the financial statements were available to be issued.
