Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Veritas Prime LLC 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section:

- The amounts and disclosures in the 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles (U.S. GAAP).
- The information in the 2024 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with U.S. generally accepted auditing standards (U.S. GAAS). 1. Description of Plan

The Veritas Prime LLC 401(k) Profit Sharing Plan (the Plan) is a defined contribution plan which began on January 1, 2018 and covers all employees of Veritas Prime, LLC (the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The following description of the Plan provides only general information. Participants should refer to the Plan provisions for more information.

Eligibility

The Plan states that all employees of the Company who have attained age 21, excluding certain union employees, nonresident aliens and persons who become employees as part of an asset or stock acquisition or merger involving a change in the employer of a trade or business, are eligible to participate in the Plan upon the first day of hire.

In order to be eligible for discretionary profit sharing contributions, employees also must have completed one year of service or 1,000 hours.

Contributions

Participants may defer pre-tax contributions to be made to the Plan through reduction of their compensation in amounts up to 100% of their eligible compensation, subject to certain limits under the Internal Revenue Code (the Code). Participants who are projected to be age 50 or older by the end of the calendar year and who are making pre-tax contributions to the Plan may also make additional "catch up" pre-tax contributions, subject to limits under the Code. Rollovers from qualified plans are permitted.

The employer may also make matching contributions and discretionary profit sharing contributions, as determined by the Company. Employer contributions are subject to certain limits under the Code. The Company did not elect to make any discretionary profit sharing contributions for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses and Plan losses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their elective contributions and the employer matching contributions plus cumulative earnings thereon. Participants vest in the Company's discretionary profit sharing contributions and cumulative earnings thereon as follows:

Participants become 100% vested in their profit sharing contributions if employed on or after retirement age, or upon death or disability.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 1% above the prime rate, as defined. Principal and interest is paid ratably through monthly payroll deductions.

Forfeitures

A participant who leaves the employment of the Company forfeits any non-vested balance following five consecutive one-year breaks in service. In accordance with Plan provisions, forfeitures are to be used to pay administrative expenses, and reduce future Company contributions to the Plan. There were no forfeitures used during the year ended December 31, 2024.

Payment of Benefits

Upon death, disability, retirement or termination of service, a participant (or their beneficiary) receives a single lump-sum payment or partial withdrawals equal to the value of the participant's vested balance in his or her account. A lump-sum distribution will be made for participants with a vested balance below \$5,000.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions or ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with U.S. generally accepted accounting principles (U.S. GAAP).

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and the disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year in which such adjustments are determined.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan Document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses are paid by the Plan.

Subsequent Events

The Company has evaluated subsequent events through September 18, 2025, the date the financial statements were available to be issued.

3. Income Tax Status

The Plan was originally established, and all subsequent amendments have been made, under the provisions of the trustee prototype plan. The IRS has determined and informed the trustee by letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Code. The Plan has been amended since receiving the determination letter. However, the trustee believes that the Plan is designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

4. Information Prepared and Certified by Custodian

The investments, investment transactions, net appreciation in fair value of investments, notes receivable from participants and interest and dividends were obtained by management and agreed to or derived from the information certified by Charles Schwab Trust Bank, the custodian, as complete and accurate. This information is included in the following:

- Statements of Net Assets Available for Benefits;
- Statement of Changes in Net Assets Available for Benefits; and
- Schedule H, line 4i – Schedule of Assets (Held at End of Year).

5. Fair Value Measurements

The Plan uses a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

Mutual funds are valued at the net asset value of shares held by the Plan at year end.

Amounts included in the interest-bearing cash account are related to a money market fund that seeks to maintain a value of \$1 per share through investments primarily in U.S. Treasury securities.

6. Party-in-Interest Transactions

The administrative expenses paid by the Plan for 2024 were \$27,075 and qualify as party-in-interest transactions as they are related to recordkeeper fees and investment advisor fees incurred by the Plan. In addition, notes receivable from participants also qualify as party-in-interest transactions.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
