Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Schwab Industries, Inc. 401(k) Profit Sharing Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

NOTE A - Description of Plan

The following description of the Schwab Industries, Inc. 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan Document and Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a 401(k) defined contribution profit sharing plan covering all employees of Schwab Industries, Inc. (Company) who have completed two months of service as defined in the Plan and are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year participants may contribute up to 100% of their annual pretax compensation, as defined in the plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company may make discretionary matching contributions based on a percentage, to be determined annually by the Company's Board of Directors, of the employees' deferral contributions to the Plan. The Company may also make annual discretionary profit sharing contributions to the Plan at the discretion of the Company's Board of Directors.

Participants may direct employee and employer contributions in a broad range of investments including common stocks, mutual funds, pooled separate accounts, and a guaranteed investment contract. Participants may change their investment options each business day.

Participant Accounts

Each participant's account is credited with the participant's contributions and discretionary employer matching contributions as well as an allocation of discretionary employer profit sharing contributions and Plan earnings. The Plan's earnings are allocated to the participants based on their respective fund earnings as defined in the Plan. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Expenses are allocated pro rata based on account balances, charged equally, or charged for specific participant transactions, as defined in the Plan.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. A participant is 100% vested in any discretionary matching contributions and discretionary profit sharing contributions plus actual earnings thereon after six years of credited service, as defined in the Plan.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their accounts balance, whichever is less. Loan terms range up to five years or up to fifteen years for the purchase of a principal residence. The loans are secured by the balance in the participant's account and bear

interest at the prevailing prime rate plus 1%. Principal and interest are paid ratably through weekly payroll deductions.

Payment of Benefits

On termination of service, death, disability or retirement, a participant or his or her beneficiaries may elect to receive the value of his or her vested interest in a lump-sum or installments over a period of years.

Forfeited Accounts

Forfeited amounts may be used to reduce future employer contributions or pay plan expenses. Employer contributions were reduced by approximately \$31,000 and \$13,000 in 2024 and 2023, respectively, from forfeited nonvested accounts. At December 31, 2024 and 2023 there were forfeited amounts of \$400 and \$7, respectively.

NOTE B - Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31,

2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses consist of contract charges and fund expenses applicable to certain investments. These expenses are charged directly to participant's accounts. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued. No significant matters were identified for disclosure.

NOTE C - Information Certified by the Trustees

Certain information related to the Plan's investments and notes receivable from participants included in the financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and the associated investment income (loss) and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by both Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the trustees of the Plan. This information has not been audited by the independent accountants.

NOTE D - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment funds: Valued at the daily closing price as reported by the fund. Registered investment funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Valued at the net asset value of units of participation that represent rights to the separate account assets of the insurance company. Unit value is adjusted daily to reflect investment results under the separate account. The initial pricing input is the quoted price obtained of the underlying mutual fund which is then adjusted to apply the expense factor of the separate account contract. The net asset value is not publicly quoted but is available to the current investors (Plan participants) daily on the Plan's website and is the basis for current transactions.

Self-directed brokerage accounts: Accounts primarily consist of common stocks that are valued at the closing price reported on the active market on which the individual securities are traded.

All world equity collective trust fund: Valued at the net asset value of units held in the collective trust fund as reported by the manager of the fund. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. The fund is invested in global equity type securities, with the objective of delivering long-term growth of capital by capitalizing on style and sector cycles as they come in and out of favor to exploit the structure of the global markets.

US fixed income collective trust fund: Valued at the net asset value of units held in the collective trust fund as reported by the manager of the fund. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. The fund is invested in a diversified portfolio of fixed income related securities, with the objective of delivering long-term preservation and growth of capital by assessing future changes in short and long term interest rates, credit spreads and corporate solvency.

NOTE E - Guaranteed Investment Contract

The Plan has a fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company of America (Empower). Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Guaranteed investment contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

NOTE E - Guaranteed Investment Contract (continued)

The crediting interest rate is based on a formula agreed upon with the issuer. The average crediting rate was approximately 2.66% and 1.23% for the years ended December 31, 2024 and 2023, respectively. The crediting rate is reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, plant closings, mergers or early retirement incentives) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuer and that would also limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) a breach of material obligation under the contract or (2) a material misrepresentation.

NOTE F - Party-in-Interest Transactions

Parties-in-interest are defined under DOL Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Plan investments incur fees for fund management which are recorded as a reduction of the return earned on each fund. These investments are issued or managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, trustees of the Plan. Registered investment advisory fees are charged to the participants' accounts which utilize the registered investment advisor, Fisher Investments, who qualifies as a party-in-interest. Notes receivable from participants also reflect party-in-interest transactions. Additional transactions during the year with parties-in-interest include administrative expenses (see Note B).

NOTE G - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

NOTE H - Tax Status

The Company has adopted a non-standardized pre-approved plan document sponsored by Empower Retirement LLC. The Internal Revenue Service has informed the prototype sponsor with an opinion letter dated November 14, 2022, that the non-standardized pre-approved plan satisfies the applicable provisions of the Internal Revenue Code. The Plan itself has not received a determination letter from the Internal Revenue Service. However, the Plan's administrator and the Plan's trustee believe that the Plan is designed and is currently being operated in compliance with the non-standardized pre-approved plan document and applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE I - Risks and Uncertainties

The Plan invests in various investment securities as directed by plan participants. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
