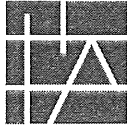

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted accounting standards (GAAS), we:

Our audit did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

The supplemental Schedule of Assets Held for Investment at Year End and Schedule of Delinquent Participant Contributions as of December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of plan

The following description of M-E Engineers, Inc. (Company) 401(K) Profit Sharing Plan and Trust (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. John Hancock Retirement Services served as the Plan's recordkeeper until February 15, 2024, when recordkeeping services transitioned to Ascensus, LLC. Ascensus Trust Company serves as the trustee and custodian of the Plan's assets and provides the annual certification of investment information used in connection with the audit of the Plan's financial statements.

Eligibility

With the exception of interns, all employees of the Company are eligible to participate in the Plan upon attaining age 21 and completing three months of service. At that time, employees may make elective deferral contributions and receive employer matching contributions. Employees become eligible for profit-sharing contributions after one year of service and completion of at least 1,000 hours during that year. Plan entry is immediate following satisfaction of the applicable eligibility requirements.

Contributions

Eligible employees may contribute a percentage of their eligible compensation on a pre-tax or Roth basis, subject to annual statutory limits under the Internal Revenue Code ("IRC"). The Company provides matching contributions as defined in the Plan document. The Plan may also provide for discretionary profit-sharing contributions at the Company's option. Participants may also roll over amounts from other qualified plans.

For 2024, participants may elect to contribute up to \$23,000 of their compensation to the Plan. Participants who are the age of 50 or more may contribute an additional \$7,500. The Company's discretionary employer matching contribution rate remained at 25% throughout 2024, subject to an annual maximum matching contribution of \$4,000 per participant.

Participant accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Plan Amendments

Effective May 1, 2023, the Plan was restated using a pre-approved plan document to incorporate law changes, procedural changes, and discretionary amendments adopted since the last restatement. The restatement did not have a material effect on the Plan's net assets available for benefits.

1. Description of plan (continued)

Vesting

Participants are immediately vested in their voluntary contributions and rollover contributions, plus actual earnings thereon. Vesting in the portion of their accounts comprised of the Company's discretionary matching and profit sharing contributions plus actual earnings thereon is based on years of service as follows:

Investment options

All of the Plan's accounts are maintained by Ascensus Trust Company. Participants may direct their contributions into any combination of the investment funds available under the Plan, which consist of a variety of mutual funds and other investment options. Participants may change their investment elections and transfer balances between funds at any time, subject to Plan provisions.

Loans

Participants may borrow up to 50% of their vested account balance, subject to limitations imposed by the Internal Revenue Service (IRS). The minimum loan amount is \$1,000 and the maximum is \$50,000. Loans incur interest at fixed rates which are set at origination based on interest rates currently being charged on similar loans. Loan repayment periods may not exceed five years, unless the loan is for the purchase of a primary residence.

Payment of benefits

On termination of service, retirement, disability, or death, participants (or their beneficiaries) may elect to receive their vested account balance in a lump sum or by direct rollover to another qualified plan or individual retirement account, in accordance with the provisions of the Plan.

Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

1. Description of plan (continued)

Forfeited accounts

At December 31, 2024 and 2023, the Plan had forfeited accounts of \$12,913 and \$16,506, respectively. In 2024, forfeitures were invested in the Plan's funds, whereas at December 31, 2023 they were held in a cash account. Forfeitures may be used to reduce future employer contributions or to pay Plan expenses

2. Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment valuation

The Plan's investments are stated at fair value or contract value, as applicable. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Mutual funds, including money market mutual funds, are valued based on quoted market prices (Level 1 inputs). The Plan also invests in a fully benefit-responsive guaranteed investment contract, which is reported at contract value, the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 3 for additional disclosures about fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded as earned. Net appreciation (depreciation) in fair value of investments includes realized gains and losses on investments sold during the year, unrealized appreciation and depreciation on investments held at year-end, and dividend and interest income from investments. Interest income on participant loans is presented separately in the Statement of Changes in Net Assets Available for Benefits.

Payment of benefits

Benefits are recorded when paid.

Plan administrative expenses

Certain administrative expenses of the Plan, such as recordkeeping and custodial fees, are paid directly from Plan assets. Other administrative expenses, such as audit and professional fees, are paid directly by the Plan Sponsor. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments and are not separately presented.

3. Fair Value Measurements

Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value and expands disclosures about fair value measurements. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The standard establishes a three-level hierarchy for inputs used in measuring fair value:

- Level 1 – Unadjusted quoted prices in active markets for identical assets or liabilities.
- Level 2 – Inputs other than quoted prices included within Level 1 that are observable, either directly or indirectly.
- Level 3 – Unobservable inputs that are significant to the fair value measurement.

The Plan invests in a fully benefit-responsive guaranteed investment contract, which is reported at contract value in the Statements of Net Assets Available for Benefits. The fair value of the contract as of December 31, 2024 was \$1,939,275 compared to a contract value of \$1,997,265. The fair value and contract value of the contract as of December 31, 2023 were both \$2,890,443, as separate fair value information was not provided by the prior recordkeeper.

Mutual funds are measured at fair value based on quoted market prices, which are Level 1 observable inputs. The guaranteed income contract is a stable value product that preserves principal and provides a guaranteed rate of return for a specified period, generally six months, after which the rate is reset. The contract guarantees both principal and accumulated interest through a rider on a group annuity contract issued by the Standard Insurance Company. This investment is valued at contract value, representing principal plus accumulated interest, and is therefore not included within the fair value hierarchy.

5. Contributions

Participants contributed \$2,383,819 to the plan during 2024. The Company made matching contributions of \$471,716. No employer profit-sharing contribution was declared for 2024.

At December 31, 2024 and 2023, the Plan recorded receivables of \$0 and \$283,494, respectively, representing the Company's discretionary profit-sharing contribution for the 2023 Plan year. The 2023 contribution was funded in 2024, net of \$16,506 of forfeitures applied. Unallocated forfeitures of \$12,913 remained in the plan at December 31, 2024 and will be applied to future employer contributions or Plan expenses.

6. Recordkeeper transition

Effective February 15, 2024, the Plan's recordkeeping services transitioned from John Hancock Retirement Services to Ascensus, LLC. Plan assets were transferred at fair value to the new recordkeeper's platform. The transition did not have a material effect on the Plan's net assets available for benefits.

7. Party-in-Interest transactions

Fees paid to the recordkeeper and the trustee qualify as party-in-interest transactions as defined by ERISA. Participant loans also qualify as party-in-interest transactions. All such transactions were conducted in the normal course of operations and on terms that were reasonable and customary.

8. Tax status

The Plan is intended to be qualified under Section 401(a) of the Internal Revenue Code (IRC) and exempt from federal income taxes under Section 501(a). The Plan has been amended since its most recent favorable determination letter, but the Plan Administrator believes the Plan continues to operate in compliance with the IRC and remains qualified and tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The Plan Administrator has determined that there are no uncertain tax positions that require recognition or disclosure in the financial statements.

9. Risks and uncertainties

The Plan invests in various investment securities that are exposed to market, interest rate, and credit risks. It is reasonably possible that changes in the fair value of these investments could occur in the near term and materially affect participants' account balances and the amounts reported in the financial statements.

Amounts receivable for participant contributions, employer matching contributions, and employer profit-sharing contributions are recognized upon the Company's formal commitment or legal requirement to make the contribution under the accrual basis of accounting. The 5500 is prepared on the cash basis of accounting, accordingly, certain amounts, such as contributions receivable, may differ between the financial statements and the form 5500.

11. Subsequent Events

Effective January 1, 2025, the Plan was amended to modify the employer matching contribution formula. Under the amended provision, the Company will match 100% of participant elective deferrals, up to a maximum of \$5,000 annually, replacing the prior matching rate of 25% up to a maximum of \$4,000 annually. In conjunction with this change, the Company does not expect to make discretionary profit-sharing contributions for the 2025 plan year.

Except as discussed above, the Plan did not have any subsequent events through October 13, 2025, which is the day the financial statements were available to be issued, which required recording or disclosure for the year ended December 31, 2024.
