### Notes to Financial Statements

#### NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### ***Basis of Presentation***

The financial statements of the Cincinnati Arts Association 403(b) Plan are prepared under the accrual basis of accounting using accounting principles generally accepted in the United States of America.

##### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statement of net assets available for benefits.

##### ***Related-Party Transactions***

Certain Plan investments are invested in funds managed by Nationwide Financial Services. Nationwide Financial Services is the Plan trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest.

Certain Plan investments are shares in mutual funds managed by Empower Retirement. Empower Retirement is a custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest.

Several employees of The Cincinnati Arts Association provide administrative services to the Plan. These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Company for the services of the employees to the Plan.

##### ***Estimates***

The preparation of financial statements in conformity with United States generally accepted accounting principles ("GAAP") requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

##### ***Benefit Payments***

Benefit payments are recorded when paid.

##### *Subsequent Events*

There were no reportable subsequent events that occurred in the time period after the December 31, 2024 net assets available for benefits date through October 10, 2025, which is the date the financial statements were available to be issued.

#### NOTE 2 DESCRIPTION OF THE PLAN

The following description of the Cincinnati Arts Association 403(b) Plan provides only general information. The Plan was established January 1, 1995. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

##### *General*

The Plan is a defined contribution plan covering all eligible employees of The Cincinnati Arts Association (the "Company") who are 18 years of age and have completed one hour of service. The Plan is subject to the Employee Retirement Income Security Act of 1974 ("ERISA").

##### *Contributions*

A participant may make pre-tax or post-tax contributions up to 100% of eligible compensation. Participants designate the percentage of their total contribution to be invested in any of the Plan's investment funds. Participants may change the percentage of contributions invested in each account and may make transfers between accounts anytime during the year. Contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986 as amended (\$23,000 at December 31, 2024). For 2021, Section 414(v) of the Internal Revenue Code of 1986 as amended allowed a maximum catch-up contribution of \$7,500 for participants over 50 years of age.

##### *Rollover Contributions*

Participants may roll over their taxable portion of funds previously held for their account in another qualified employee benefit plan to the Plan on a tax-free basis.

##### *Participant Accounts*

Each participant's account is credited with the participant's contributions and a pro-rata allocation of the Plan's earnings. The pro-rata allocation is based upon the proportion of individual account balances to total participants' account balances in the respective investment funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

##### *Vesting*

Participants become immediately vested at the time of participation in the Plan in their contributions plus actual earnings thereon.

### Notes to Financial Statements (Continued)

#### NOTE 2 DESCRIPTION OF THE PLAN (CONTINUED)

##### *Payment of Benefits*

Upon a participant's termination of service, participants may receive benefits in accordance with the Plan's provisions and existing laws and regulations.

In conditions of "financial hardship", a participant may apply to the Plan administrator for approval to withdraw that portion of his 403(b) retirement account balance necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

In-service distributions are permissible from the Plan for participants that have attained the age of 59 ½.

##### *Tax Status*

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (the Code). The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service (IRS) in Revenue Procedure 2007-71 [or the draft *Listing of Required Modifications* issued April 4, 2009]. The Plan Administrator intends to apply for a determination letter on the Plan once the IRS opens such a program. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b).

#### NOTE 3 INFORMATION CERTIFIED BY QUALIFIED INSTITUTIONS

The following information provided by Nationwide Financial Services, Inc. and Empower Retirement for the years ended December 31, 2024 and 2023, was certified by them to be accurate and complete:

- (a) The assets held by Nationwide Financial Services, Inc. and Empower Retirement as of December 31, 2024 and 2023, as well as the transactions involving these assets for the year ended December 31, 2024.
- (b) The amount of investment income for the year ended December 31, 2024.
- (c) The Schedule H, Line 4i – Schedule of Assets (Held at End of Year) for the year ended December 31, 2024.

#### NOTE 4 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. Upon termination of the Plan, the assets will be distributed to participants in accordance with the Plan's provisions and existing laws and regulations.

#### NOTE 5 FAIR VALUE MEASUREMENTS

Applicable GAAP accounting for Fair Value Measurements and Disclosures establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation approaches used for assets measured at fair value:

*Money Market Funds* – Value at the net asset value (“NAV”) of shares held by the plan at year end.

*Mutual Funds* – Value at the net asset value (“NAV”) of shares held by the plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
