### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the MSB/BWS 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS  
DECEMBER 31, 2024 AND 2023**

**NOTE 1: DESCRIPTION OF THE PLAN**

The following description of the MSB/BWS 401(k) Plan (the "Plan") provides only general information. Reference should be made to the Plan document for a more complete description of the Plan's provisions.

**General** – The Plan is a defined contribution plan covering substantially all employees of Mike Schaap Builders, Inc. and Benchmark Wood Studio, Inc. (the "Company") who have met the service requirements of the plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Contributions** – Each year, participants may contribute up to 100% of the participant's pre-tax annual compensation during the pay period, as defined in the Plan, not to exceed the maximum allowed by ERISA and IRS regulations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. In addition, participants have the option to elect after-tax salary deferrals to a Roth 401(k). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan is a safe harbor 401(k) plan which is a plan design in which the Employer commits to making contributions to the Plan. During the year ended December 31, 2024 and 2023, the safe harbor matching contribution was equal to 3% of employee compensation for the portion of the plan year that an employee was an active participant of the plan. Eligibility for the Plan occurs after the employee has completed 60 days of service and is age 18 or older. Contribution maximums are subject to certain IRS limitations. The employer may also do discretionary contributions to all eligible plan participants on the last day of the plan year. This amount will not exceed 5.7% of annual pay.

**Participant Accounts** – Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching contribution and (b) Plan earnings (losses) and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Participant Loans** – The Plan does not permit participants to take loans from the Plan.

**Termination of the Plan** – Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the plan subject to certain provisions set forth in the Plan. In the event of Plan termination, participants will become fully vested in their accounts.

**Vesting** – Participants are vested immediately in their contributions plus actual earnings thereon. The safe harbor matching contribution is immediately 100% vested. Annual discretionary matching contributions are also allowed. Employer discretionary contributions vest over a period of 5 years, starting at 0% for less than one year, and reaching 100% after 5 years of service

**Payment of Benefits** – Generally the Plan does not permit the payment of any benefits, unless the participant has terminated employment with the Company, attained the age of 59½ or in the event of death or disability. Participants who terminate may generally receive their vested benefits in a lump sum payment. Additionally, hardship withdrawals are available to current employees who qualify.

**Forfeited Accounts** – For the years ended December 31, 2024 and 2023, forfeited nonvested accounts were to be used to reduce employer contributions and/or pay plan expenses. The amount used in 2024 to pay plan expenses was \$0. The amount used in 2023 to pay plan expenses was \$0. The ending balances of the forfeited accounts at December 31, 2024 and 2023, were \$0 and \$0.

**NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING AND REPORTING POLICIES**

**Basis of Accounting** – The financial statements of the Plan are prepared on the accrual basis of accounting.

**Investment Valuation and Income Recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. This is the quoted market price as reported by the asset custodian and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Excess Contributions Payable** – Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributes the excess contributions to the applicable participants prior to March 15 of the following year. For the plan years ended December 31, 2024 and 2023, there were \$0 and \$0, respectively, of excess contributions.

**Payments of Benefits** – Benefits are recorded when paid.

**Administrative Expenses** – Certain investment advisory, service provider, and loan fees are paid directly from Plan Assets. Other administrative expenses of maintaining the Plan are paid by the Organization. The amounts paid from Plan assets for the years ended December 2024 and 2023, were \$11,886 and \$33,967, respectively. Expenses paid from Plan assets are allocated to participant accounts.

**Certified Investments** – Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Principal Trust Company, the custodian and trustee of the Plan.

**Subsequent Events** – The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

**NOTE 3: RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

**NOTE 4: FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means;
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Principal (Mutual Funds):* Investments in the funds are valued using unit values to arrive at the valuation for accounts. The financial trend should be the same as the net asset value (NAV) per share at the close of each business day as reported by each mutual fund. The mutual funds held by the Plan are held in the Principal Trust Company custodial platform.

*Principal (Collective Trust):* Investments in the collective trust are valued at the net asset value (NAV) per share, calculated daily by the fund manager based on the underlying investments.

*Principal (Pooled Separate Accounts):* Investments in the pooled separate accounts are valued at the net asset value (NAV) per share, calculated daily by the fund manager based on the underlying investments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024 there were no significant transfers between Levels 1 and 2 and no transfers into or out of Level 3.

**NOTE 5: RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are units of registered investment companies and are managed by Principal Trust Company, who is the Plan custodian and trustee. Principal Trust Company received fees from the Plan for their services for the years ended December 31, 2024 and 2023. Therefore, these transactions qualify as party-in-interest transactions. The total party-in-interest fees for the years ended December 31, 2024 and 2023 amounted to \$11,886 and \$33,967, respectively.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 6: TAX STATUS**

The Plan is qualified and has received a determination letter from the IRS, dated June 30, 2020, stating that the Plan was designed in accordance with the provisions of the Internal Revenue Code (IRC). The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

**NOTE 7: INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN**

The Plan administrator has elected the method of compliance permitted by 29 CFR Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Principal Trust Company, the custodian of the assets of the Plan, except for comparing such information certified by these parties with information included in the Plan's financial statements and supplemental Schedule H, line 4i-Schedule of Assets (Held at End of Year).
