Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Earthbound LLC 401(K) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan was established on January 1, 2006, to provide benefits to eligible employees. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") covering eligible employees of Earthbound LLC, BJ Licensing LLC, Earthbound Licensing LLC, Earthbound PW LLC, Flatiron Apparel Brands LLC, Flatiron Brands LLC, Flatiron Kids LLC, and Flatiron Technologies LLC (collectively, the "Company" or "Employers") who are of age eighteen (18) years or older.

Assets of the Plan are allocated to participant accounts based on specific contributions made by each participant and respective match made by the Company. Investment income (loss) is credited to each account based on the appreciation (depreciation) of specific assets held in each participant account and any earnings thereon.

**Plan Contributions**

Each year, participants may contribute up to 100% of their pre-tax and/or after-tax ("Roth") annual compensation, not to exceed the maximum allowable limits as prescribed by the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans ("Rollovers"). Contributions are subject to certain statutory limitations.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and collective trust funds as investment options for participants. The Plan does not include an auto-enrollment provision. Upon enrollment in the Plan, contributions are invested in a designated asset, selected by the participant, until changed, directed by the participant.

The Company, at its discretion, may make a matching contribution equal to a flexible discretionary match as defined in the Plan document, to eligible employees under the terms of the Plan. The Company matches twenty-five (25) percent up to four (4) percent of compensation. An eligible employee must be the age of eighteen (18) to receive the discretionary match. The Company retains operational discretion over the formula(s) for allocating the flexible discretionary match, including the discretionary matching contribution rate or amount, the limit on elective deferrals subject to match, the per participant match allocation limit(s), the participants or categories of participants who will receive the allocation and the time period applicable to any matching formula, and the Company will be subject to the provisions as defined in the Plan document. The Company, at its discretion, may also make profit-sharing contributions to eligible employees under the terms of the Plan. The amount may vary from year to year. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's discretionary matching contributions, Plan earnings (losses), forfeitures, and is charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Options**

Upon enrollment in the Plan, participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. Participants may direct their contributions into one or more investment options offered under the Plan. All Company contributions will be invested in the same proportion as the participant-elected contribution. Participants may change their investments as frequently as they choose.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after four years of credited service. Company contributions and profit-sharing contributions are subject to a vesting schedule. The following table illustrates the vesting percentage of any Company contributions and profit-sharing contributions that an employee is entitled to, based on the number of years of continuous service with the Company:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 2	0%
2 but less than 3	33 1/3%
3 but less than 4	66 2/3%
4 or more	100%

**Notes Receivable from Participants**

Participants may borrow from their vested amounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms range from one to five years and may be extended for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate commensurate with local prevailing rates as determined by the Plan administrator. Interest rates on new and renewed loans will be computed at prime plus one percent. Principal and interest is paid ratably through payroll deductions. Participants may only take out one loan during any twelve-month period and may only have two loans outstanding at any time.

**Participant Investment Rollover**

Participants are allowed to transfer or rollover funds into the Plan from other qualified plans. For the year ended December 31, 2024, total assets rolled into the Plan were \$157,193. These rollovers are included on the statement of changes in net assets available for benefits.

**Payments of Benefits**

Upon termination of service due to death, disability, or retirement, a participant may receive the value of the vested interest in his or her account as a lump sum distribution as soon as administratively feasible. The Plan also provides for in-service distributions subject to conditions and limitations provided for in the Plan document.

**Forfeited Accounts**

Forfeitures are created when participants terminate employment before becoming vested in their full benefits under the Plan. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$21,168 and \$12,899, respectively. These accounts may be used to pay administrative expenses, reduce future employer contributions, or be allocated to the remaining participants. For the year ended December 31, 2024, there were no forfeitures used to offset employer contributions. For the year ended December 31, 2023, forfeitures used to offset employer contributions amounted to \$166.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting – Compliance with the Accounting Standards Codification (ASC) of the Financial Accounting Standards Board (FASB)**

The financial statements of the Plan are prepared using the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan’s valuation policies utilizing information provided by the trustees. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**Excess Contributions Payable**

Amounts payable to participants for employer contributions in excess of amounts allowed by the IRS under the Plan document are recorded as a liability with a corresponding reduction to employer contributions. As of December 31, 2024 and 2023, the Plan had excess employer contributions payable to participants in the amount of \$178 and \$-0-, respectively.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by either the Plan or the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Administrative expenses paid by the Plan include recordkeeping fees, trustee fees and related expenses. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

**NOTE 3 - INVESTMENT CERTIFICATIONS**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Empower Trust Company, LLC, and Empower Life & Annuity Insurance Company of New York, the trustees of the Plan, have certified the completeness and accuracy of all investments and related investment activity in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the accompanying supplemental schedule, Schedule H, Line 4(i) – schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

ASC Topic 820, Fair Value Measurement (ASC Topic 820), provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs of valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of fair value hierarchy under ASC Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by observable or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There are no Plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission ("SEC"). These funds are required to publish their net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust funds:* Valued as practical expedient based on net asset value ("NAV") of units held by the Plan at year end. The calculated NAV is directly related to the NAV of the underlying investment adjusted for dividends on distributions received by the custodian and the daily equivalent of any fees charged. The investments held by the collective trust fund are traded on an active market.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value ("NRV") or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

Effective July 1, 2022, the Plan entered into a traditional investment contract with Empower Life & Annuity Insurance Company of New York. This contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this was the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract value was \$32,643 and \$15,054 at December 31, 2024 and 2023, respectively. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The traditional investment contract held by the Plan is a group annuity contract. The contract issuer is contractually obligated to repay the principal and interest at a specified rate that is guaranteed in the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1 percent. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

1. Amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan).
2. Changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions.
3. Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan.
4. The failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.
5. Premature termination of contracts.

Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines.
2. A breach of material obligation under the contract.
3. A material misrepresentation.
4. A material amendment to the agreements without the consent of the issuer.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with participants.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the Plan provides 100% vesting and the net assets of the Plan will either be distributed to the participants and beneficiaries of the Plan or the participants' benefits will be transferred to another Plan sponsored by the Company.

**NOTE 7 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds, collective trust funds, and group annuity contract managed by Empower Trust Company, LLC and Empower Life & Annuity Insurance Company of New York.

Empower Trust Company, LLC and Empower Life & Annuity Insurance Company of New York are the trustees as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities of the Plan. These transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA and applicable exemptions promulgated thereunder. Fees paid by the Plan for the investment advisory services amounted to \$20,189 and fees paid by the Plan for the contract administrator fees amounted to \$13,113 for the year ended December 31, 2024, which are included in administrative expenses on the accompanying statement of changes in net assets available for benefits.

**NOTE 8 - TAX STATUS**

The IRS has determined and informed the Company, by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 10 - SUBSEQUENT EVENTS**

Plan management has performed its evaluation of subsequent events through October 6, 2025, the date the financial statements were available to be issued.

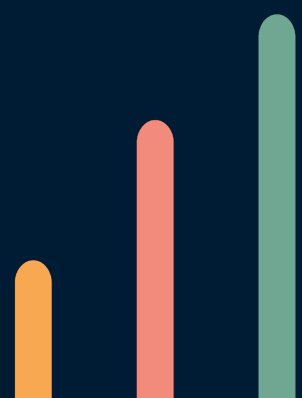
