INDEPENDENT AUDITOR'S REPORT

TO THE PARTICIPANTS AND PLAN ADMINISTRATOR OF THE VAN BORTEL FORD, INC. 401(K) PROFIT SHARING PLAN

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Van Bortel Ford, Inc. 401(K) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Opinion

Basis for Opinion



NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 1 – GENERAL DESCRIPTION OF THE PLAN

The following brief description of the Van Bortel Ford, Inc. (the “Company”) 401(K) Profit Sharing Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution profit sharing plan covering all employees of Van Bortel Ford, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The stockholders of the Company are responsible for oversight of the Plan’s investment offerings and monitoring investment performance.

Contributions

Each year participants may elect to contribute up to one hundred percent of their pre-tax annual compensation, subject to Internal Revenue Services (“IRS”) limitations. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct their investment of their contribution into various investment options offered by the Plan. The Company may contribute a discretionary matching contribution and a discretionary profit-sharing contribution. For both the Plan years ended December 31, 2024 and 2023, the Company matched 25% of contributions up to 4% of a participant’s compensation (total of 1%).

Participant Accounts

Separate accounts are maintained for each participant. The custodian invests the contribution amounts, as instructed by the participants, in one or more of the separate investment funds offered under the Plan. Each participant’s account is credited with (a) the amount of the participant’s elected contributions; (b) the amount of the participant’s Company matching and discretionary contributions, if any; (c) the amount of any attributable investment earnings and market appreciation or depreciation; and (d) charged with direct administrative expenses when applicable. The benefit to which a participant is entitled is the final market value of the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus earnings thereon. For the Companies’ matching or discretionary profit sharing contribution plus earnings thereon is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

Eligibility

Employees aged 18 or older are eligible to participate in the Plan on the first day of employment. Employees must have completed one year of service in which they are credited 1,000 hours of service and are age 21 or older to be eligible for the employer discretionary profit sharing and matching contributions.

NOTE 1 – GENERAL DESCRIPTION OF THE PLAN – CONTINUED

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at the rate of 4.25% - 9.50% and have maturity dates that range from 2025 to 2029. Principal plus interest is paid ratably through payroll deductions. Fees related to the administration of notes receivable from participants are charged directly to the specific participants account.

Payment of Benefits

Upon retirement, disability or death, the participant is eligible to receive their vested benefits in accordance with the provisions of the Plan. The amount of the participant's retirement account may be distributed to the participant or the designated beneficiary in a lump sum distribution or installment payments, as defined in the Plan. Upon separation from service before retirement, disability or death, the participant is eligible to request early payment of vested benefits or defer receipt of a distribution in accordance with Plan provisions.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$4,600 and \$-0-, respectively. Forfeitures arising under the Plan can be used to pay Plan expenses. Any remaining forfeitures are available to be allocated to participant accounts. During the years ended December 31, 2024 and 2023, forfeitures of approximately \$4,620 and \$3,400 were used to reduce Plan expenses, respectively.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure on contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net investment appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation and participant compensation is earned.

Notes Receivables From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

Excess Contribution Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in the administrative expenses. Investment related expenses are included in investment appreciation of fair value of investments.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Date of Managements Review

The Plan administrator has evaluated subsequent events for potential recognition and disclosure through October 6, 2025, the date the financial statements were available to be issued. Management has determined that no such events have occurred.

NOTE 3 – FINANCIAL INFORMATION CERTIFIED BY PLAN CUSTODIAN

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator has obtained a certification from Canandaigua National Bank and Trust a qualified institution and the custodian of the Plan, that all of the information provided by them is complete and accurate. Information included in the accompanying financial statements as of December 31, 2024 and 2023 and for the year ended December 31, 2024, pertaining to investments, interest income, dividends, net investment gain (loss) and all information in the supplemental schedule, is presented in reliance solely upon those certifications.

NOTE 4 – FAIR VALUE

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification (“FASB ASC”) No. 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Interest Bearing Cash: Valued at cost which approximates fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Canandaigua National Bank and Trust is the custodian of participant directed Plan assets as defined by the Plan and, therefore investment and benefit payment processing transactions qualify as party-in-interest transactions. Fees incurred and paid directly by the Plan participants to Canandaigua National Bank and Trust were approximately \$26,200 and \$23,600 for each of the years ended December 31, 2024 and 2023, respectively.

NOTE 6 – PLAN TERMINATION

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

NOTE 7 – INCOME TAX STATUS

The Plan has adopted the Epic Advisors, Inc. Non-Standardized Profit Sharing / 401(k) Plan With CODA. The Plan obtained its latest determination letter on June 30, 2020, in which the IRS ruled that the prototype plan of Epic Advisors, Inc. is acceptable under Section 401(a) of the Internal Revenue Code (“IRC”) and, therefore, is not subject to federal income tax under present law. Although the Plan has been amended and restated since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As the Plan is tax-exempt, the Plan administrator has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan provides for various investment options in any combination of a variety of mutual funds. Investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain mutual funds and the level of uncertainty related to changes in the value of mutual funds, it is at least reasonably possible that changes in the values of the mutual funds will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
