Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Eastern Washington–Northern Idaho Carpenters 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we—

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental schedule of assets held for investment as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion —

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements

Note 1 – Description of the Plan

The following description of the Eastern Washington–Northern Idaho Carpenters 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the trust agreement and official plan document for important details not included in these notes.

- a. **General** – The Plan is a defined contribution plan which became effective January 2, 2002, as a result of collective bargaining between the Inland Northwest Associated General Contractors of America, Inc., a Washington corporation, acting for and on behalf of its members and other signatory employers, and the Pacific Northwest Regional Council of Carpenters and Local Unions. The purpose of the Plan is to provide retirement and associated benefits for employees and their beneficiaries under a profit-sharing plan under Section 401(a) of the Internal Revenue Code (IRC) which includes a cash or deferred arrangement that is intended to qualify under Section 401(k) of the IRC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). To be eligible to participate in this Plan, a person must work for an employer signatory to a collective bargaining agreement or special agreement that allows for participation, as defined in the plan document. There are no age or minimum service requirements.
- b. **Contributions** – Participants make voluntary tax-deferred contributions to the Plan through payroll deductions of \$0.50 to \$7.00 per hour worked, in increments of \$0.50 (not to exceed the Internal Revenue Service (IRS) maximum allowable contribution). A participant who receives a distribution from another qualified plan may make a rollover contribution to the Plan provided that certain conditions are met, including the approval of the plan administrator. Participating employers may make a matching contribution of \$0.50 per hour worked, if allowed by the collective bargaining agreement. Some participating employers are also required to make contributions determined by the collective bargaining agreement (generally at \$1.00 per hour worked).
- c. **Vesting** – Participants are immediately vested in their contributions, the employer contributions, and all earnings thereon.
- d. **Participant accounts** – Each participant’s account is credited with the employer’s and participant’s contributions and earnings. The expenses of administration of the Plan, including the expenses of the administrator, trust fund office expenses, and expenses of the Board of Trustees shall be paid from the trust as a general charge thereon; administrative expenses that are allocable to the individual account of a specific participant shall be paid from that individual account. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Upon enrollment in the Plan, a participant may direct contributions to any available investment options. Participants may change their investment options daily.
- e. **Payment of benefits** – Normal retirement under the Plan occurs at age 55. Upon retirement or termination of employment, participation in the Plan will cease, and benefits will be distributed according to provisions set forth in the plan document. All vested account balances may be distributed in a lump-sum payment or installment payments over a specified period of time. The method of distribution is elected by the participant.

Note 1 – Description of the Plan (Continued)

- f. **Administration of the Plan** – The Plan is administered by Trustees and Trustee-appointed third-party administrators, accountants, consultants, counsel, specialists, and other persons deemed necessary or desirable in connection with the administration of the Plan. Plan assets are invested in accordance with the trust agreement. Records of participant account activity are processed and maintained by John Hancock Life Insurance Company (John Hancock), which also performs other administrative support services for the Plan. Certain costs and expenses with regard to the Plan are ordinarily borne by the participants.

Note 2 – Summary of Significant Accounting Policies

- a. **Basis of accounting** – The accounting records of the Plan are maintained on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. A receivable is established for employee and employer contributions not received by the Plan at year end.
- b. **Investment valuation and income recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.
- Purchases and sales of shares are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.
- c. **Payment of benefits** – Benefits are recorded when paid; there were no benefits payable to persons who have withdrawn from participation in the earnings and operations of the Plan at December 31, 2024 and 2023.
- d. **Use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.
- e. **Subsequent events** – The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Note 3 – Fair Value Measurements (Continued)

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Level 1 – The fair value of mutual funds is based on quoted net asset value of the shares held by the Plan at year end.

Level 2 – The Plan has no investments that are classified as Level 2 for either year ended December 31, 2024 or 2023.

Level 3 – The Plan has no investments that are classified as Level 3 for either year ended December 31, 2024 or 2023.

Investments Measured at Net Asset Value (NAV):

The Plan invests in a common/collective trust (CCT) whose underlying assets are primarily fully-benefit responsive guaranteed investment and wrap contracts, which are general obligations of the companies that issue the contracts. The CCT can be traded daily at its net asset value, which is based on the contract value of the contracts and the fair value of other investments in the CCT.

Note 3 – Fair Value Measurements (Continued)

Investments Measured at Net Assets Value (NAV) (continued):

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in Fair Value Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. We evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers in or out of Levels 1, 2, or 3.

Common/Collective Trust:

This entity is a direct filing entity that is reported in Schedule D of the Plan’s Form 5500 and investment objective is no longer required to be disclosed on the Plan’s financial statements under *Accounting Standards Update 2015-07*.

NOTE: Redemptions by participants for bona fide benefit payments and employee-directed transfers to reinvest in options that do not compete with the fund are generally permitted without restriction. Participants may make withdrawals from the fund for other purposes generally only upon 12 months’ advance written notice to the Trustees.

Note 4 – Related-party and Party-in-interest Transactions

Certain plan assets are managed by John Hancock. Zenith American Solutions provides certain accounting and administrative services to the Plan. John Hancock is the Plan’s investment advisors and custodian/trustee, and Zenith American Solutions is the Plan’s third-party administrator; therefore, these transactions qualify as party-in-interest transactions.

Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Trustees have the right to terminate the Plan subject to the provisions of ERISA at any time. In the event of plan termination, participant accounts remain fully vested.

Note 6 – Tax Status

The trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate section of the IRC and, accordingly, the trust's net investment income is exempt from income taxes. The Plan has obtained a favorable determination letter from the IRS but has since been amended. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified and the related trust is tax-exempt as of the financial statement date. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of the liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions and could be subject to income tax if certain issues were found by the IRS that could result in the disqualification of the Plan's tax-exempt status; however, there are currently no audits for any tax periods in progress.

Note 7 – Risks and Uncertainties

The Plan provides for various investment options in any combination of mutual funds and other investment securities. Investment securities are exposed to various risks, such as interest rate, market, political, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related risks to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Note 8 – Information Certified by the Plan Trustee

As permitted by Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator has elected that information certified by John Hancock not be subject to any auditing procedures except for comparing such information to the related information contained in the accompanying financial statements and supplemental schedule. The following information has been certified by John Hancock as complete and accurate:

- (a) Investments as indicated on the statements of net assets available for benefits;
- (b) Net appreciation in fair value of investments as indicated on the statements of changes in net assets available for benefits; and
- (c) Supplemental information – assets held for investment.

Note 9 – Compliance Test Correction

The Plan failed the Average Deferral Percentage tests during the years ended December 31, 2024 and 2023. This test compares the average deferral percentage of the higher paid group to the lower paid group. If the average of the two groups differs more than 2%, refunds of excess contributions must be issued. The Plan accrued \$51,614 and \$41,183 at December 31, 2024, and 2023, respectively, for these refunds to be issued.
