Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Saint Mary's School 403(b) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for plan benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in note 4 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

December 31, 2024 and 2023

(1) Summary of Significant Accounting Policies

(a) Basis of Presentation

The accompanying financial statements of Saint Mary's School 403(b) Retirement Savings Plan (the "Plan") have been prepared in accordance with accounting principles generally accepted in the United States of America and present the net assets available for plan benefits and changes in those net assets on an accrual basis.

(b) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the use of estimates and assumptions that affect the reported amounts of net assets available for plan benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(c) Investments and Fair Value Measurements

The Plan presents in the statements of changes in net assets available for plan benefits the investment return, including the net appreciation (depreciation) in the fair value of its investments, which consists of realized gains or losses, the unrealized appreciation (depreciation) on those investments, and investment management fees. There are no unfunded commitments as of December 31, 2024 and 2023.

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The authoritative guidance for fair value measurements establishes a three-level hierarchy which encourages an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The three levels of the hierarchy consist of the following: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and the Level 3 inputs are unobservable and have the lowest priority.

Following is a description of the valuation techniques used by the Plan to measure different financial instruments at fair value on a recurring basis and the level within the fair value hierarchy in which the financial instrument is categorized.

The fair values of investments in registered investment companies are based on quoted market prices, when available (Level 1). The fair value of investments in the pooled separate account is based on the market value of the underlying real estate holdings, valued principally using external appraisals. Unit values are calculated and available daily, and these financial instruments are classified as Level 1 in the fair value hierarchy. The fair value of the Retirement Choice account unallocated insurance contract (Retirement Choice account, see note 5) is contract value based on accumulated cash contributions and interest thereon, less any withdrawals; therefore, this contract is classified as Level 3 in the fair value hierarchy.

The Retirement Choice Plus account is a fixed annuity contract that is fully and unconditionally guaranteed by Teachers Insurance and Annuity Association of America ("TIAA") and College Retirement Equities Fund ("TIAA-CREF"). The Retirement Choice Plus account unallocated insurance contract is fully liquid and immediately cashable, as such this investment is fully benefit-responsive and not subject to the fair value hierarchy.

(d) Payment of Benefits

Benefits are recorded as expense when paid.

(2) Description of Plan

The following description of the Plan provides only general information. Participants in the Plan should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan became effective on January 1, 1983 as a defined contribution plan. The Plan is sponsored by Saint Mary's School (the "School") and was most recently amended effective January 1, 2023. The Plan covers all eligible employees of the School which generally includes all employees except those who normally work fewer than 20 hours per week. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

(b) Contributions

Eligible employees may contribute to the Plan as soon as reasonably practicable after the effective date of their election to participate. Years of service with another eligible institution preceding the employee's date of employment with the School were recognized for purposes of eligibility for employer matching contributions.

As of September 1, 2019, participants were eligible for matching contributions beginning the first day of the first month following their date of hire. As of November 1, 2020, participants may make contributions on irregular compensation such as bonuses.

As of January 1, 2023, participants are eligible to contribute to the Plan and receive employer matching contributions immediately upon hire.

Once eligible for the employer match, the School will make a matching contribution equal to 100% of employee contributions not to exceed 5% of employee compensation.

Participants can deposit "rollovers" (distributions from other qualified plans) into the Plan.

(2) Description of Plan, Continued

(c) Participant Accounts

Each participant's account is credited with the employee's contributions, the School's contribution and plan investment return. Allocations are based on participants' account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

Participants are 100% vested in their contributions, the School's mandatory and matching contributions and their rollover contributions to the Plan.

(e) Investment Options

Participants are able to select from investments in numerous registered investment companies, a pooled separate account, and an unallocated insurance contract as provided by TIAA-CREF. These investment vehicles do not transfer any benefit obligation or related risk from the Plan to TIAA-CREF.

(f) Administrative and Investment Costs

Certain administrative costs are absorbed by the School. Investment management fees are charged to the individual funds in the Plan and are included in the net appreciation (depreciation) in the fair value of investments.

(g) Loans to Participants

Loans to participants are made by the Plan custodian, not the Plan, and therefore, are excluded from the Plan's net assets. If a participant defaults on his/her loan, the participant's account is segregated as collateral for the defaulted amount.

(h) Payment of Benefits

Generally, participants become eligible to receive benefits on their normal retirement age (65), in-service withdrawals beginning at age 59½, death, or termination of employment. Participants may receive 100% of their account balance in a variety of annuity options or a lump sum. Purchased individual annuity contracts are not included in Plan assets.

Effective April 1, 2020, the Plan was amended to include a mandatory force-out distribution to terminated participants whose vested benefits do not exceed \$7,000.

(3) Federal Income Taxes

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (the "Code"). The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b). The Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable provisions of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. No provision for income taxes has been included in the Plan's financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

(4) Certified Financial Data

As discussed in note 1, fixed annuity contracts consist of an investment option available to participants known as the TIAA Traditional Annuity. These contracts are established between the participants and TIAA, an insurance company registered in the state of New York. The TIAA Traditional Annuity investment option is offered in two formats, the Retirement Choice and the Retirement Choice Plus.

TIAA Traditional Annuity accounts are credited with a guaranteed minimum rate of interest that is determined annually. Participants may also earn interest in addition to the guaranteed rate at the discretion of TIAA. Such discretionary interest, if any, is declared by TIAA on a year-by-year basis and remains in effect for the subsequent twelve-month "declaration year". Contributions to the TIAA Traditional Annuity accounts are grouped by TIAA into "vintages" comprised of premiums received over defined time periods of one or more continuous calendar months.

Non benefit-responsive

Retirement Choice account balances may only be withdrawn either over an 84-month period in monthly systematic payments, or in lump sum, but such withdrawal is subject to a 2.5% surrender charge. These provisions are considered to restrict participants of their "reasonable access" to their contract balances, and the balances are not considered to be fully benefit-responsive investment contracts. As of December 31, 2024 and 2023, respectively, non-fully benefit-responsive investment contracts totaled \$3,475,489 and \$3,434,069.

Fully benefit-responsive

Retirement Choice Plus account balances are considered to be fully benefit-response investment contracts, because they are fully liquid and immediately cashable once a participant terminates employment with the School. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. This contract maintains the participants' contributions plus a specified rate of interest and is guaranteed by TIAA's claims paying ability. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Contributions to a participant's account provide a guaranteed amount of lifetime annuity income. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. As of December 31, 2024 and 2023, respectively, fully benefit-responsive investment contracts totaled \$637,532 and \$571,471.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the *Internal Revenue Code* or the failure of the trust to be tax-exempt under Section 501(a) of the *Internal Revenue Code*
- Premature termination of the contracts
- Plan termination or merger
- Changes to the Plan's prohibition on competing investment options
- Other Plan sponsor events that significantly affect the Plan's normal operations

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines
- A breach of material obligation under the contract
- A material misrepresentation
- A material amendment to the agreements without the consent of the issuer

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

Retirement Choice account balances are stated at fair value, and Retirement Choice Plus account balances are stated at contract value in the accompanying statements of net assets available for plan benefits. The Plan custodian has represented that contract value approximates fair value for both types of accounts.

(6) Plan Termination

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

(7) Related Party Transactions

Certain Plan investments are managed by TIAA-CREF. TIAA-CREF is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Investment management fees are charged to the individual funds in the Plan by TIAA-CREF and qualify as party-in-interest transactions.

(8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits.

(9) Subsequent Events

The date to which events occurring after December 31, 2024, the date of the most recent statement of net assets available for plan benefits, have been evaluated for possible adjustment to the financial statements or disclosure is October 9, 2025 the date the financial statements were available to be issued.
