1. Description of the Plan

The following description of the Doggett Company, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan which provides for profit-sharing and other incidental benefits for eligible employees of Doggett Company, LLC and affiliates (the "Company" or "Employer"). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan Committee has the responsibility of supervising and directing the administrative activities of the Plan and is the plan fiduciary.

Administration

The Plan is administered by the Company. The record-keeper and trustee for the Plan's assets is Fidelity Management Trust Company ("FMTC" or the "Trustee").

Eligibility

An employee becomes eligible to participate in the Plan after completion of one month of credited service and attaining the age of 21 years. An employee may begin contributing to the Plan at the first pay period after the eligibility requirements have been met.

Contributions

Participant Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. In addition, participants may separately elect to defer up to 100% of any bonuses paid to them during the year. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants. Contributions are subject to certain limitations.

Contributions, continued

Employer Contributions

The Employer may make a discretionary pretax matching contribution to each participant's account. During 2024, the Employer contributed 50% of the first 6% of compensation that a participant contributed to the Plan. The amount is determined annually by the Employer. Additionally, the Employer may make discretionary profit sharing contributions on behalf of each participant in an amount to be determined by management at the end of the Plan Year. No profit sharing contribution was made for 2024. Employer contributions do not begin until after six months of service.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's contribution and, (b) Plan earnings, and charged with transaction and service-based fees and an allocation of administrative expenses, if applicable. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and Employer profit sharing contributions plus actual earnings thereon. Participants who were employed prior to November 1, 2007, are at all times vested in Employer's matching contributions plus actual earnings or losses thereon. Participants who were employed after November 1, 2007, are vested in the Employer's matching contributions plus actual earnings or losses thereon based on years of continuous service. Vesting in the Employer's matching contributions and earnings is in accordance with the following schedule:

Forfeited Accounts

Forfeited balances of terminated participants' nonvested accounts are used by the Plan to pay administrative expenses or reduce future Employer contributions of the Plan. For the year ending December 31, 2024, the Plan utilized forfeitures of \$133,676 to pay Employer contributions and \$29,874 to pay for administrative expenses. The unallocated forfeitures balance as of December 31, 2024 and 2023 was \$102,568 and \$51,758, respectively.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest. Principal and interest is paid ratably through after-tax payroll deduction. All loans must be repaid within five years, unless used to purchase a principal residence which carries a longer repayment term, and have associated fees. A participant may have two outstanding loans at a time.

Payment of Benefits

On termination of service due to death, disability, or normal retirement, a participant (or beneficiary in case of death) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or partial withdrawals or installments over a period of time, or a rollover or direct transfer. Upon termination of employment, distributions of vested account balances can be made at the participant's election in a lump-sum payment or a rollover or direct transfer. If a participant's vested account balance is not greater than \$5,000, it will be paid automatically in a lump-sum payment as soon as administratively feasible after the event that entitled a distribution.

Participants may receive a distribution from the Plan prior to termination of employment provided they have attained age 59 1/2. A hardship distribution may also be made to satisfy certain immediate and heavy financial needs.

2. Summary of Significant Accounting Policies

The following is a description of significant accounting policies followed by the Plan in the preparation of its financial statements:

Basis of Accounting

The accounting records of the Plan and the Form 5500 prepared by FMTC are maintained and presented on the cash basis. The accompanying financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of the Plan's financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and Statement of Changes in Net Assets Available for Benefits.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Net depreciation in fair value of investments includes realized gains and losses on investments sold during the year and unrealized appreciation (depreciation) of investments held at the end of the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded when earned. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Fees

Administrative fees incurred by the Plan in 2024 include advisory fees of \$122,211, recordkeeping fees of \$57,232, consultant fees of \$19,669, and audit engagement fees of \$16,500. All other expenses of maintaining the Plan are paid by the Employer or participants.

Excess Contributions

Amounts payable to participants totaling \$292,047 and \$325,793 as of December 31, 2024 and December 31, 2023, respectively, for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as excess contributions, with a corresponding reduction to contributions from participants. The Plan distributed the excess contributions prior to March 15 of each respective year.

3. Income Tax Status

The Company adopted a volume submitter profit sharing plan with CODA sponsored by the Trustee. The volume submitter plan received a favorable opinion letter from the IRS dated June 30, 2020, which stated that the volume submitter plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("IRC"). The Company believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

U.S. GAAP requires the Company to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Furthermore, 2021 and later remain subject to examination by the IRS.

5. Fair Value Measurements

The Financial Accounting Standards Board Accounting Standards Codification Topic 820 ("ASC 820") establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets or liabilities that the reporting entity can access at the measurement date; Level 2 inputs consist of inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly; and Level 3 inputs consist of unobservable inputs for the asset or liability. Level 1 is given the highest priority while Level 3 is given the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure fair value of its investments.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

In determining fair value, the Plan uses the market approach, which uses prices and other relevant data based on market transactions involving identical or comparable assets and liabilities.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Registered investment companies ("mutual funds"): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: Valued at the NAV of units of the common collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common collective trust, the investment adviser reserves the right to temporary delay withdrawals from the trust in order to ensure that securities liquidations will be carried out in an orderly business matter.

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value at the reporting date.

6. Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Fidelity Investments. FMTC is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to FMTC in 2024 totaled \$57,232.

The Plan issues notes receivable from participants and certain fees to the Trustee for the daily operational services of the Plan. These transactions qualify as party-in-interest transactions, as defined by ERISA. However, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

7. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

9. Delinquent Participant Contributions

For the year ended December 31, 2024, the Company determined that certain employee deferrals aggregating \$324,259 had not been remitted to the Plan in a timely manner, according to DOL regulations. An investigation was held to determine the root cause of the delinquent contributions, and corrective measures are being conducted. The Plan Administrator is in the process of calculating the lost earnings, if any, from these delinquent contributions and will process and deposit any lost earnings to participant accounts as soon as is practical.
