Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Axley Brynerson, LLP 401(k) Savings & Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Opinion

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). NOTE 1 DESCRIPTION OF PLAN

The following description of Axley Brynelson, LLP 401(k) Savings & Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan originally effective August 1, 1984. The Plan has been amended throughout the years to comply with tax legislation and most recently amended effective May 1, 2024. The Plan excludes leased employees, nonresident aliens, and employees covered by a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees of Axley Brynelson, LLP (the Company) are eligible to participate in the deferral component of the Plan once employees completed one year of service, defined as 1,000 hours. Participants are eligible for the Employer discretionary contribution if they meet the eligibility requirements above and are employed on the last day of the Plan year and must be credited with at least 1,000 hours of service during the Plan year to be eligible.

Contributions

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, up to 80% as limited by Plan provisions, of their compensation contributed as pre-tax 401(k) contributions to the Plan. Effective January 1, 2024 the Plan has been restated to also allow Roth contributions to the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation, and their contributions invested in the designated default fund until changed by the participant. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Employer's Executive Committee may authorize a discretionary profit-sharing contribution to the Plan. The contribution is allocated pro rata to eligible employees based on their annual compensation. Discretionary contributions of \$1,881,245 and \$1,796,181 were made for the years ended December 31, 2024 and 2023, respectively.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with (a) the participant's salary reduction contributions, (b) rollover contributions, (c) an allocation of the Employer's contributions, (d) Plan investment income, and (e) forfeitures. Each participant's account is charged with an allocation of (a) Plan investment losses, (b) administrative expenses, and (c) any distributions requested by the individual participant. Allocations are based on the participant's eligible compensation, account balances, or specific participant transactions, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately fully vested in their salary reduction contributions and rollover contributions, including the earnings attributable to them. Participants, who leave the Plan because of death, normal retirement, or disability retirement, as defined in the Plan, are considered fully vested in their account balance related to Employer contributions. Vesting in the Employer discretionary contribution portion of their accounts, plus actual earnings thereon, is based on years of credited service. A participant is 100% vested after six years of credited service.

Investment Options

Participants are allowed to direct the investment of contributions into three unitized funds offered by the Plan.

Benefit Payments

Benefits may be paid to the participant or beneficiary upon death, disability, retirement, or termination of employment, as defined in the Plan agreement. The Plan provides for normal retirement at age 65. Participants with a vested balance in excess of \$7,000 as of December 31, 2024 (\$5,000 as of December 31, 2023) may receive their benefits in the form of a lump sum, installments, or an annuity. Vested account balances of \$7,000 or less as of December 31, 2024 (\$5,000 as of December 31, 2023) are distributed in a lump-sum payment.

In-service distributions are available to those participants who have reached age 59½ and are still employed by the Company. In-service distributions can be all or a portion of the participants' vested account balance. As of December 31, 2024 and 2023, there were no distributions that were requested by a participant that had not yet been distributed.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$5,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest rates at the prime interest rate plus one percentage point. Principal and interest are paid ratably through payroll deductions over a maximum 5-year period unless the loan is for the purchase of a principal residence, in which case the loan cannot exceed 10 years.

Forfeited Accounts

Forfeitures arise as a result of participants who separate from service with the Employer before becoming 100% vested in the Employer's discretionary contributions. Forfeitures are used to pay Plan expenses or are used to reduce discretionary Employer contributions. Forfeited nonvested accounts as of December 31, 2024 and 2023 totaled \$-0-. Forfeitures of \$-0- were used to reduce Employer contributions during the years ended December 31, 2024 and 2023. Forfeitures of \$60,334 and \$34,160 were used to reduce Plan expenses during the years ended December 31, 2024 and 2023, respectively.

Administration

The Company is the administrator of the Plan and has appointed Matrix Trust Company as trustee and custodian. OneAmerica Retirement Services, LLC was appointed as recordkeeper. The custodian is responsible for investing and safekeeping all of the assets of the Plan.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting. Accordingly, participant and Employer contributions are recorded when due from the participants and Axley Brynelson, LLP (the Employer).

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees charged quarterly are included in administrative expense. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued.

Effective September 16, 2025, the Plan was restated to change the name of the Plan to Axley LLP 401(k) Savings and Profit Sharing Plan. The Plan Sponsor's name was also changed to Axley LLP.

NOTE 3 INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

Matrix Trust Company, the qualified institution of the Plan, has certified to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Registered Investment Companies: Shares of registered investment companies (RICs) are valued at the daily closing price as reported by the fund. RICs held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The RICs held by the Plan are deemed to be actively traded.

NOTE 5 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer may terminate the Plan at any time subject to the provisions of ERISA. Upon permanent discontinuance of the Plan, its participants' accounts shall become fully vested. In the event of Plan termination, distributions to participants will be made in accordance with the provisions of the Plan. The trust will continue until all funds have been disbursed.

NOTE 7 TAX STATUS

The Employer has adopted the OneAmerica Financial Partners, Inc. Volume Submitter Profit Sharing Plan which obtained an opinion letter in which the IRS stated that the Volume Submitter Plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and the related trust is tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Matrix Trust Company, the qualified institution of the Plan. Therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management, recordkeeping, and trustee services qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
