Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Louisville Tile Distributors, Inc. Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not to extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audits of the Financial Statements* section of our report:

Notes to the Financial Statements

December 31, 2024 and 2023

(1) Description of plan

The following description of the Louisville Tile Distributors, Inc. Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan Adoption Agreement and Summary Plan Description, for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan which was adopted to provide retirement benefits for employees of Louisville Tile Distributors, Inc. (the "Plan Sponsor"). The Plan covers substantially all employees who are age twenty-one or older and have completed one month of service ("participants"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

(b) Contributions

Contributions to the Plan are made by the participants and the Plan Sponsor. Participants may elect to defer up to 100% of their pre-tax annual compensation, after-tax Roth elected deferrals, or a combination of both, as defined by the Plan and consistent with the Internal Revenue Service ("IRS") limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Additionally, participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3% of eligible compensation. This deferral rate will not increase unless the participant elects to do so. The Plan provides for contributions to be invested at the participant's direction in various investment options offered by the Plan. The Plan currently offers investment directives including mutual funds and a money market fund.

The Plan Sponsor may make contributions equal to a discretionary matching percentage. In addition, the Plan Sponsor may make discretionary contributions to the Plan from its net profits for the year. Plan Sponsor and participant contributions may not exceed the maximum amount deductible for federal income tax purposes. The Company matched 50% of the first 6% of compensation earnings contributed to the Plan by a participant for 2024 and 2023, respectively.

(c) Participant accounts

Each participant's account is credited (charged) with the participant's contributions and allocations of Plan Sponsor contributions, investment earnings, and administrative expenses. Allocations are based on participant's compensation or account balances as defined in the plan agreement. The benefit to which a participant is entitled was the benefit that could be provided from the participant's vested account.

(d) Vesting

Participants are vested immediately in their elective salary deferral contributions plus actual earnings thereon. On termination of service due to death, disability or retirement, a participant is fully vested in the Plan Sponsor matching portion of their account and actual earnings thereon. For termination of service for other reasons, vesting in the Plan Sponsor's discretionary contributions, plus any earnings thereon, is based on three years of continuous service, according to the vesting schedule below:

(e) Forfeited accounts

Forfeitures are created when participants terminate employment prior to becoming fully vested in the applicable Plan Sponsor contribution portions of their accounts. Such forfeitures are used to pay reasonable plan expenses or used to reduce Plan Sponsor's contributions to the Plan. Forfeited nonvested accounts totaled \$51,709 and \$24,622 at December 31, 2024 and 2023, respectively. There were no forfeitures utilized during 2024 and 2023.

(f) Payment of benefits

Upon termination of service for any reason, a participant may elect to receive either a lump-sum amount or rollover payment equal to the vested value of his or her account on termination of service due to death, permanent disability, or retirement, a participant may elect to receive a lump-sum payment equal to his or her entire account. For termination of service due to other reasons, a participant will be entitled to receive only the vested interest in his or her account as a lump-sum distribution.

(g) Participant notes receivable

Participants may borrow from their pre-tax accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of participants vested account balance. The participant notes receivable are secured by the balance in the participant's account and bear interest at fixed rates ranging from 7.50% to 8.50%, which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are collected ratably through payroll deductions.

(h) Hardship withdrawals

The Plan permits distributions in the event of a hardship, as defined in the plan agreement. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½. Hardship withdrawals were limited to the participant's elective and vested account balance.

(i) Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Transaction expenses are charged directly to the participants' accounts and are included in administrative expenses. Fees incurred by the Plan for recordkeeping and investment management services are included in net appreciation in fair value of investments.

(j) Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the plan agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

(2) Summary of significant accounting policies

(a) Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

(b) Investment valuation and income recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Payment of benefits

Benefits are recorded when paid.

(d) Participant notes receivable

Participant notes receivable are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant notes receivable are reclassified as distributions based upon the terms of the plan document.

(e) Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(f) Events occurring after reporting date

The Plan Sponsor has evaluated events and transactions that occurred between December 31, 2024, and October 13, 2025, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Certified information

Certain information related to investments and participant notes receivable reported and disclosed in the accompanying financial statements and supplemental schedule of assets (held at end of year), including the fair value of investments and participant notes receivable held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income on participant notes receivable for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Ascensus, LLC, as an agent for Ascensus Trust Company and Newport Trust Company, LLC ("Ascensus").

(4) Fair value measurements

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Money market fund*: Valued at the net asset value ("NAV") of shares held by the Plan at year-end. The money market fund is redeemable daily, and there are no restrictions on redemptions.
- Mutual funds*: Valued based on the funds' reported NAV as of the last business day of the plan year. The mutual funds are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Income tax status

The Plan Sponsor adopted a pre-approved non-standardized profit sharing plan which received a favorable opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020, which stated that the prototype plan was designed in accordance with the applicable sections of the IRC. The Plan itself has not received a determination letter from the IRS stating that the Plan is qualified under Section 401(a) of the IRC. However, the plan administrator believes that the Plan, as amended, is designed and is currently being operated in compliance with the applicable requirements of the IRC, and is therefore, qualified and exempt from taxation.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(6) Risks and uncertainties

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

(7) Related party and party-in-interest transactions

Certain Plan investments included shares of money market and mutual funds that are managed by The Vanguard Group, Inc. or affiliated companies, the recordkeeper of the Plan. Therefore, these transactions qualify as party-in-interest transactions under ERISA. As described in Note 1, the Plan paid expenses to various service providers and holds participant notes receivable which qualify as party-in-interest transactions.
