NOTE 1: DESCRIPTION OF THE PLAN

The following description of the Diesel USA, Inc. 401(k) Savings Plan (the Plan), is provided for general information purposes only. Participants should refer to the Plan document for a more detailed explanation of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Diesel, Inc., Staff International USA, Inc, Marni USA, Inc., and Mariela USA, Inc. (the Company) who have attained 21 years of age and have completed 60 days of service. The Plan excluded non-resident aliens and part-time employees working less than 1,000 hours. Effective April 1, 2016, the Plan was amended to also exclude employees covered by a collective bargaining agreement and to include non-resident aliens.

Great-West Life & Annuity Insurance Company and Great-West Trust Company, LLC (Great-West) are the trustees of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to make pre-tax contributions, subject to the statutory limitation as provided for in the Internal Revenue Code (IRC). Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants may direct the investment of their account balance into various investment options offered by the Plan. The Plan allows for a discretionary matching contribution. During 2024, the Company matched 50% of the first 5% of eligible compensation that participants contributed to the plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and Plan earnings and charged with withdrawals and an allocation of administrative expenses and Plan losses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1: DESCRIPTION OF THE PLAN - CONTINUED

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of the participant's account plus earnings thereon is based on the vesting schedule below:

1	25%
2	50%
3	75%
4	100%

The Company considers one year of service to be at least 1,000 hours worked. Participants' interest in their accounts shall become 100% vested and nonforfeitable without regard to their credited years of service if they are employed by the Company on or after age 65, incur a permanent disability, die while employed by the Company, or if the Plan is terminated.

Forfeitures

In accordance with the Plan document, forfeitures of non-vested employer contributions and earnings thereon are used to pay for administrative expenses of the Plan or to reduce future employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$73,705 and \$31,717, respectively.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 and a maximum equal to the lesser of (a) \$50,000 reduced by the highest outstanding loan balance during the previous 12 months, or (b) 50% of their vested account balance. A participant may have a maximum of two loans outstanding at any time. The loans bear interest at a rate equal to the prime rate plus 1%. Generally, loans must be repaid within five years, unless for the purchase of a primary residence.

Payment of Benefits

The Plan has provisions for in-service, hardship, disability, death and termination benefits for those participants who are eligible to receive such benefits. Distributions can be lump-sum payments or substantially equal installments.

Administrative Expenses

The Plan allows for payment of administrative expenses by the Company or the Plan.

Revenue Credit Account

The Plan has a Revenue Credit Account, which is a suspense account funded with excess revenue generated by the Plan. During the year ended December 31, 2024, the Plan received revenue credits of \$5,722 which are included in interest and dividends on the statement of changes in net assets available for benefits. These funds may be used to pay Plan expenses. During 2024, \$5,722 of Plan expenses were paid from the Revenue Credit Account. At December 31, 2024 and 2023, the balance in the Revenue Credit Account totaled \$0.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared using the accrual basis of accounting.

Investment Valuation and Income Recognition

Except for the guaranteed interest account held by Great-West, investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities and changes therein. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the Plan document.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – CONTINUED

Excess Contributions Payable

At December 31, 2024 and 2023, the Plan does not have a liability for amounts refundable by the Plan to participants for contributions made in excess of amounts allowed under the IRC.

Risks and Uncertainties

The Plan invests in various investment securities which are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with these securities, it is at least reasonably possible that changes in their values will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

NOTE 3: FAIR VALUE MEASUREMENT

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan follows the fair value measurement guidance required by accounting principles generally accepted in the United States of America for financial and nonfinancial assets and liabilities. This guidance defines fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value.

Registered Investment Companies: These investments are valued using the net asset value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4: GREAT WEST INVESTMENT CONTRACT

The Plan has entered into a benefit-responsive investment contract with Great-West. Great-West maintains the contributions in a guaranteed portfolio fund account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract.

Contract value, as reported to the Plan by Great-West, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer and is reviewed on a quarterly basis for resetting. The minimum gross interest credit rate under the contract will never be less than 0%. The interest credit rate earned by the Plan for the years ended December 31, 2024 and 2023 were 1.81% and 1.59%, respectively.

NOTE 4: GREAT WEST INVESTMENT CONTRACT (CONTINUED)

Certain events limit the Plan's ability to transact at contract value with Great-West. Such events include the following: (a) amendments to the plan documents (including complete or partial plan terminations or merger with another plan), (b) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with Plan participants, is probable.

NOTE 5: PLAN TERMINATION

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

NOTE 6: TAX STATUS

The Plan adopted a non-standardized form of a prototype plan. The prototype plan has received an opinion letter dated March 31, 2014, from the Internal Revenue Service (IRS) as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan has been amended since the prototype plan received the opinion letter. However, the Plan Administrator believes that the Plan is currently designed and is being operated in compliance with the applicable provision of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7: FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The guaranteed investment contract is managed by Great-West. Great-West is the trustee as defined by the Plan and therefore, transactions with this investment qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.

NOTE 9: SUBSEQUENT EVENTS

In preparing the financial statements, management has evaluated events and transactions for potential recognition or disclosure through October 7, 2025, the date that the financial statements were available to be issued.
