Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Apparel Group, Ltd. Notes to Financial Statements

1. Description of Plan

The following description of The Apparel Group, Ltd. Employee Savings and Protection Plan (the “Plan”) provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all employees of The Apparel Group, Ltd., Size Stream, LLC., and J. Hilburn, Inc., companies related through common ownership (collectively, the “Company”). An employee who has attained the age of 20 and has worked three consecutive months is eligible to participate in the Plan as of the first day of the month coinciding with or following the date the employee has satisfied such requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Contributions

Eligible employees will be automatically enrolled to defer 3% of pre-tax compensation unless they elect an alternative deferral percentage or decline participation in the Plan. Participants may otherwise elect to contribute up to 100% of their pre-tax and after-tax compensation, as defined by the Plan, not to exceed the limit set by the Internal Revenue Service (“IRS”). Participants who have attained age of 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”). During 2024 and 2023, the Company made safe harbor matching contributions equal to 100% of participant contributions up to 5% of compensation as defined by the Plan. The Plan also includes a discretionary profit sharing contribution, which is determined annually by the Company. Discretionary profit sharing contributions are allocated to participants based on the percentage of each participant’s compensation to total compensation of all eligible participants. However, no discretionary profit sharing contributions were made for 2024 or 2023.

Upon enrollment in the Plan, a participant may direct participant and Company contributions in any of the investment options offered through the Plan. Participants may change their investment options and deferral percentages at any time.

Participant Accounts

Each participant’s account is credited with the participant’s and the Company’s contributions and an allocation of the Plan’s net earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their voluntary contributions, the Company’s contributions, plus any income or loss thereon.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or separation, a participant may elect to receive a lump-sum payment or installment payments. In-service distributions may be made to participants who have reached the age of 59½. Withdrawals from the Plan may also be made upon circumstances of financial hardship or disability, in accordance with the provisions specified in the Plan.

Forfeitures

Forfeitures from non-vested participant accounts may be used to offset plan expenses or future Company contributions. During 2024 and 2023, forfeitures of approximately \$7,000 and \$5,300 were utilized to offset administrative expenses or the Company's matching contributions. As of December 31, 2024 and 2023, forfeitures of \$0 and approximately \$7,000 were available to offset future administrative expenses or Company matching contributions.

Notes Receivable from Participants

A vested participant may borrow from their account a minimum of \$1,000 up to a maximum of one-half of the vested portion of the participant's account, not to exceed \$50,000. Interest is charged at the prime rate plus 1% as of the origination date. Notes are secured by the participant's vested account balance and are stated at the outstanding principal balance. The terms of the participant notes are five years unless used to purchase a principal residence for which the term can be up to 10 years. Participants may have up to two notes at a time. Principal and interest are paid ratably through payroll deductions.

Administrative Expenses

The Company absorbs certain expenses incidental to the administration of the Plan, including internal administrative costs. Other fees, including trustee, recordkeeping, and asset, are paid by the Plan. Distribution and loan fees are paid out of the affected participant accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management has evaluated events occurring subsequent to the date of the financial statements through October 8, 2025, the date the financial statements were available to be issued, and has determined that no events have occurred that require adjustments to or additional disclosure in the financial statements.

3. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company, the trustee of the Plan.

4. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

5. Income Tax Status

The Plan has adopted a prototype plan document sponsored by Principal Life Insurance Company ("PLIC"). The IRS has determined and informed PLIC by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since the date of the determination letter; however, the plan administrator believes that the Plan is designed and is currently being operated in compliance with applicable provisions of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

7. Party-in-Interest Transactions

Fees paid by the Plan to PLIC for administrative services were approximately \$103,000 and \$92,000 and in 2024 and 2023.

8. Fair Value Measurements

The Plan adopted Accounting Standards Codification 820, “Fair Value Measurements and Disclosures” (“ASC 820”), which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under ASC 820 are as follows:

Basis of Fair Value Measurements

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the net asset value (“NAV”) of shares held by the Plan at year-end. The NAV for these investments is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

Common collective trust funds: Valued at NAV as determined by the issuer using estimated fair value of the underlying assets, minus liabilities, held in the funds. These investments are classified within Level 2 of the valuation hierarchy because the unit value is quoted on a private market that is not active; however, the unit value is based on the underlying investments, which are traded on an active market.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
