1. Summary of Significant Accounting Policies

This summary of significant accounting policies of Chobani Global Holdings, LLC 401(k) Profit Sharing Plan & Trust (the “Plan”) is presented to assist in the understanding of the Plan’s financial statements. The financial statements and notes are representations of the Plan’s management who is responsible for their integrity and objectivity. The accounting policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements, except as disclosed below. The Plan’s financial statements are prepared on the accrual basis of accounting.

The preparation of the Plan’s financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Benefits are recorded when paid.

The Plan provides for various investment options including mutual and stable value funds. The underlying investments are stocks, bonds, fixed income securities and other investment securities. Investment securities are subject to risks including interest rate, market and credit risks. These risks make it at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

2. Plan Description

The following description of Chobani Global Holdings, LLC 401(k) Profit Sharing Plan & Trust provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a 401(k) defined contribution plan covering all eligible employees, as defined, of Chobani Global Holdings, LLC and Subsidiaries (collectively referred to as the “Company”). The Plan was established effective January 1, 2011. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Eligible employees may participate in the Plan on the first day of the month immediately following the employee’s first day of employment, provided the employee is age eighteen or older. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan following 60 days from date of employment, if not already enrolled. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Plan is administered by the Company. All funds and investments are held in accounts or invested in mutual funds, under a service agreement with the trustee, Fidelity Management Trust Company for the Plan and, therefore, qualify as a party in interest. In addition, the Plan issues notes receivable to participants, which are secured by the balances in the participants’ accounts. Therefore, related transactions qualify as party-in-interest transactions. All other transactions which may be considered party-in-interest transactions related to normal Plan management and administrative services, and the related payment of fees.

Effective December 15, 2023, Chobani Global Holdings, LLC acquired La Colombe Holdings. Effective December 31, 2024, Chobani Global Holdings, LLC merged the La Colombe Holdings 401(k) plan into Chobani Global Holdings, LLC 401(k) Profit Sharing Plan & Trust.

Contributions

Each year, participants may contribute up to 92 percent of their eligible pay, subject to the limitation provisions of the Internal Revenue Code (IRC), on a before-tax or after-tax basis or a combination of both. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Amounts transferred from other plans maintained by the Company, as allowed by the Plan, are included in transfers of assets to the Plan. Transfers initiated by the other plan, not received by the Plan are recorded as transfers receivable.

The Company has a Safe Harbor matching contribution for all employees. Effective January 2024, under the Safe Harbor matching contribution, the Company will make a matching contribution based on the participants’ deferral contribution of up to 100% of the first 4% of the participants’ compensation, as defined in the Plan, plus 50% of participants’ compensation of the next 1% of participants’ compensation not to exceed 6% of eligible compensation. Prior to January 2024, the Company made a matching contribution based on the participant’s deferral contribution of up to 100% of the first 3% of the participants’ compensation, as defined in the Plan, plus 50% of participants’ compensation of the next 2% of participants’ compensation not to exceed 5% of eligible compensation.

Contributions, Continued

The Plan also provides for discretionary profit-sharing contributions. Contributions to the Plan by the Company are determined by the Company's Board of Directors. Employees are eligible in the pay period following completion of one year of service with the Company. The contribution is not to exceed the maximum amount allowable as a deduction under Section 404 of the Internal Revenue Code.

The Company did not make discretionary contributions for 2024 or 2023.

Participants direct the investments of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a stable value fund as investment options for participants. Employer matching contributions that the Company makes on behalf of the participants are directed pro-rata to the same investment options as the employee contributions.

Participant Accounts

Each eligible participants' account is credited with the participants' contributions, related employer contributions, allocations of Plan's earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on the proportion of each participants' account balance to the total of all participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participants' vested account balance.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000 reduced by the highest outstanding loan balance (if any) in their account during the prior twelve month period. Loan repayment may not exceed a period of more than 5 years, unless for the purchase of a primary residence, in which case, the maximum duration may not extend beyond 10 years. The loans are collateralized by the vested balance in the participant's account and bear interest at rates equal to the prime rate as of the last business day of the month prior to the issuance of the loan plus 1%. At December 31, 2024, loan interest rates ranged from 4.25% to 9.50%. Principal and interest is paid ratably through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Vesting

Participants are 100% vested in their Plan account with respect to individual contributions, rollover contributions and the Company's matching contribution, plus actual earnings thereon.

Vesting in profit sharing contributions by the Company is based on years of service according to the following schedule:

A participant will be 100% vested in profit sharing contributions upon termination of employment due to death or disability.

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$26,504 and \$13,562, respectively. These accounts will be used to reduce future employer contributions. During 2024 and 2023, \$11,998 and \$632, respectively, of forfeitures were used to reduce employer contributions.

Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either periodic payments, annuities or a lump sum amount equal to the value of the participant's vested interest in his or her account.

Investment Management and Administrative Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation (depreciation) in fair value of investments presented in the accompanying statements of changes in net assets available for benefits. Investment management and administrative expenses paid out of the Plan assets during 2024 and 2023 amounted to \$108,461 and \$99,406, respectively.

3. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits.

Fair Value Inputs

Various inputs are used to determine the fair value of the Plan's investments. These inputs are summarized in the three broad levels listed below:

Level 1 - Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Observable inputs other than Level 1 quoted prices (including, but not limited to, quoted prices for similar securities, interest rates, prepayment speeds and credit risk)

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable value funds: Valued at the NAV of the individual collective trust fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investments for an amount different than the reported NAV.

4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their profit-sharing contributions account balance.

5. Tax Status

The prototype Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan is designed in accordance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognized a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations from years prior to 2021.

6. Certified Information

Certain information disclosed in the accompanying financial statements and ERISA - required supplementary schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by the trustee of the Plan.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Subsequent Events

Management believes no further events occurred through October 13, 2025, the date the financial statements were available to be issued, that require adjustment of, or disclosure in, the accompanying financial statements.
