We have performed audits of the accompanying financial statements of Educators for Excellence Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Note 1 – Description of Plan

The following description of the Educators for Excellence Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established on January 1, 2011 and subsequently amended and restated. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). All employees of Educators for Excellence, Inc. (the “Organization”), who are age 21 or older are eligible to participate in the Plan. The Plan Administrator is responsible for oversight of the Plan and determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Contributions

Each year, participants may contribute up to 100% of their pre-tax annual compensation, subject to certain limitations set under the Internal Revenue Code (the “Code”). The Plan also allows for after-tax contributions to be made. Participants may also contribute rollover amounts representing distributions from an eligible retirement plan. New employees are automatically enrolled into the Plan at a 3% salary deferral amount once they meet the above eligibility requirements. Eligible employees have the option to “opt out” of the Plan. The Organization may make discretionary matching contributions equal to the uniform percentage of salary deferrals. For 2024, the Organization elected to contribute an amount equal to 50% of participant elective deferrals up to 6% of compensation.

Investment options

Each participant may direct their investment accounts into certain available investment options. The assets of the Plan are allocated to the applicable funds at the direction of the participant.

Management fees and operating expenses charged to the Plan for investments are deducted from the individual investments and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Participant accounts

Each participant’s account is credited with the (a) participant’s contributions, (b) allocations of the Organization’s contributions, and (c) Plan earnings net of an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately 100% vested in their contributions plus actual earnings thereon. Participants have a 2-year schedule to vest for the Organization’s discretionary matching contributions with participants 50% vested after one year and fully vested after two years.

Note 1 – Description of Plan (continued)

Forfeitures

Forfeitures are entered when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures may be used to pay Plan expenses or reduce future employer contributions. As of December 31, 2024 and December 31, 2023, forfeited non-vested accounts totaled \$196 and \$2,673, respectively. For the year ended December 31, 2024, forfeitures totaling \$4,764 were used to reduce employer contributions.

Participant notes receivable

Under the terms of the Plan, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. The term of participant loans may not exceed five years and participants can only have one outstanding loan. Loans bear interest at a rate equal to the Wall Street Journal Prime Rate plus 1%. Principal and interest are paid through payroll deductions.

Payment of benefits

Upon termination of service, retirement, death, or total permanent disability, a participant or their beneficiary may elect to receive a distribution of his or her entire accumulated Plan balance, subject to the terms of the funding vehicles. Distribution options include lump-sum payments or direct rollover to another qualified plan. In addition, participants may elect in-service withdrawals of their elective deferral account balances after reaching age 59-1/2. Participants may also elect in-service withdrawals of their elective deferral account balances in the case of a hardship. Minimum required distributions for participants who have reached a certain age also apply per Internal Revenue Service (“IRS”) regulations.

Plan termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their accounts.

Note 2 – Summary of significant accounting policies

Basis of accounting

The Plan’s financial statements are prepared on the accrual basis of accounting, except for benefits paid which are recorded on a cash basis.

Investment valuation and income recognition

The Plan's investments are stated at contract value.

Realized and unrealized gains and losses from the assets in each account are credited to or charged against each participant's account.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date.

Administrative expenses

General administrative expenses of the Plan are paid by the Organization and are not reflected in the accompanying financial statements. Certain other transaction-related participant expenses, such as those associated with loan maintenance and administration, are paid by the Plan and are included in the accompanying financial statements.

Certain administrative functions are performed by officers or employees of the Organization. No such officer or employee receives compensation from the Plan.

Risks and uncertainties

The Plan's investments are exposed to various risks such as interest rate, market, credit and liquidity risks. Due to the level of risk associated with investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits as of December 31, 2024. The Plan's investments are not insured or protected by the Pension Benefit Guaranty Corporation, or any other governmental agency, accordingly, the Plan is subject to the normal investment risks associated with pooled separate accounts and stable value funds. Any defaults on participant notes receivable are treated as taxable distributions to the participants.

Contributions

Contributions from participants are recorded as they are withheld from the participants' wages. Employer contributions are recorded when earned.

Participant notes receivable

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest on outstanding balances is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and December 31, 2023.

Payments of benefits

Benefit payments to participants or their beneficiaries are recorded when paid.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements. Actual results could differ from these estimates.

Subsequent events

The Plan has evaluated events and transactions for potential recognition or disclosure through September 15, 2025, which is the date the financial statements were available to be issued.

Note 3 – Investments at contract value

The Plan holds a portfolio of investment contracts comprised of fixed annuities and variable annuities. These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. The reported values for fixed annuity investment options are reported daily based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider. The prices and unit values for variable annuity investment options are calculated daily by the annuity provider according to the methods described in the annuity contract. The following represents the contract value types of investment contracts held by the Plan as of December 31, 2024 and December 31, 2023:

The Plan's investments are fixed annuities and variable annuities managed by the Trustee as defined by the Plan, and therefore, transactions pertaining to these investments qualify as party-in-interest transactions.

Trustee, advisory and other similar type fees related to the administration of the Plan were paid by the Plan or by the Organization. These transactions also qualify as party-in-interest transactions.
