Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

We have performed audits of the accompanying financial statements of First Children, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

A. DESCRIPTION OF PLAN

The following description of the First Children, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed, defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan is sponsored by First Children, LLC (the "Plan Sponsor"). Ascensus Trust Company (the "Trustee") is the trustee of the Plan. Ascensus, LLC (the "Trustee's Agent") is an authorized representation of the Trustee.

The Plan was restated effective October 15, 2021.

Eligibility and Membership

The Plan provides retirement benefits to the employees of the Plan Sponsor, Mountain Eagle Group, LLC, First Children Learning Services, LLC, and Regional Enrichment Learning Center, LLC (collectively the "Employer"). An employee of the Employer becomes eligible to participate in the Plan after completing three consecutive months of service. The Plan excludes independent contractors and other individuals not considered to be an actual employee from participating. An employee meeting the aforementioned eligibility requirements will be eligible to contribute to the Plan, receive employer matching contributions, and receive an allocation of any employer profit sharing contributions.

Contributions

A participant in the Plan may annually contribute pre-tax elective deferrals and/or Roth elective deferrals, through payroll deductions, not in excess of amounts as determined by the Internal Revenue Service ("IRS"), and may contribute amounts representing distributions from other qualified plans. Any participant, age 50 or over, may make an additional "catch-up" contribution as determined by the IRS. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Employer may make a discretionary matching contribution or profit sharing contribution to the Plan. These amounts are determined by the Employer, in its sole discretion, from year to year. For the year ended December 31, 2024, the Employer did not make any matching contribution or profit sharing contribution to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Employer's matching and profit sharing contributions, and (b) Plan earnings (losses) and is charged with an allocation of investment expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTES TO FINANCIAL STATEMENTS

A. DESCRIPTION OF PLAN (CONTINUED)

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Employer's contribution portion of their accounts is based on years of service. Years of service is measured over twelve consecutive months based on the Plan year. A participant is one-hundred percent vested after four years of credited service, based upon the following schedule:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum of \$50,000 or fifty percent of their vested account balance, whichever is less. The notes receivable are secured by the account balance in the participant's account. Each note receivable will bear a rate of interest based on the prime rate on the date that the loan originated. Principal and interest is paid ratably through bi-weekly payroll deductions. Loans must be repaid over a period not extending beyond five years from the date of the loan. Loans used to purchase a principal residence for the participant must be repaid over a period not extending beyond ten years from the date of the loan. There were no notes receivable from participants as of December 31, 2024. The interest rate on notes receivable for the participant was 8.5% as of December 31, 2023.

Payment of Benefits

Except in the case of hardship, death, disability or termination of employment, as defined in the Plan, withdrawals are not permitted from a participant's account prior to either termination of employment or the reaching of age 59½. Hardship withdrawals must be submitted to the Plan Administrator in writing and make the participant ineligible to contribute to the Plan for twelve months.

At a participant's normal retirement (age 65), disability date or upon death, the participant's entire account balance is available for distribution. Such distributions are made in the form of annuities unless otherwise elected by the participant. In the event of termination of employment, a participant, with an account balance of \$1,000 or less, will receive, as a lump sum distribution, their participant contributions, vested Employer contributions, if any, and earnings thereon. A participant with an account balance of more than \$1,000 can elect to have their vested balance distributed upon termination as a lump sum or a partial distribution.

Plan Expenses

The Plan's administrative expenses are paid either by the Employer, through the use of forfeitures, or allocated to each participant at the Employer's option.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and changes therein. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value and are certified by the Trustee's Agent. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by the Trustee. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Forfeitures

Forfeitures may be used to pay Plan administrative expenses or reduce future employer contributions to the Plan. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$7,965 and \$1,938, respectively. During the year ended December 31, 2024, no forfeitures were applied to Plan administrative expenses or used to reduce employer contributions.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Subsequent Events

Management has evaluated subsequent events for potential recognition and disclosure through October 6, 2025, the date the financial statements were available to be issued. No items were determined by management to require disclosure.

C. INFORMATION CERTIFIED BY THE TRUSTEE'S AGENT

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus, LLC, an authorized representative of Ascensus Trust Company, a qualified institution, has certified that the following investment information in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Total investment return and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

D. FAIR VALUE MEASUREMENTS

Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures to Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in less active markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market and Mutual Funds: Valued at the net asset value of shares held by the Plan based on quoted prices in active markets.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in Fair Value and Related Gains and Losses

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the end of the reporting period.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits.

E. PLAN TERMINATION

The Plan Sponsor may terminate, amend, modify or suspend the Plan in whole or in part at any time. No such change is currently being contemplated; however, in any such event, the participants' rights to their accrued benefits are non-forfeitable.

F. TAX STATUS

The Employer adopted a Prototype Standardized 401(k) and Profit Sharing Plan, and received a favorable opinion letter from the IRS on January 1, 2018, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRS.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

G. CONCENTRATION OF RISK

The Plan invests in various investment instruments. Investment securities are exposed to various risks, such as those involving interest rates, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

H. RELATED PARTY-IN-INTEREST TRANSACTIONS

Ascensus Trust Company is the Plan's Trustee; therefore, transactions between the Trustee and the Plan qualify as party-in-interest transactions. No direct expenses were paid to the Trustee during the year ended December 31, 2024.

During the year ended December 31, 2024, the Plan inadvertently failed to timely make deferral election changes for certain employees. Plan management intends to correct this issue during the year ending December 31, 2025.
