- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about The Most Worshipful Grand Lodge of F. and A.M. of Florida Employee Plan and Trust’s ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Supplemental Schedules Required by ERISA**

The supplemental schedules of Statements of Assets Held for Investment Purposes are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. **DESCRIPTION OF PLAN**

The following description of The Most Worshipful Grand Lodge of F. & A.M. of Florida Employee Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all eligible employees of The Most Worshipful Grand Lodge of F. & A.M. of Florida (the "Company"). Employees become eligible to participate in the Plan once they have completed one year of service consisting of at least 1,000 hours and are age 21 or older. John Hancock USA serves as Custodian to the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Each year, participants may contribute compensation, as defined in the Plan document, subject to certain Internal Revenue Code ("IRC") limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company contributes 50% of the first 6% of base compensation that a participant contributes to the Plan, up to a maximum of \$1,250. Additional profit-sharing amounts may be contributed at the option of the Company's Board of Directors. The Company contributed 3% of eligible participants' base compensation as a profit-sharing contribution for years ended December 31, 2024 and 2023. Contributions are subject to certain limitations.

**Investment Options**

Participants direct the investment of their compensation deferrals, employer match and profit-sharing portion into various investment options offered by the Plan. The Plan currently offers pooled separate accounts.

1. **DESCRIPTION OF PLAN** – (Continued)

**Participant Accounts**

Each participant's account is credited with an allocation of (a) the Company contribution, and (b) Plan earnings or account balances and charged with an allocation of administrative expenses and benefit payments. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of service. A participant is 100% vested after six years of credited service. Additionally, 100% vesting occurs upon death, disability, retirement (age 65) or termination of the Plan.

**Distributions**

On termination of service due to death, disability or retirement, a participant may elect an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or various installment and annuity options provided by the Plan. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account, as a lump-sum amount. Amounts contributed on a before-tax basis may only be withdrawn upon demonstration of financial hardship, disability, or after the participants reach the age of 59.5 years.

**Expenses and Fees**

Expenses and fees associated with the Plan are paid with Plan assets. Such expenses and fees include the compensation of third-party administrator, legal and professional, and costs related to Plan administration. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. During the years ended December 31, 2024 and 2023, expenses and fees were \$6,073 and \$2,134, respectively.

**Forfeitures**

At December 31, 2024 and 2023 there were \$54,630 and \$2,777 of forfeited non-vested accounts, respectively. During 2024 and 2023, forfeitures of \$0 were used to reduce Company contributions.

**Participant Loans**

Beginning in 2020, participants may, pursuant to the provisions in the Plan document, borrow from their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate. At December 31, 2024, outstanding loan bore an interest rate of 8.5%. Principal and interest is paid ratably through payroll deductions.

2. **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The Plan uses the accrual method of accounting. Under this method of accounting, contributions to the Plan are recognized when approved by the Company. Revenues are recognized when earned, and expenses are recognized when incurred.

**Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of asset and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

**Investment Valuation**

Investments are recorded at the fair value on the last business day of the Plan year. Quoted market prices are used to value investments. Increases and decreases in the market value of the investments are reflected in the statements of changes in net assets available for benefits.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Risks and Uncertainties**

The Plan invests primarily in mutual funds and money market funds. These investments are exposed to various risks, such as interest rate fluctuations, market changes, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of these investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

**Notes Receivable from Participants**

Notes receivable from participants (participant loans) are measured at their unpaid principal balance. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Payment of Benefits**

Benefits are recorded upon distribution.

3. **TAX STATUS**

The Internal Revenue Service has determined and informed the Plan Sponsor by a letter dated March 31, 2008, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRS. The Plan is subject to examination by the Internal Revenue Service. As of December 31, 2024, the Plan's tax years for 2021, 2022, 2023, and 2024 are subject to examination.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax provisions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of the liability (or asset) or disclosure in the financial statements.

4. **FAIR VALUE MEASUREMENTS**

Fair value as defined under generally accepted accounting principles (“GAAP”) is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value.

These tiers include:

- Level 1: Observable inputs such as quoted prices in active markets for identical assets that the Plan has the ability to access at the measurement date.
- Level 2: Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3: Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Following is a description of the valuation methodologies used for assets measured at fair values. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: Invests in mutual funds. The fair values of the underlying mutual funds are publicly quoted prices used in determining net asset value.

For the years ended December 31, 2024, and 2023, there were no significant transfers between Levels 1 and 2 and no transfers in or out of Level 3 and no changes in Fair Value of Level 3 Assets and Related Gains and Losses.

**5. PARTIES-IN-INTEREST**

Certain Plan investments are units of pooled separate accounts managed by John Hancock USA. The John Hancock transactions qualify as party-in-interest transactions and have been identified as such within the supplemental information.

Certain Plan investments are managed by John Hancock. It is the trustee/custodian for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

During the year ended December 31, 2024 and 2023, John Hancock USA, Morgan Stanley Insurance Services, Ameriprise Financial Services, LLC, Millennium Investment and Azalea Administration, received advisory fees and/or administrative fees. Fees paid for these services are included in Plan expense. These transactions also qualify as party-in-interest transactions for which there is a statutory exemption.

**6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a plan termination, participants would become 100% vested in their accounts.

**7. CERTIFIED INVESTMENTS**

The Plan Administrator has elected the methods of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at December 31, 2024 and 2023 including investment information related to the 401(k) account, that is disclosed in the accompanying financial statements and supplemental schedules, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.), the custodian of the Plan.
