Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Mesa Systems, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Mesa Systems, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of Mesa Systems, Inc. (the Company). The Plan covers all employees who have completed three months of service with the Company. Such employees are eligible to participate in the Plan, including the Company's discretionary matching and profit sharing contributions. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA) and includes a deferred compensation arrangement under Internal Revenue Code (IRC) Section 401(k), which allows eligible employees to make elective deferral contributions to the Plan as a percentage of their compensation.

Contributions

Under the terms of the Plan, employees may elect to make both pre-tax and after-tax contributions. The total of each participant's annual pre-tax and after-tax contributions are subject to applicable IRC limits. The Plan includes an automatic enrollment feature. The automatic enrollment feature is a mechanism under which an eligible employee who does not make an affirmative election to make contributions to the Plan is automatically enrolled in the Plan. Participants are automatically enrolled to make a 3% pre-tax contribution unless the employee specifically elects not to participate in the Plan.

Effective April 28, 2023, the Company elected to adjust the calculation of employer matching contributions amount from a base match of \$0.20 per dollar contributed to the Plan by an individual participant, up to 3% of a participant's salary to a base match of \$0.20 per dollar contributed to the Plan by an individual participant, up to 5% of a participant's salary.

The Company, at the discretion of Company management, may make profit sharing contributions, as defined in the plan agreement. There were no profit sharing contributions made for the years ended December 31, 2024 and 2023.

For the years ended December 31, the Company made matching contributions of \$121,667 (2024) and \$76,447 (2023), respectively.

The Plan allows for participants to rollover contributions into the Plan from another qualified plan or individual retirement account. Such rollovers are included in the accompanying statements of changes in net assets available for benefits.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions made on the participant's behalf, and an allocation of Plan earnings. Allocations are based on participant account balances as of the beginning of the plan year.

Investment Elections

Each participant may direct that salary reductions to his or her account be invested in one or more of the investment options offered by the Plan. Participants may change such allocations at any time directly with the Standard Insurance Company, the Plan's third party administrator (TPA).

Vesting

Participants are immediately vested in their elective deferral contributions plus actual earnings or losses thereon. Vesting in the Company's discretionary matching and profit sharing contributions plus earnings or losses thereon is based on years of continuous service at 20% per year beginning at the end of year one resulting in the participant becoming 100% vested at the end of year five. As defined in the plan agreement, to earn a year of service, a participant must be credited with at least 1,000 hours of service during the plan year.

A participant can also become 100% vested in the Company's discretionary contribution portion of their account plus earnings thereon if the participant dies, attains age 59½, becomes disabled, or upon termination of the Plan.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the loan fund. The maximum loan term is five years unless the loan is used for the purchase of a principal residence. Participants may only have two loans outstanding at any time. The loans are secured by the vested balance in the participant's account. The loans are secured by the balance in the participant's account and bear interest at a set interest rate established by the Plan Administrator in a nondiscriminatory manner.

Payment of Benefits

Upon termination of service, a participant will receive a lump-sum payment equal to the value of his or her account, provided the account does not have a value greater than \$1,000. Distributions greater than \$1,000 and less than \$7,000 must be directly rolled over to an IRA on behalf of the terminated participants who do not select a payout option. A participant with a vested account balance greater than \$7,000 may continue holding investments within the Plan, or elect to withdraw. Prior to separation from service, a participant may elect to receive a distribution of all or any portion of the participant's account balance attributable to their pre-tax and after-tax contributions as well as discretionary matching and profit sharing contributions made by the Company if the participant has attained the age of 59 1/2 and has completed five years of service with the Company, or the participant has incurred a disability. For participants who select a payout option, they may elect to receive a lump-sum distribution, partial payment, a monthly life income annuity to be paid in monthly installments over a period not to exceed the employee's lifetime, or the vested portion of their account may be applied toward the purchase of an annuity contract as defined by the Plan document.

Administrative Expenses

Administrative expenses shown in the Plan's statements of changes in net assets available for benefits include professional fees and other expenses paid to third-party administrators performing various services such as recordkeeping, transaction processing, and custodial services for the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Investment Valuation and Income Recognition

Mutual Funds

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note 5).

Fully Benefit-Responsive Guaranteed Fund

The fully benefit-responsive guaranteed fund (the Fund) is reported at contract value. The Fund is valued at contract value as reported to the Plan by Standard Insurance Company. Contract value represents contributions made under the Fund, plus earnings, less participant withdrawals and administrative expenses (see Note 6).

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Interest income is recorded on the accrual basis.

Payment of Benefits

Benefits are recorded when paid by the third-party administrator.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

NOTE 3 - TAX STATUS

The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements as of December 31, 2024 and 2023.

NOTE 4 - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Reliance Trust Company, the trustee of the Plan for the period from May 1, 2023 through December 31, 2024 and Charles Schwab Trust Bank, the trustee for the period from January 1, 2023 through April 30, 2023, have certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the related investment activity reflected in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

NOTE 5 - FAIR VALUE MEASUREMENTS

The Plan accounts for fair value in accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures* (ASC 820). ASC 820 defines fair value, establishes a consistent framework for measuring fair value and expands disclosure requirements for fair value measurements. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

Under ASC 820, assets and liabilities are grouped into three levels, based on the markets in which the assets and liabilities are traded and the reliability of the assumptions used to determine fair value. These levels are:

- Level 1 – Valuation is based upon quoted prices for identical instruments traded in active markets.
- Level 2 – Valuation is based upon quoted prices for similar instruments in active markets, quoted prices for identical or similar instruments in markets that are not active, and model-based valuation techniques for which all significant assumptions are observable in the market.
- Level 3 – Valuation is generated from model-based techniques that use significant assumptions not observable in the market. These unobserved assumptions reflect Plan management's own estimates of assumptions that market participants would use in pricing the asset or liability. Valuation techniques include use of option pricing models, discounted cash flow models and similar techniques.

Under ASC 820, the Plan bases fair values on the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements for assets and liabilities where there exists limited or no observable market data and, therefore, are based primarily upon Plan management's own estimates, are often calculated based on current pricing policy, the economic and competitive environment, the characteristics of the asset or liability and other such factors. Therefore, the results cannot be determined with precision and may not be realized in an actual sale or immediate settlement of the asset or liability. Additionally, there may be inherent weaknesses in any calculation technique, and changes in the underlying assumptions used, including discount rates and estimates of future cash flows, that could significantly affect the results of current or future values.

Following is a description of the valuation methodology used for assets measured at fair value:

Mutual Funds: Valued at the net asset value of shares held by the Plan at year-end.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although Plan management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 - INVESTMENT CONTRACT WITH INSURANCE COMPANY

As described in ASC 962, *Plan Accounting-Defined Contribution Pension Plans*, as updated by ASU 2015-12, fully benefit-responsive investment contracts held by a defined contribution plan are required to be reported at contract value. The Plan has a fully benefit-responsive investment group annuity contract (the Contract) with Standard Insurance Company. Standard Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Contract is included in the financial statements at contract value as reported to the Plan by Standard Insurance Company. Contract value represents contributions made under the Contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Contract's issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The Plan administrator does not believe there are any events that would limit the Plan's ability to transact at contract value with Standard Insurance Company. The Plan administrator also does not believe there are events and circumstances that would permit Standard Insurance Company to terminate the Contract and settle at an amount different from Contract value. The contract value of the Contract at December 31, was \$55,923 (2024) and \$14,925 (2023).

NOTE 7 - PLAN TERMINATION

Subsequent to year end, Plan management elected to transfer and merge participant balances to a Pooled Employer Plan (PEP) sponsored by Standard Insurance Company beginning in October 2025. Upon all assets being transferred to the PEP, the Plan will then be terminated. If the Plan is terminated prior to all participant balances being transferred to the PEP, all Participants remaining in the Plan will become 100% vested in their accounts. Any unallocated assets of the Plan then held by the trustee shall be allocated among the appropriate participant accounts. (See Note 11).

NOTE 8 - FORFEITURES

Forfeitures are determined at year-end and may be used to reduce the Company's expenses, if any, for the Plan year immediately following the plan year in which the forfeiture occurs or to pay Plan expenses. For the years ended December 31, \$14,750 (2024) and \$10,314 (2023), of forfeitures were used to pay Plan expenses. Unallocated forfeitures are not considered assets available for Plan benefits as of year-end. As of December 31, there were \$33,229 (2024) and \$14,926 (2023) in unallocated forfeitures.

NOTE 9 - RELATED PARTY TRANSACTIONS

The Plan pays for certain expenses while the Company absorbs certain administrative expenses on behalf of the Plan, such as accounting fees.

Charles Schwab Trust Bank was trustee of the Plan for the period from January 1, 2023 through April 30, 2023. As of May 1, 2023, the Reliance Trust Company assumed the role of Plan trustee from Charles Schwab Trust Bank. Standard Insurance Company is the Plan's third party administrator. During the year ended December 31, 2024, Standard Insurance Company managed certain Plan investments. Therefore, these transactions qualified as party-in-interest transactions and are denoted as such on the supplemental Schedule H, Line 4i - Schedule of Assets (Held at the End of Year).

NOTE 10 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 11 - SUBSEQUENT EVENTS

The Plan's management has evaluated subsequent events through October 3, 2025, the date at which the financial statements were available to be issued.

Subsequent to year end, Plan management elected to transfer and merge participant balances to a PEP sponsored by Standard Insurance Company beginning in October 2025. Upon all assets being transferred to the PEP, the Plan will then be terminated.
