Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Trading Technologies 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF PLAN

Trading Technologies International, Inc. (“the Company”) sponsors the Trading Technologies 401(k) Plan (the “Plan”). The following description provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

Effective January 1, 2022, the Plan was restated to reflect required regulatory changes and legislative changes for The Bipartisan Budget Act of 2018 and Final Regulations Relating to Hardship Distributions and Tax Cuts and Jobs Act.

General

The Plan is a defined contribution plan established for the benefit of the Company’s employees, except for nonresident aliens, collective bargaining employees, interns, and leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

All non-excluded employees are immediately eligible upon hire to participate in the Plan. Newly eligible participants are automatically enrolled in the plan with a deferral equal to 3% of eligible compensation unless the employee declines to participate or elects a different deferral rate.

Contributions

Each year, participants may contribute up to the 401(k) plan limit set by the IRS which was \$23,000 in 2024. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions up to \$7,500. Participants have the option of treating their contributions or any portion thereof, as post-tax Roth contributions. Participants may contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan and may modify or transfer existing balances each business day. At its sole discretion, the Company may make matching and or profit-sharing contributions to the Plan. Such contributions are invested into investment options in proportion to the participants’ investment selection for elective contributions.

For years ended December 31, 2024 and 2023, the Company matched 25% of deferrals up to a maximum of 6% of compensation, which resulted in matching contributions totaling \$479,393 and \$372,397, respectively. The Company elected not to make a profit-sharing contribution for years ended December 31, 2024 and 2023.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of the Company's matching and profit sharing contributions, and Plan earnings. Earnings are allocated based on each participant's account balance as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the company contribution portion of their accounts is based on years of continuous service and ranges from 25% vesting after two years of service to 100% vesting after five years of service.

Participants automatically become 100% vested upon normal retirement (attainment of age 65), disability, or death. Participants who terminate for any other reason are entitled to the vested amount of their accounts.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account, have a maximum repayment period of 60 months, and currently bear interest at 4.25% to 8.50%, which is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Benefits under the Plan are payable to participants or their beneficiaries upon death, retirement, disability, proven financial hardship or severance of employment. Benefits are to be paid in a lump-sum. Balances that do not exceed \$7,000 are automatically distributed upon severance of employment.

Forfeited Accounts

Forfeited non-vested accounts can be used to reduce administrative expenses of the Plan or future employer contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$102,681 and \$24,027, respectively. Forfeitures of \$0 and \$52,818 were used to reduce employer contributions or administrative expenses in 2024 or 2023, respectively.

Administrative Expenses

Trading Technologies International, Inc., at its discretion, pays certain administrative expenses of the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fully benefit-responsive investment contracts are reported at contract value because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on the trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Fees related to investment advisory fees, the administration of notes receivable from participants and distributions to participants are charged directly to the participant's account and are included in other fees.

Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, which is the date the final statements were available to be issued.

NOTE 3 – FAIR VALUE MEASURES

The Financial Accounting Standards Board established a three-tier hierarchy to measure the fair value of an asset or liability. Level 1 inputs include unadjusted quoted prices in active markets for identical assets or liabilities. Level 2 inputs include market data that are directly or indirectly observable. Level 3 inputs are unobservable and corroborated by little or no market data.

Following is a description of the valuation methodologies used for assets measured at fair value.

- Mutual funds are valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are included in Level 1.
- Common stocks and options, included in the participant-directed brokerage accounts, are valued at reported closing market prices and included in Level 1.
- Collective investment trusts and pooled separate accounts are valued using the net asset value ("NAV") as a practical expedient which represents the price at which the fund is able to initiate a transaction. NAV is determined using the fair value of the underlying investments held by the funds less their liabilities and adjusted for contractual expense factors. These investments are excluded from the fair value hierarchy. Units are valued daily.

The valuation methodologies described above may generate a fair value calculation that may not be indicative of net realizable value or future fair values. While the Plan believes the valuation methodologies used are appropriate, the use of different methodologies or assumptions in calculating fair value could result in a different fair value measurement at the reporting date.

NOTE 4 - INVESTMENTS

Participants direct the investment of their accounts, as listed on Schedule A-1. The Plan's Trustee, Delaware Charter Guarantee and Trust Company, doing business as Principal Trust Company provides a menu of investment options from which participants may select. Participants may modify or transfer existing balances each business day. The plan trustee executes all investment transactions and Schedule A-1 summarizes the fair value of investments at December 31, 2024.

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company, doing business as Principal Trust Company.

NOTE 5 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain administrative expenses were paid by the Company on behalf of the Plan for the year ended December 31, 2024. The Company does not expect reimbursement from the Plan for these expenses. Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services.

As of December 31, 2024 and 2023, Plan investments included pooled separate accounts with Principal Life Insurance Company and a mutual fund where Principal Funds Inc acted as an advisor and issuer for one of the Plan's funds. Principal Life Insurance Company and Principal Funds Inc are parties in interest with respect to the Plan.

NOTE 6 – INCOME TAX STATUS

The Internal Revenue Service ("IRS") has determined and the Plan informed by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan administrator and the Plan sponsor believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

NOTE 7 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.
