### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Adams Construction Company Employees 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### Note 1 – Plan Description

---

The following description of the Adams Construction Company Employees 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### *General*

The Plan is a defined contribution plan covering all non-union employees of Adams Construction Company (the “Company”) who have one year of service and meet the age 18 requirement for eligibility. Effective April 1, 2023, the Plan document was amended to reduce the eligibility requirement for employee deferrals to three months of service.

Effective February 25, 2023, the Plan document was amended to count service with all employers which have been acquired as part of a transaction under Code 410(b)(6)(C) for purposes of determining eligibility and vesting. In addition, the amendment added Branscome Inc. as a participating employer.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### *Contributions*

Each year, participants may contribute from 1% up to 75% of eligible compensation as pre-tax or Roth deferrals up to the maximum allowed by the *Internal Revenue Code (IRC)*. Participants may also contribute amounts representing distributions from other qualified plans. Participants are automatically enrolled at 3% with 1% annual automatic increases, up to 8% of compensation. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company makes a safe harbor matching contribution and may make an additional matching contribution up to 4% of the participant’s eligible compensation. Additional amounts may be contributed at the option of the Company’s Board of Directors. There was a discretionary contribution made in 2024 for \$1,500,000. Contributions are subject to certain limitations.

#### *Participant Accounts*

Each participant’s account is credited with the participant’s deferral contributions, the Company’s discretionary and safe harbor contributions, and an allocation of Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### *Vesting*

Participants are immediately vested in their deferrals and rollover contributions and the Company’s safe harbor matching contributions plus earnings thereon. Vesting in the Company’s discretionary contribution portion of their accounts plus earnings thereon is based on years of continuous service. Participants vest on a graded schedule and are 100% vested after five years of credited service.

#### *Payment of Benefits*

Upon termination of service for any reason, a participant with a vested balance in excess of \$5,000 may elect to receive either a lump-sum amount or annual installments. Vested benefits less than \$5,000 will be paid in a lump-sum amount.

Effective April 1, 2024, the automatic rollover limit was increased to \$7,000 in accordance with SECURE 2.0.

Hardship withdrawals and age 59 ½ in-service withdrawals are allowed from all sources, as defined.

### *Administrative Costs*

Plan fees and administrative expenses are paid by the Company on a discretionary basis. The majority of these fees and expenses were paid by the Plan for the year ended December 31, 2024.

### *Forfeited Accounts*

Forfeitures may be utilized to pay reasonable Plan expenses, reduce employer contributions, or may be allocated to participants in the Plan year immediately following the Plan year in which the forfeiture occurs. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2,780 and \$2,544, respectively. During 2024, \$2,955 of forfeitures were used to pay Plan expenses.

---

## **Note 2 – Significant Accounting Policies**

---

### *Basis of Accounting*

The financial statements of the Plan are prepared using the accrual method of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for these fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

### *Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### *Investment Valuation and Income Recognition*

The Plan's investments, except for fully benefit-responsive investment contracts, are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### *Benefit Payments*

Benefits are recorded when paid.

### *Subsequent Events*

Subsequent events have been evaluated through October 8, 2025, the date the financial statements were available to be issued.

---

### **Note 3 – Fair Value Measurements**

---

The Plan's investments, except for fully-benefit responsive contracts, are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

The Plan held investments in the YourPath Multi-Manager Collective Investment Trust at December 31, 2024 and 2023. The investments are composed primarily of a mix of mutual funds and other investments that correspond to specific risk profiles and investment time horizons that includes the year (target date) in which participants are expected to retire. Each portfolio also includes the Lincoln Stable Value Fund to help reduce market volatility. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

### **Note 4 – Fully Benefit-Responsive Investment Contract**

The Plan holds an investment contract with The Lincoln National Life Insurance Company. This contract, the Lincoln Stable Value Account, meets the fully benefit-responsive traditional investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments in these contracts at contract value. The following represents the total contract value of these investment contracts held by the Plan.

The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified rate of interest that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but will not fall below zero percent. The guaranteed minimum interest rate ranged from 1% to 3%.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the *Internal Revenue Code* or the failure of the trust to be tax-exempt under Section 501(a) of the *Internal Revenue Code*
- Premature termination of the contracts
- Plan termination or merger
- Changes to the Plan's prohibition on competing investment options
- Other Plan Sponsor events that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines
- A breach of material obligation under the contract
- A material misrepresentation
- A material amendment to the agreements without the consent of the issuer.

---

### Note 5 – Related Party and Party-in-Interest Transactions

---

Certain administrative functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

The Plan invests in mutual funds and investment contracts managed by Lincoln Financial Group ("Lincoln") and these transactions, therefore, qualify as party-in-interest transactions. Fees paid to the Trustee by the Plan for recordkeeping, investment management, and administrative services were \$106,441 for the year ended December 31, 2024. Lincoln provides certain administrative services to the Plan pursuant to a Service Agreement between the Plan and Lincoln. Revenue credits generally represent the return of excess revenue generated by the Plan based upon the terms of the Service Agreement. Revenue credits are deposited to the Plan's expense account and may be used to pay reasonable and necessary Plan expenses. The Plan Sponsor may make a payment to Lincoln for administrative expenses not covered by revenue credits.

The Plan uses an investment advisor, Morgan Stanley, that is a party-in-interest. Fees paid to the investment advisor were \$53,080 for the year ended December 31, 2024. Revenue credits of \$53,060 were used to pay investment advisor fees for the year ended December 31, 2024. Administrative expenses are presented net of revenue credits.

---

### Note 6 – Plan Termination

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

---

### Note 7 – Tax Status

---

Effective January 1, 2022, the Plan document was restated to a non-standardized pre-approved profit-sharing plan sponsored by Lincoln Financial Group and received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the Plan and related trust are designed in accordance with applicable sections of the *IRC*. Although the Plan has been restated, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC* and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
