Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Shumaker, Loop & Kendrick Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Opinion

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 DESCRIPTION OF PLAN

The following description of Shumaker, Loop & Kendrick Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan originally effective January 1, 1968. The Plan has been amended throughout the years to comply with tax legislation and most recently amended effective May 3, 2021. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA). The Insurance and Pension Committee is responsible for the oversight of the Plan. Fifth Third Bank is the trustee of the Plan and is the custodian of certain of the Plan's self-managed assets. Charles Schwab is also the custodian of certain of the Plan's self-managed accounts. Empower is the custodian of the remainder of the Plan's assets, primarily consisting of mutual funds.

Eligibility

Upon completion of one month of service, each employee or partner of the Partnership is eligible to participate in the compensation or earned income deferral option. Plan entry dates for elective deferrals are the first day of the month coinciding with or next following the completion of one month of employment. Plan entry dates for discretionary Partnership contributions are January 1 and July 1 coinciding with or next following completion of two Years of Service. Upon entry into the Plan, each partner or employee of the Partnership is eligible to receive an allocation of any discretionary Partnership contributions. Equity track associate attorneys and employees classified as "senior attorney" are not eligible to participate in the Plan, but participate in the Shumaker, Loop & Kendrick Associates' 401(k) Savings Plan (the Associates' Plan).

Contributions

A Partnership contribution to the Plan is made in an amount determined on a discretionary basis by the Partnership's Management Committee and is allocated by applying the rules of permitted disparity. The permitted disparity level is the Social Security taxable wage base for the year as described in Section 230 of the Social Security Act. An additional allocation is made to certain eligible partners in specified amounts multiplied by points earned under the Partnership agreement and by years of service as defined in the Plan. Contributions to the Plan are subject to certain limitations which are modified from time to time to comply with changes in Internal Revenue Service regulations.

In addition, employees who elect to defer a portion of their eligible compensation and partners who elect to defer a portion of their earned income into the Plan may do so up to the Internal Revenue Services (IRS)-imposed dollar maximum for the year. The Plan allows participants to designate any or all of their deferral contributions as pre-tax deferrals and/or Roth 401(k) after-tax deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan also provides for rollover contributions of amounts from other qualified plans, subject to certain restrictions as defined in the Plan.

Transfers of Assets from Other Plans

The Plan received transfers from the Associates' Plan of \$571,769 in 2024. These transfers were a result of prior associate attorneys becoming eligible to participate in the Plan.

Participant Accounts

Participants direct the investment of their accounts among the investment funds offered by the Plan, including two brokerage account options. Participants who have brokerage account investment accounts pay any related transaction and account fees. Participants who have elected to receive online investment services bear any fees that are charged related to these services. Participants who have life insurance accounts pay any related premiums.

Each participant's account is credited with the participant's contributions, an allocation of Partnership contributions based on eligible compensation or earned income, and an allocation of Plan earnings or losses based on the performance of the investment options selected by the participant. Participants are charged a recordkeeping fee in addition to the fees referred to above, if applicable. Participants' accounts may also be credited with an allocation of revenue sharing income not used to pay administrative expenses, based on account balances (see Note 8). Participants who initiate a loan or benefit payment are charged a fee for that transaction. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting

Participants are immediately vested in all contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The \$50,000 maximum amount is reduced by the excess of the participant's highest outstanding balance of all loans on any day during the one-year period ending on the day before the loan is made, over the outstanding balance of loans on the date the loan is made. The notes are secured by the balance in the participant's account and bear interest at the Federal Reserve Bank Prime Rate at the time of the borrowing plus 1%. Principal and interest is paid ratably through payroll deductions.

Benefit Payments

Upon termination of service due to death, disability, or normal retirement, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution, periodic or installment payments or in the form of either a joint and 50% survivor annuity or 75% qualified optional survivor annuity (married participants) or a single life annuity (unmarried participants), with the automatic form of a benefit greater than \$5,000 being a 50% joint and survivor annuity for a married participant (single life annuity for an unmarried participant) unless waived by the participant with the participant's spouse's consent if married. The Plan allows for in-service distributions if a participant reaches age 59½. The Plan allows for in-service distributions of rollover contributions at any age. The Plan also permits withdrawals of active participants' account balances, other than the Employer Pension Account and the Prior Plan Account sources, only in amounts necessary to satisfy financial hardship as defined in the Plan.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determine the Plan's valuation policies utilizing information provided by the Plan trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment Valuation and Income Recognition (Continued)

Management fees and operating expenses charged to the Plan for investments in mutual funds, money market fund and the common/collective trust are deducted from income earned on a daily basis and are not separately reflected. Consequently, such management fees and operating expenses are reflected as an addition to net depreciation or a reduction of net appreciation in fair value of investments and a reduction of common/collective trust and money market fund dividends and interest.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments, and the Plan administrator deems the note receivable to be in default based upon terms of the Plan, the note receivable is reduced and a deemed distribution of notes receivable from participants is recorded.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

The Plan's administrative expenses are paid either by the Plan or the Partnership, as provided by the Plan document. Certain administrative expenses, including an allocation of salaries related to the Plan administration and legal costs, are paid by the Partnership. Revenue sharing income received from mutual funds is used to pay the Plan's administrative expenses related to services rendered by the Plan's trustee, with any balance of such expenses being paid by the Partnership. As party-in-interest transactions, these expenses are exempt from prohibited transaction rules.

Expenses that are paid directly by the Partnership are excluded from these financial statements. Certain expenses, such as investment management fees, self-managed account and transaction fees, insurance premiums, loan fees, and distribution fees are borne by the applicable participant's account. Administrative fees are allocated to participants' accounts.

Subsequent Events

The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

Fifth Third Bank (the trustee) has supplied the Plan administrator with a certification as to the completeness and accuracy of all notes receivable from participants and investment information, except the cash surrender value of life insurance policies and related appreciation in fair value of \$43,599 in 2024, reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market Fund: Valued based on quoted prices in active markets which represent the NAV of shares held by the Plan.

Common/Collective Trust: Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserve the right the temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Cash Surrender Value of Life Insurance: The life insurance contracts are valued at cash surrender value, which represents the net amount of premiums, less partial withdrawals, plus interest, less administrative charges and any indebtedness.

Exchange Traded Funds: Investments in exchange traded funds are valued at the daily closing price as reported by the fund. Exchange traded funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV). The exchange traded funds held by the Plan are deemed to be actively traded.

Common and Preferred Stock: Valued at the closing price reported in the active market in which the individual securities are traded.

Certificate of Deposit: Valued at cost adjusted for accreted original issue discount (a noncash payment of interest, reflecting interest earned while the investment is owned) on long-term (more than one year) CDs.

Notes and Bonds: Valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings. When quoted prices are not available for identical or similar notes or bonds, the note or bond is valued under a discounted cash flows approach that maximizes observable inputs, such as current yields of similar instruments, but includes adjustments for certain risks that may not be observable, such as credit and liquidity risks or a broker quote is available.

U.S. Government Securities: Investments in the U.S. government securities are valued based on the closing prices reported in the active markets in which the individual securities are trade.

Self-Directed Brokerage Accounts: These accounts consist of mutual funds, money market funds, common and preferred stock, exchange traded funds, certificates of deposit, corporate bonds, and government securities. See above for a description of the valuation of these assets.

NOTE 5 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Partnership has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. To the extent not used to pay expenses related to the termination of the Plan, any unallocated assets of the Plan would be allocated to participant accounts and distributed in such a manner as the Partnership may determine.

NOTE 7 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter dated April 9, 2018, received from the IRS indicating that the Plan is qualified under Section 401 of the Internal Revenue Code (IRC) and is therefore not subject to tax under current income tax law. The Plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan's legal counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Fifth Third Bank, the trustee of the Plan, and Charles Schwab, the custodian of certain Plan assets. Therefore, the investment transactions with these entities qualify as party-in-interest transactions. Fees paid by the Plan for investment management, fund expenses, self-managed investment account transactions and other recordkeeping fees are borne by the applicable participants' accounts and are included in administrative and other expenses. These fees amounted to \$122,234 in 2024.

Fees for custodial services rendered by Fifth Third Bank in the amount of \$9,477 in 2024 were paid by the Plan using revenue sharing income received from mutual funds owned by the Plan. Unallocated assets resulting primarily from revenue sharing income that had not yet been used to pay Plan expenses or allocated to participants were \$3,533 and \$3,686 at December 31, 2024 and 2023, respectively.
