Their report also indicated that the form and content of the 2023 supplemental schedules, other than the information in the 2023 supplemental schedules that agreed to or is derived from the certified investment information, were presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

1. Summary of Plan Description

The following description of the REH Services 401(k) Plan, provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan consists of a profit-sharing component for certain non-highly compensated employees ("Profit-Sharing"), an active 401(k) component ("401(k)"), and a suspended money purchase component represented by the Trust assets transferred to the Plan. The Plan was established to provide retirement benefits for eligible employees of REH Services Company and affiliates (the "Company" or "Employer"). Upon election, the participants can direct their balances and future contributions to various funds available in the Plan.

Eligibility

Employees of REH Company and SOGC, Inc. are eligible to participate in both the nonelective discretionary Profit-Sharing component and the 401(k) component of the Plan upon being hired by the company (to be eligible for nonelective discretionary profit sharing contributions, employees must be employed on the last day of the Plan year). Employees of the hospitality, ranch, and resort affiliates are eligible to participate upon completion of 12 months of full-time service. Eligible employees may enter the plan at monthly entry dates.

Vesting

Employee contributions and employer safe harbor matching contributions to the Plan's 401(k) component vest immediately. Employer nonelective discretionary contributions (i.e. profit sharing contributions) do not vest until three years or more of service, at which time these contributions are 100% vested.

Contributions

The Plan is a defined contribution plan. Employee contributions to the Plan's 401(k) component are at the election of eligible employees. Employees of the Company may contribute up to 80% of their pretax annual compensation subject to certain limitations. The Plan also allows participants to designate contributions as Roth contributions. Employees' contributions for the year ended December 31, 2024 were limited to \$23,000 per employee under Internal Revenue Code (IRC) Section 402(g). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, which were limited to \$7,500 for the year ended December 31, 2024. Participants may contribute amounts representing distributions from other qualified plans (rollover). The Employer contributes a safe harbor matching percentage up to a maximum of 6% for the year ended December 31, 2024.

For the profit-sharing contribution, the Plan allowed the Employer to make a discretionary contribution to the Plan out of current or accumulated profits. For the year ended December 31, 2024 the Employer contributed an amount equal to 4% of each participant's eligible compensation. The maximum annual addition to a participant's account could not exceed the lesser of \$69,000 (\$76,500 including catch up contributions) or 100% of a participant's compensation for the year ended December 31, 2024. The total profit-sharing contribution for the year ended December 31, 2024 was \$151,475.

Termination and Payment of Benefits

Upon termination of employment due to retirement at or after age 62, disability or death, the participant will become fully vested. Upon such event, the full value of the participant's account will be distributed to the participant in a lump sum payment or in periodic installments, or in the case of death, to the participant's beneficiaries. If the participant terminates from the Company for any reason other than retirement, death or disability, the vested portion will be payable to the participant.

Upon termination of employment, an individual may choose to keep the vested value of his or her account invested in the Plan if the vested value is greater than or equal to \$1,000. A terminated participant with a balance of less than \$1,000 may be automatically paid out by the Plan upon termination. Distributions may be made at the participant's election prior to termination upon attainment of age 59 ½ or hardship as defined in the Plan document. When the individual reaches age 70½, the Plan must commence making periodic distributions to the individual based on Internal Revenue Code (IRC) requirements.

Investment Options

Upon enrollment to the Plan, a participant may direct deferrals and employer contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company safe harbor matching contributions, as well as allocations of the Company discretionary contributions and Plan earnings. Allocations are based on participant's compensation, account balances or specific participant transactions, as defined by the Plan document. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market

participants at the measurement date. The Administrative Committee determines the Plan's valuation policies. See Note 5 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year

Fees and Administrative Expenses

The fees of the Trustee and the fees of the money managers are charged against the income of the Plan. The majority of administration costs required to maintain the Plan are paid by employees.

Forfeited Accounts

Upon termination of a participant's employment, the non-vested portion of a participant's account shall be forfeited. Any forfeitures occurring during a Plan year may be used to reduce employer contributions. At December 31, 2024 and 2023 the balance of net assets included in forfeited nonvested accounts was \$25,105 and \$642,934, respectively. For the year ended December 31, 2024, employer contributions were reduced by \$563,556 from forfeited nonvested accounts.

Excess Contributions Payable

There were no amounts payable to participants for contributions in excess of amounts allowed by the IRS at December 31, 2024 or 2023.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Benefit Payments

Benefit payments are recorded when paid. At December 31, 2024 and 2023, there were no amounts allocated to accounts of persons who had elected to withdraw from the plan, but have not yet been paid.

Contributions

Participant contributions and the related Company safe harbor matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

3. Tax Status

Effective December 1, 2020, the Plan entered into Adoption Agreement #001 under the Fidelity Management Volume Submitter Profit Sharing Plan with CODA, which has received a favorable opinion letter dated June 30, 2020 from the Internal Revenue Service that the plan is acceptable under Section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. The Plan Administrator believes that the Plan is being operated in compliance with applicable IRC requirements. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). In the event of Plan termination, participants will become fully vested in their accounts.

5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

6. Guaranteed Investment Contract with Insurance Company

The Plan has a fully benefit-responsive investment contract with the Empower Annuity Insurance Company (Empower). The contract was originally entered into with Prudential Insurance Company (Prudential), however, Prudential was acquired by Empower in 2022 and the contract holder became Empower. Empower maintains the contributions in the general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Because the guaranteed investment contract is fully benefit-

responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by the trustee, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Company or the issuer may terminate the contract at any time by giving a termination notice which notice shall specify a termination date which is at least 15 days, or 60 days if initiated by the issuer without cause, later than the date of the termination notice.

There are no reserves against contract value of credit risk of the contract issuer or otherwise. The fair value of the investment contract at December 31, 2024 and 2023 was \$16,242,456 and \$20,099,589, respectively. The crediting interest rate is based on a formula agreed upon with the issuer (but it may not be less than 0%) and reviewed quarterly for resetting.

Certain events limit the Plan's ability to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on completing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974, as amended.

The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

7. Certification of Investment Information

The statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, the accompanying notes to the financial statements, and the supplemental schedule of assets (held at end of year) as of December 31, 2024 were prepared in part or entirely from information certified by Fidelity Management Trust Company ("Fidelity"), the trustee of the Plan, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

The information certified includes total investments at December 31, 2024 and 2023, related dividend and interest income, and net appreciation in fair value of investments for the year ended December 31, 2024.

8. Related Party Transactions

Certain Plan investments are shares of mutual funds managed by Fidelity. Fidelity is the

trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$189,767 for the year ended December 31, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

9. Delinquent Participant Contributions

During 2024 and 2023, the Company failed to remit to the Plan certain employee contributions totaling \$251,571 and \$31,458, respectively, within the period prescribed by DOL regulations. Delays in remitting contributions to the trustee were due to administrative errors, and the Company has or will make contributions to the affected participants' accounts to compensate those participants for potential lost income due to the delay.

10. Subsequent Events

Subsequent events were evaluated through October 9, 2025, the date the financial statements were available to be issued.
