## INDEPENDENT AUDITORS' REPORT

To the Trustee and Participants of Abilene Machine LLC 401(k) and Profit Sharing Plan  
Abilene, Kansas

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Abilene Machine LLC 401(k) and Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Basis for Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF THE PLAN

The following description of the Abilene Machine LLC 401(k) and Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

**General** – The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) for employees of Abilene Machine LLC, (the “Company”).

Empower Trust Company, LLC and Empower Annuity Insurance Company of America (“Empower”) serve as custodians of the Plan. Empower Retirement serves as the recordkeeper of the Plan. An employee of the Company serves as the Plan’s trustee.

**Eligibility** – An employee is eligible to participate in the Plan after one year of service and upon reaching the age of 19. Once the requirements have been met, the employee may enroll in the Plan on the first day of the calendar quarter. Union employees are not eligible for the Plan.

**Contributions** – Participants may contribute up to 85% of their annual compensation, subject to certain Internal Revenue Code (“IRC”) limitations.

The Company makes a safe-harbor matching contribution equal to 100% of each participant’s salary reduction contributions up to 5% of compensation. The Company may make a discretionary additional matching contribution. No additional matching contribution was made in 2024.

Additionally, the Company may make discretionary profit sharing contributions. In order to receive a profit sharing contribution, a participant must be employed on the last day of the Plan year, or if not employed on the last day of the Plan year, have at least 501 hours of service during the Plan year. There was no such contribution made for the year ended December 31, 2024.

**Participant Accounts** – Each participant’s account is credited with the participant’s and Company’s contributions, an allocation of the Plan’s investment earnings, and is charged with the participant’s withdrawals and distributions and an allocation of Plan expense (if applicable). The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Investment Options** – The Plan offers mutual funds as investment options for participants.

**Vesting** – Participants’ contributions, Company safe-harbor match and discretionary additional matching contributions are fully vested at all times. The employer discretionary profit sharing contribution vests in 20% increments, with 20% vested after the second year, 40% vested after the third year, and increasing in 20% increments. After 6 years of service, the employer discretionary profit sharing contribution becomes fully vested. In the event of permanent disability, death, reaching normal retirement age, or termination of the Plan, the Company discretionary profit sharing contributions will become fully vested.

**Forfeitures** – Forfeitures occur upon termination of employment by a participant who is not fully vested in the Plan. Forfeitures will be used by the Company to pay Plan expenses or reduce future employer contributions. As of December 31, 2024 and 2023, there are \$694 and \$667 in forfeitures available, respectively.

**Payment of Benefits** – Upon termination of service, a participant may elect to receive either a lump-sum amount equal to vested account balances, or installment payments over a fixed, reasonable period of time, as defined by the Plan document. If the account balance does not exceed \$5,000, a lump-sum payment is the only form of disbursement available. Upon termination of employment, account balances less than \$1,000 will be automatically distributed.

**In-Service Withdrawals** – Certain participants may make withdrawals prior to termination of employment. Hardship withdrawals are available to Plan participants, as defined by the Plan and permitted by the IRC. Hardship withdrawals are limited to the participant's account balance that is 100% vested excluding safe harbor matching contributions.

Participants who have obtained the age of 59 ½ are allowed to receive a distribution of all or any portion of their vested account balances in a single sum payment.

**Notes Receivable from Participants** – Participants are permitted to borrow against their individual account balances a minimum of \$1,000 up to a maximum of \$50,000 or 50% of the participant's vested account balance. Loans are secured by the participant's vested account balance. Interest rates on the loans are set at 1.0% over the prime rate published in the *Wall Street Journal* on the first business day of the month before the loan is originated. Loan terms are in accordance with limitations set forth by the IRS, and may not exceed five years. Loan repayments are made ratably through payroll deductions.

**Administrative Expenses** – The Plan pays the majority of the expenses from Plan assets. During 2024, the Plan paid \$43,752 for investment advisory and consulting services, recordkeeping and other professional services. The Company may pay other professional fees associated with the Plan.

**Termination of the Plan** – Although the Company has not expressed any intent to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA. In the event that the Plan should be terminated, participants' accounts would become fully vested, and all remaining Plan assets would be allocated to the participants as described in the full text of the Plan.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Contributions** – Employer and employee contributions are reported in the year services are rendered to the Company by the Plan participants.

**Investment Valuation and Income Recognition** – The Plan’s investments are stated at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for doubtful accounts is considered necessary.

**Payment of Benefits** – Benefit payments are reported in the year paid.

**Date of Management’s Review** – Subsequent events have been evaluated through October 8, 2025, which is the date the financial statements were available to be issued, and there were no material events requiring recognition or disclosure.

### 3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The asset’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds – Valued at the net asset value of shares held by the plan at year end based on published quoted prices.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 4. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### 5. INFORMATION CERTIFIED BY THE CUSTODIANS

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company and Empower Annuity Insurance Company of America, the custodians of the Plan, have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

- Investments, at fair value
- Investments, at contract value
- Notes receivable from participants and related interest income
- Net appreciation in fair value of investments
- Interest and dividend income
- Schedule of Assets (Held at End of Year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**6. EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

A Plan investment was the guaranteed investment contract managed by Empower. Empower is a custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest. The Plan has a number of service providers, and such providers are parties in interest under ERISA. Notes receivable from participants are party-in-interest transactions.

The Plan has a revenue-sharing agreement whereby certain investment managers return a portion of the investment fees to offset Participants' administrative expenses, and thereafter, to be allocated as additional earnings. For the year ended December 31, 2024, approximately \$17,400 was used to offset expenses for Plan participants.

**7. TAX STATUS**

The Company adopted the Empower Retirement, LLC Defined Contribution Pre-Approved Plan which received a favorable opinion letter from the IRS on November 14, 2022, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles requires Plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
