INDEPENDENT AUDITORS' REPORT

To the Plan Administrator

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Christian Schools, Inc. DBA Goodpasture Christian School 401(K) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Opinion

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. NOTE A - DESCRIPTION OF PLAN

The following description of the Christian Schools, Inc. DBA Goodpasture Christian School 401(K) Plan (“the Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan, originally established October 1, 1974, that provides retirement benefits for employees of Christian Schools, Inc. DBA Goodpasture Christian School (the “Plan Sponsor”). The Plan covers most employees except those that are interim, summer camp, extended care, work study employees and bus drivers (“participants”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Participants may voluntarily make qualified retirement contributions to the Plan which are deductible by the participants for federal income tax purposes under Section 401(k) of the Internal Revenue Code (“IRC”). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. On meeting the eligibility requirements, each participant is automatically enrolled in the Plan to contribute 4% of his or her compensation unless the participant makes an alternate selection or declines participation. Participants may make a minimum contribution of 1% to a maximum of 100% of their total annual compensation, as defined in the plan agreement, subject to certain IRC limits. Participants may designate all or a portion of their contributions as Roth deferral contributions at the time their deferral election is made.

The Plan Sponsor will make a matching contribution at an amount equal to 100% of the participant’s elective deferral contribution up to 5% of the participant’s compensation.

The Plan also provides that the Plan Sponsor may contribute each year a discretionary profit-sharing contribution in an amount authorized by the Plan Sponsor’s Board of Directors; however, an annual discretionary profit-sharing contribution is not required. Eligibility requirements for the discretionary profit-sharing contribution are the same as for the matching contribution. During 2024 and 2023, the Plan Sponsor did not make a discretionary profit-sharing contribution.

Plan Sponsor and participant contributions may not exceed the maximum amount allowable for federal income tax purposes.

Participant Accounts

Each participant’s account is credited or charged with the participant’s contributions, allocations Plan Sponsor contributions, investment earnings or losses, and administrative expenses. Allocations are based on participant compensation or account balances, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

NOTE A - DESCRIPTION OF PLAN (CONTINUED)

Vesting

Participants are immediately vested in their elective salary deferral contributions and the Plan Sponsor's contributions plus actual earnings or losses thereon. Vesting in the Plan Sponsor's contributions plus earnings or losses thereon is based on years of continuous service. Participants vest ratably at approximately 20% after the second year of service and each year thereafter until fully vested after 6 years of service.

Payment of Benefits

On termination of service due to death, permanent disability, or retirement, a participant with an account balance that exceeds \$5,000 may elect to receive either a lump-sum payment or annual installments over a specified period equal to his or her entire account. For termination of service due to other reasons, a participant with an account balance that exceeds \$5,000 will be entitled to receive only the vested interest in his or her account. If the vested value of a participant's account is less than \$5,000, the total vested balance is distributed as an automatic lump-sum payment in cash.

Forfeited Accounts

Forfeitures are created when participants terminate employment prior to becoming fully vested in the Plan Sponsor contribution portion of their accounts. Such forfeitures may reduce the Plan Sponsor's contributions or expenses to the Plan. \$24,597 and \$7,677 were used in 2024 and 2023, respectively, to reduce Plan Sponsor's matching contributions. During 2024, \$4,284 were used to reduce Plan expenses. Forfeited nonvested amounts available for use were \$2,381 and \$16,392 at December 31, 2024 and 2023, respectively.

Administrative expenses

Certain expenses for maintaining the Plan are paid by the Plan or the Plan Sponsor. Fees incurred for investment management services are netted within the net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than as a direct payment. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

Reclassifications

Certain reclassifications have been made to the 2023 financial statements in order for them to confirm to the 2024 presentation. These reclassifications have no effect on net assets available for benefits as previously reported.

Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the plan agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments in the money market and pooled separate accounts are stated at fair value. The investment contract is stated at contract value, which approximates fair value. Refer to Note D for additional information about fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America which requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE D – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Accounting Standards Codification (“FASB ASC”) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023.

- (i) *Money market fund:* Valued at the net asset value of shares held by the Plan at year end based on a quoted price in an active market.
- (ii) *Pooled separate accounts:* Valued at net asset value, which is based on the market value of the underlying investments held by the pooled separate accounts at year end. The net asset value is not a publicly quoted price in an active market. The accounts provide for daily redemptions by the Plan at reported net asset values per share with no advance notice required or restrictions on redemptions.
- (iii) *Investment contract:* Valued at contract value, which approximates fair value, based on the amount the Plan Sponsor would receive if they terminated the contract at the reporting date, which is book value less an early withdrawal charge, discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. The investment contract provides for daily redemptions. See Note E for additional contract provisions of the investment contract.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E – INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan is party to an investment contract with the custodian, the VOYA Fixed Account. The contract underlying this investment option is considered to be fully benefit-responsive. The custodian maintains the Plan's contributions in a general account which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by the custodian. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment without restrictions.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise. As of December 31, 2024 and 2023, the contract value of this investment was \$1,903,449 and \$2,461,536, respectively. The fair value of the contract approximated fair value. The average yield and interest rate credited to participants was approximately 1.5% and 1% for the years ended December 31, 2024 and 2023, respectively. The custodian guarantees the credit rate will never fall below the lifetime guaranteed minimum of 1%. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on an annual basis for resetting.

NOTE F - TAX STATUS

The Plan Sponsor amended and restated its plan January 1, 2021 by adopting a prototype 401(k) profit sharing plan, which received a favorable opinion letter from the Internal Revenue Service (“IRS”) on November 30, 2020, which stated that the prototype plan was designed in accordance with applicable sections of the IRC. The Plan itself has not received a determination letter from the IRS stating that the Plan is qualified under Section 401(a) of the IRC. The Plan has been amended since the opinion letter was obtained. However, the plan administrator believes that the adopted prototype plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and is therefore, qualified and exempt from taxation.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

NOTE G – RELATED PARTY TRANSACTIONS

Certain expenses for maintaining the Plan are paid by the Plan or the Plan Sponsor. Fees incurred for investment management services are netted within the net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than as a direct payment. During 2024 and 2023, respectively, administrative fees of \$30,378 and \$28,505 were paid by the Plan to parties-in-interest.
