Note A – Description of Plan

The following description of Enumerate 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of Tops Software of Florida, LLC d/b/a Enumerate (the “Company” or “Employer”). The Plan was formed and adopted on January 1, 2011 and most recently restated and amended effective January 1, 2024. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Employees who have attained age of 18 and have completed three months of service are eligible to participate in the Plan. Excluded employees who are not eligible to participate in the Plan are nonresident aliens and residents of Puerto Rico. Eligible employees may enter the Plan on the first day of the month coinciding with or next following date upon satisfaction of eligibility requirements.

Effective January 1, 2024, the Plan was amended to change the name of the Plan from Tops Software LLC 401(k) Profit Sharing Plan and Trust to Enumerate 401(k) Profit Sharing Plan and Trust. Additionally, the Plan sponsor was changed from Tops Software LLC to Tops Software of Florida, LLC d/b/a Enumerate.

Administration of the Plan

The Plan is administered by the Company. The Plan’s assets for the year were maintained and administered by John Hancock Life Insurance Company (the “Custodian”). With regard to contributions, John Hancock Life Insurance Company invests cash received, interest and dividend income as directed by the participant, and makes distributions to participants.

Contributions

The Plan has an automatic enrollment feature for all eligible participants at an automatic deferral of 1% of compensation. The deferral rate will automatically increase 1% each January after initial enrollment of the participant until the participants’ deferral rate reaches 3%. Participants may contribute from 1% up to 90% of pretax annual compensation, as defined in the Plan, subject to 2024 Internal Revenue Code (“IRC”). The maximum participant deferral for December 31, 2024 was \$23,000. A participant who has attained the age of 50 may also make catch up contributions, subject to Internal Revenue Service, (“IRS”) limitations of \$7,500 for December 31, 2024. Participants may also make Roth deferrals and contribute amounts representing distributions from other qualified plans. The Company may also make discretionary contributions to the Plan. During the year ended December 31, 2024, the Company made no discretionary matching contributions.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, if applicable. Each participant’s account shall be allocated earnings, gains, expenses, and losses with respect to the investments of the participant’s account. Allocations of Plan earnings or losses are based on each participant’s investment fund balance in proportion to the total investment fund balance.

Vesting

Participants are fully vested in their elective contributions, as well as any rollover contributions plus or minus any earnings or losses thereon. Vesting in any Employer contributions is based on years of service. A participant is fully vested in any Employer contributions plus actual earnings or losses thereon upon retirement (age 65), death, disability or after 5 years of credited service as follows:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant notes receivable. Loan terms can be up to five years unless the note is for the purchase of a primary residence, in which case the repayment schedule may be for a term in excess of five years. Principal and interest are paid by payroll deduction in substantially equal payments over the life of the loan.

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. In the event of default, the unpaid portion of the participant's loan will be treated as taxable income as of the last day of the calendar quarter following the calendar quarter in which the participant made their last payment.

Distribution of Benefits

Upon termination of service due to death, disability, retirement or termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or installments paid over various periods, as defined in the Plan agreement, less any applicable taxes. Participants with less than \$5,000 in their account are automatically distributed upon termination. Participants may request an in-service distribution upon attaining age 59 ½ or as a qualified reservist. Benefits may be received when a participant demonstrates a situation of financial hardship as defined by the IRC.

Forfeitures

Forfeited balances of non-vested accounts may be used to pay administrative expenses of the Plan. Forfeitures of matching contributions that are not used to pay Plan expenses are used to reduce future Employer contributions. For the years ended December 31, 2024 and 2023, forfeited non-vested and asset holding accounts totaled approximately \$1,000 and \$0, respectively. During the year ended December 31, 2024, the Company did not use any forfeitures to reduce Plan expenses and Employer contributions.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions to the Plan at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan terminates, the net assets will be allocated to the participants and beneficiaries based on the balance of each participant's account subject to adjustments for gains or losses incurred or accrued as of the termination date.

Note B – Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“US GAAP”).

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and the changes in net assets available for benefits and disclosure of contingent assets and liabilities during the reporting period. Actual results could differ from these estimates.

Valuation of Investments

The Plan’s investments are stated at fair value. If available, quoted market prices are used to value investments. Shares of mutual funds are valued at the net asset value (“NAV”) of shares held by the Plan at year end. The Plan’s interest in the common collective trust is valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year-end. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Fair Value Measurements

The Financial Accounting Standards Board has established a framework for measuring fair value in ASC 820, *Fair Value Measurements*. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described below:

Fair Value Measurements (continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used during the Plan years ending December 31, 2024 and 2023.

Pooled separate accounts: Valued at the net asset value (“NAV”) provided by the Custodian. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the trust, minus its liabilities, divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There were no unfunded commitments to purchase investments at December 31, 2024. Participant-directed redemptions have no restrictions and are recorded at the end of every business day.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investments measured using the NAV as a practical expedient are exempt from being presented in the fair value hierarchy.

In 2023, the Plan was in the process of transferring its assets to John Hancock Life Insurance Company. These funds were reflected as cash in transit as of December 31, 2023.

As all of the Plan's investments as of December 31, 2024 are exempt from the fair value hierarchy, the table has been excluded.

Note C – Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company, a qualified institution. As of and for the year ended December 31, 2024, the Plan Administrator instructed the auditors not to perform any auditing procedures with respect to the information certified by John Hancock Life Insurance Company, except for comparing such information to the related information included in the financial statements, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note D – Income Tax Status

The underlying standardized prototype plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the written form of the underlying prototype document is qualified under Section 401(a) of IRC, and that any employer adopting this form of the Plan will be considered to have a plan qualified under Section 401(a) of the IRC. Therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Note D – Income Tax Status (continued)

Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examinations for years prior to 2021.

Note E – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note F – Party-In-Interest Transactions

Fees paid during the year for accounting and other services rendered by parties-in-interest were based on customary and reasonable rates for such services. Certain Plan investments and the related transactions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, were in investment funds managed by the Custodian; therefore, these investments and transactions qualify as party-in-interest transactions. Notes receivable from participants are also considered to be party-in-interest transactions because they are transacted with Plan participants. Fees paid to parties-in-interest by the Plan for services amounted to approximately \$23,000 during the year ended December 31, 2024.

Note G – Reconciliation of Financial Statements to Form 5500

As of December 31, 2024 the Plan held investments in pooled separate accounts, which is how they are reported on Form 5500, Schedule D, DFE/Participating Plan Information. Plan number "000" has been used to report these investments on Schedule D because the Custodian has not filed a Form 5500 directly with the Department of Labor for these investments. As such, the Plan's interest in such investments cannot be included in Schedule H, line 1c(10). Instead, the Plan's interest in the underlying assets of the pooled separate accounts must be allocated and reported in the appropriate categories on a line-by-line basis. Therefore, these investments are reflected as mutual funds on Form 5500, Schedule H, line 1c(13) and line 1c(9), respectively, but as pooled separate accounts for financial statement purposes.
