## **Independent Auditor's Report**

To the Plan Administrator and Participants

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Endpoint Clinical, Inc. 401(k) Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). #### NOTE 1 - DESCRIPTION OF PLAN

The following description of the Endpoint Clinical, Inc. 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan that was established on March 1, 2010 by Endpoint Clinical Inc. ("the Company" or "Plan Administrator") covering all eligible employees of the Company as defined in the Plan agreement. Effective January 1, 2024, the Company's name was changed from Labcorp Endpoint Clinical, Inc. to Endpoint Clinical Inc. Certain classes of employees as defined in the Plan agreement are excluded from plan participation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

A Plan Committee ("the Committee") manages the operation and administration of the Plan, including the appropriateness of the Plan's investment offerings and investment performance. The Company has contracted with Voya Retirement Insurance and Annuity Company ("Voya") to act as custodian and record-keeper to process and maintain the records of participant data. A third-party administrator ("TPA") provides certain plan services. Certain company personnel serve as plan trustees.

The provisions of SECURE 2.0 Act of 2022 continue the themes and reforms that began with the 2019 SECURE Act. Certain provisions of both Acts have been implemented by the Plan and the Plan Administrator will continue to determine provisions which will impact the operation of the Plan. Participants should refer to plan documents for any changes made to the Plan.

**Contributions** - Each year, participants may contribute an amount of eligible pre-tax annual compensation as defined in the Plan agreement, not to exceed the maximum statutory amount. The Plan allows for ROTH deferral contributions. Participants who are age 50 or older can elect to make catch-up contributions to the Plan, not to exceed the maximum statutory amount. Participants may also contribute amounts representing distributions from other eligible qualified plans.

The Plan allows for an employer safe harbor matching contribution subject to certain eligibility requirements. For the years ended December 31, 2024 and 2023, the Company matched 100% of a participant's salary deferrals up to 4% of the participant's eligible compensation. In 2024, the Company made safe harbor matching contributions in the amount of \$1,217,749 of which \$345 was funded through excess employer contributions made to the Plan and \$120,900 was a

receivable as of December 31, 2024 and was paid in 2025. In 2023, the Company made safe harbor matching contributions in the amount of \$1,185,264 of which \$6,500 was funded through excess employer contributions made to the Plan and \$46,265 was a receivable as of December 31, 2023 and was paid in 2024.

The Plan also allows for a discretionary employer matching contribution and an employer discretionary non-elective contribution subject to certain eligibility requirements; none were made for the year ended December 31, 2024.

Effective January 1, 2024, the Plan was amended to increase the service requirement for employer discretionary non-elective contributions from three months to one year. Participants should refer to plan documents for specific changes made to the Plan.

**Participant Accounts** - Each participant's account is credited with the participant's contribution, the Company's safe harbor matching contribution, the discretionary matching contribution (if any), an allocation of the discretionary non-elective contribution (if any), plan earnings and losses, and plan expenses as applicable to the Plan. Allocations of the discretionary non-elective contribution are based on participant compensation. Allocations of plan earnings and losses are based on individual participant investment choices. All contributions/investments are participant directed. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**Vesting** - Participants are 100% vested in their accounts at all times.

**Notes Receivable from Participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with prevailing rates as determined by the Plan Administrator. Outstanding notes receivable from participants as of December 31, 2024 and 2023 carry interest rates which range from 4.25% to 9.50%. Principal and interest is paid per the terms of the note and in accordance with plan provisions. The Plan Administrator establishes the specific terms and conditions of such notes.

**Payment of Benefits** - Upon the satisfaction of certain distributable events, participants or their beneficiaries may elect to receive their account balance and are paid in accordance with plan provisions.

### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

***Basis of Accounting*** - The financial statements of the Plan are prepared on the accrual basis of accounting.

***Use of Estimates*** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition*** - Investments are reported at fair value except for fully benefit-responsive investments which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by Voya. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date (if any). Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Contributions*** - Contributions from plan participants and employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

***Notes Receivable from Participants*** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

***Excess Contributions Payable*** - Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability. As of December 31, 2024 and 2023, there were no material excess contributions payable.

***Plan Expenses*** - In 2024, some plan fees were paid by the Company and these amounts are excluded from the Plan's financial statements. Investment/fund fees, contract administrator fees, TPA fees and certain participant transaction fees are

paid through the Plan and charged to participant accounts as applicable. The Plan maintains a Recordkeeping Expense Account which is funded by excess revenue amounts (fees generated by charging applicable participants). These amounts can be used to pay reasonable plan expenses and the unused account balance can be allocated back to eligible participants.

**Payment of Benefits** - Benefits are recorded when paid.

**Subsequent Events** - The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

### **NOTE 3 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **NOTE 4 - CERTIFIED INVESTMENTS**

Certain information related to investments disclosed in the accompanying financial statements and ERISA required supplemental Schedule of Assets (Held at End of Year), including investments (notes receivable from participants is not certified) held at December 31, 2024 and 2023, interest, dividends, and net appreciation in fair value of investments (interest income on notes receivable from participants is not certified) for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya.

### **NOTE 5 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** - Inputs other than quoted prices include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Separate Accounts:** Units held in the separate accounts are valued using the equivalent of a net asset value ("NAV") for the funds. The NAV is based on the fair value of the underlying assets owned by the funds, minus liabilities, and then divided by the number of units outstanding. The NAV of the separate accounts is calculated based on a compilation of primarily observable market information. The number of units of the funds that are outstanding on the calculation date is derived from observable purchase, and redemption activity in the funds. The NAV is used as a practical expedient to estimate fair value for the funds. This practical expedient would not be used if it is determined to be probable that the funds will sell the investments for an amount different from the reported NAV. For the separate accounts there are no unfunded commitments and the units can be redeemed daily. The separate accounts are part of the Plan's Group Contract with Voya and either party may terminate the contract with at least 30 days advance written notice to the other party.

### NOTE 6 - FIXED ACCOUNT

The Voya Fixed Account is part of the Plan's Group Contract with Voya. Because the Fixed Account is considered fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Fixed Account. As of December 31, 2024 and 2023, fair value approximates contract value and there are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1.0%. Such interest rates are reviewed on an annual basis for resetting. At this time, no events are probable of occurring that might limit the ability of the Plan to transact at contract value with Voya or with participants.

### NOTE 7 - PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Plan investments are held by Voya. Any purchases and sales of these investments are performed in the open market at fair value or contract value. Plan related fees are paid to Voya and the TPA. The Plan has other service providers. All these

transactions while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

### **NOTE 8 - PLAN TERMINATION AND/OR MODIFICATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### **NOTE 9 - TAX STATUS**

The Plan adopted a non-standardized pre-approved plan which received an opinion letter dated June 30, 2020 from the IRS. The Plan has been amended since, however, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various taxing authorities and government agencies. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **NOTE 10 - NONEXEMPT TRANSACTIONS**

During 2024, certain participant contributions and loans repayments in the amount of \$116,828 were not deposited with the custodian on a timely basis, in accordance with Department of Labor's ("DOL") Rules and Regulations, resulting in lost earnings of \$591 (prohibited transaction amount) which was deposited into the Plan by the Plan Sponsor in 2025.

During 2023, certain participant contributions in the amount of \$2,500 were not deposited with the custodian on a timely basis, in accordance with DOL Rules and Regulations, resulting in lost earnings of \$413 (prohibited transaction amount) which was deposited into the Plan by the Plan Sponsor in 2024.
