***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements***

We have performed an audit of the financial statements of Perrin Employee Stock Ownership and 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

#### **Note A – Description of Plan**

The following description of the Perrin Employee Stock Ownership and 401(k) Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering employees of Perrin Souvenir Distributors Inc. (the Company). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by an administrator appointed by Perrin Souvenir Distributors Inc.'s Board of Directors.

#### **Eligibility and Contributions**

Employees become eligible to make elective deferrals into the Plan upon completion of 30 days of service. Employees who have attained age 21 and have at least 1,000 hours of service during the Plan year and are employed on the last day of the Plan year are generally eligible for the company match and Employee Stock Ownership Plan (ESOP) contributions. Employees of the Company may defer a portion of their wages into the Plan beginning on the first Plan entry date after meeting eligibility requirements. Entry dates for company matching contributions and employer ESOP contributions are the first day of the plan year and the first day of the seventh month of the plan year, following the date the employee has reached one year of service.

Each year, participants may contribute up to 100% of base compensation up to the statutory limit, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a guaranteed investment contract as investment options for participants. Investments in the ESOP portion of the Plan are not directed by the participant.

The Company may make discretionary matching contributions to the Plan on behalf of each participant that contributes to the Plan. For the years ended December 31, 2024 and 2023, contributions were equal to 100% of the first 4% of compensation that a participant contributed to the Plan.

The Company may also make a discretionary contribution to the Plan in an amount determined by the Company's Board of Directors. Contributions are allocated on a ratio of each participant's compensation to total compensation. There was no such discretionary contribution made for the years ended December 31, 2024 and 2023.

The Company also generally makes a discretionary contribution of cash or stock to the ESOP portion of the Plan, in an amount determined by the Company's Board of Directors. Contributions of stock are allocated based on qualified eligible compensation. The Company made stock contributions of \$883,294 and \$811,787 for the years ended December 31, 2024 and 2023, respectively.

#### **Note A – Description of Plan (Continued)**

##### **Plan Operations**

The Company acts as plan administrator and appoints a qualified individual to act as Trustee. The Trustee is responsible for holding the investment assets of the Plan, voting shares of Company stock, executing investment transactions, and making distributions to participants. The plan administrator interprets and communicates the provisions of the Plan, ensures that all government and participant reporting requirements are fulfilled, and approves all distributions from the Plan to participants.

##### **Participant Accounts**

Individual accounts are maintained for each participant, with benefits limited to the amount contributed by the participant and an allocation of (a) the Company's matching contribution, (b) the Company's discretionary contribution, (c) the Company's ESOP contribution, and (d) investment earnings. Allocations to participant accounts are based on compensation or account balances, as specified by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Put Option**

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock on its last valuation date. The Company can generally pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

##### **Vesting and Forfeitures**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in company matching and discretionary contributions and ESOP contributions is based on years of continuous service, as follows:

##### **Vesting and Forfeitures (Continued)**

A participant also becomes fully vested at the time of the participant's death, if the participant becomes disabled while employed, or upon attainment of normal retirement age. Forfeitures of nonvested 401(k) account balances will be used to reduce future employer contributions or pay certain administrative expenses. During the years ended December 31, 2024 and 2023, the Company applied forfeitures of \$44,198 and \$41,619, respectively, to administrative expenses. During the year ended December 31, 2024, the Company used forfeitures of \$6,096 to reduce the company matching contribution. The balance in the 401(k) forfeiture account at December 31, 2024 and 2023, was \$371 and \$20,899, respectively.

Forfeitures of nonvested ESOP account balances will be first used to restore any forfeited amounts that are required to be restored, and then will be used to pay certain administrative expenses or allocated as an additional Company contribution to eligible participants. ESOP forfeitures of \$27,379 and \$103,534 were reallocated for the years ended December 31, 2024 and 2023, respectively. Forfeitures of \$53,686 and \$55,407 remained in terminated participants' accounts to be allocated at a future date as of December 31, 2024 and 2023, respectively.

##### **Diversification**

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares that have been allocated to their ESOP account. In the sixth year, the percentage changes to 50%.

##### **Payment of Benefits**

On termination of service, a participant may elect to receive a distribution in the form of a lump-sum or direct transfer to another eligible retirement plan. Distributions will be paid in cash, Employer stock, or a combination of both. If the participant receives Employer stock, it must be sold back to the Company at a price determined by the last valuation date. The participant is paid either in a lump sum payment in cash or by a promissory note payable over a period of not more than five years, bearing a reasonable rate of interest.

##### **Voting Rights**

All shares of employer stock held by the Trustee shall be voted by the Trustee. However, each participant shall be entitled to direct the Trustee as to the manner in which all employer stock allocated to the participant's account shall be voted with respect to any corporate matter which involves the voting of shares for the approval or disapproval of a merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all assets of the Company, or similar transactions. Unallocated shares shall be voted by the Trustee, as directed by the administrative committee.

#### **Note B – Summary of Accounting Policies**

##### **Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

##### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

##### **Investment Valuation and Income Recognition**

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Income from interest is recorded as it is earned. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade date basis. Net appreciation or depreciation of investments is determined using the value at the beginning of the year or purchase price if acquired since that date. Management fees and operating expenses charged to the Plan for investments in mutual funds and insurance company contracts are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

##### **Guaranteed Investment Contract with Insurance Company**

Plan assets include a fully benefit-responsive investment contract with Principal Life Insurance Company (Principal Life). Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

##### **Guaranteed Investment Contract with Insurance Company (Continued)**

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The interest rate credited was 4.85% and 6.05% for the years ended December 31, 2024 and 2023, respectively. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a semi-annual basis for resetting.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

##### **Operating Expenses**

Certain administrative fees are paid by the Plan and are based on reasonable and customary rates. Certain other costs and expenses of maintaining the Plan are paid by the Company.

##### **Benefits**

Benefits are recorded when paid.

##### **Subsequent Events**

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through September 26, 2025, which is the date the financial statements were available to be issued.

##### **Reclassification**

Certain amounts in the 2023 financial statements have been reclassified to conform with 2024 presentation.

#### **Note C – Fair Value Measurements**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – inputs are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 – inputs to the valuation methodology include:

- quoted prices for similar assets and liabilities in active markets,
- quoted prices for identical or similar assets and liabilities in markets that are not active,
- other inputs that are observable or can be corroborated by observable market data,
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – inputs are generally unobservable and significant to the fair value measurement. Such inputs typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability, including certain pricing models, discounted cash flow methodologies and similar techniques that use significant unobservable inputs.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued using quoted net asset values (NAV) of the shares held by the Plan on the last business day of the plan year.

*Perrin Souvenir Distributors, Inc. common stock:* The fair value of Company common stock is valued at estimated fair value based upon an independent appraisal. This appraisal is based upon an income approach, specifically using a capitalized cash flow method.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **Note F – Party-In-Interest Transactions**

Plan investments include shares of Company common stock valued at \$14,920,011 and \$19,300,005 at December 31, 2024 and 2023 respectively. These transactions qualify as party-in-interest transactions.

As of and for the years ended December 31, 2024 and 2023, the Plan invested in Principal Guaranteed Option, which is an unallocated insurance contract issued by Principal Life Insurance Company, a party-in-interest.

Fees paid by the Plan to parties-in-interest for services rendered to the Plan were \$69,851 and \$63,590 for the years ended December 31, 2024 and 2023 respectively. Such fees were based on reasonable and customary rates.

#### **Note G – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their accounts.

#### ***Note H – Tax Status***

The Plan obtained its latest determination letter dated August 23, 2023, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since the determination letter was requested. However, the plan administrator and the Plan's tax counsel believe that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The Plan is no longer subject to income tax examinations for years prior to 2021.

#### ***Note I – Risks and Uncertainties***

The Plan holds various investment securities. Investment securities are exposed to various risks such as interest rate, market, liquidity, and credit risks. Due to the level of risk associated with certain investment securities and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participants' individual account balances.
