**Opinion**

### NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

#### NOTE 1 - DESCRIPTION OF PLAN

##### ***General***

The National Association of REALTORS® Salary Reduction Profit Sharing Plan (the “Plan”) is a defined-contribution plan administered by the National Association of REALTORS® (the “Company” or “Employer”), with recordkeeping responsibilities provided by Schwab Retirement Plan Services, Inc. (“Recordkeeper”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The following is a general description of the Plan. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

##### ***Eligibility***

Employees of the Company and its participating Institutes, Societies, and Councils (collectively, the “Employer”) are eligible to participate in the Plan as of the first administratively practicable payroll period following their date of hire if age 21. Participants are eligible for Employer matching contributions on the first day of the month on or after they have reached age 21 and completed one year of eligible service, as defined.

In May 2022, the Plan was amended for automatic enrollment of eligible new hires at 6%. Participants are eligible for Employer matching contributions on the first day of the month on or after they have reached age 21.

##### ***Contributions***

Participants may contribute up to 50% of compensation, as defined. The Employer contributes 50% of the first 6% of compensation, as defined, that a participant contributes to the Plan. The Employer match is subject to annual true-up. Participants may direct all contributions into the fund options in multiples of 1% and may revise such directions daily. Additional contributions may be made by the Employer at its discretion. No additional contributions were made by the Employer for the years ended December 31, 2024, and 2023. Contributions are subject to certain limits as described in applicable regulations and the Plan document. An eligible employee may make a rollover contribution from another qualified plan with the consent of the Plan Administrator.

##### ***Participant Accounts***

Each participant’s account is credited with the participant’s own contributions and an allocation of the Employer’s contributions, Plan earnings, and is charged with his or her withdrawals. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

##### ***Vesting and Forfeitures***

Participants are immediately fully vested in their contributions and Employer matching contributions, plus actual earnings thereon. Vesting in Employer discretionary contributions, plus actual earnings thereon, is based on years of continuous service at the rate of 20% per year, beginning after the second year of continuous service. Amounts forfeited from a participant are applied first to restoration of participant’s account, any remaining amounts are applied to any fail-safe contributions for the participant’s employer, applied to reduce the contributions required of the participant’s employer and lastly to reduce any non-elective contributions required of the participant’s employer. Forfeitures are applied in the year in which the forfeitures occurred, and any remaining unapplied forfeitures are held in a suspense account and are applied in the next succeeding plan year. Forfeitures of \$1,112 and \$242 were applied to the restoration of participants accounts in 2024 and 2023, respectively. There were no forfeited non-vested accounts for the years ended December 31, 2024 and 2023.

***Payment of Benefits***

On termination of service due to death, disability, or retirement, the normal required form of distribution is in the form of various annuity options as outlined in the Plan document unless consent is provided by participant and spouse as applicable. A participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account depending on the amount of the account balance. Participants may take in-service withdrawals for hardship purposes or upon attainment of age 59½.

***Participant Loans***

The Plan document allows loans to be made to participants. Participants may borrow an amount up to 50% of their eligible account balance, as defined, with a minimum loan amount of \$1,000 and a maximum amount of \$50,000.

Loans bear interest at a rate as determined by the Plan Administrator. The loans are secured by the vested account balance of the participant. The period of repayment is not to exceed five years except loans for the purchase of a participant's principal residence which are not to exceed 10 years. Loan processing fees are deducted from the participant's balance and are transmitted by the trustee to the Plan recordkeeper. Each participant can have a maximum of two (2) loans at the same time.

***Plan Termination***

While the Employer has not expressed any intent to terminate the Plan, it is free to do so at any time. In the event of Plan termination, participants would become 100% vested in their Employer discretionary contributions and earnings thereon.

**NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The financial statements have been prepared under the accrual method of accounting in conformity with accounting principles general accepted in the United States of America ("U.S. GAAP").

***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' vested account balances.

***Payment of Benefits***

Benefits are recorded when paid.

***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions and expenses during the reporting period. Actual results could differ from those estimates.

***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

- Level 1 - Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.
- Level 2 - Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- Level 3 - Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability. Unobservable inputs reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

*Collective trust fund:* The fair values of participation units in the collective trust fund are based upon the net asset value (“NAV”) of such fund including direct and indirect interests in fully benefit-responsive contracts, as reported in the audited financial statements of the fund. The NAV is used as a practical expedient to estimate fair value. The collective trust is a fund of funds that invests all of its assets in the Wells Fargo Stable Return Fund C, which invests in investment contracts and security backed contracts. The fund provides for daily redemptions by the Plan at the reported NAV per share, with no advance notification requirements. There are no unfunded commitments as of December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 - INCOME TAX STATUS**

The Internal Revenue Service (“IRS”) has determined and informed the Company by a letter dated June 14, 2017, that the amended Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under the Department of Labor’s regulations as any fiduciary of the Plan, any party rendering services to the Plan, the Employer, and certain others. Investment management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments. Some professional and administrative fees related to the operation of the Plan were paid by the Employer. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Notes receivable from participants also qualify as party-in-interest transactions.

**NOTE 6 - RISKS AND UNCERTAINTIES**

The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments, and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

**NOTE 7 - SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events for recognition and disclosure through October 10, 2025, which is the date the financial statements were available to be issued. The Plan management is not aware of any subsequent events which would require recognition or disclosure in the financial statements.
