Independent Auditors' Report

To the Plan Administrator of the
Hi-Tech Electric, Inc. Savings and Investment Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Hi-Tech Electric, Inc. Savings and Investment Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). - Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgement, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at year end) as of December 31, 2024 is presented for the purpose of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. Description of Plan

General

The Hi-Tech Electric, Inc. Savings and Investment Plan (Plan) is a defined contribution plan that was established to provide retirement benefits to eligible employees of Hi-Tech Electric, Inc. (Company). The Plan was established September 1, 1991 and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The following descriptions provide only general information.

During the year ended December 31, 2024, the Plan operated under SECURE Act 2.0 provisions to conform with applicable rules and regulations. The Plan has not formally amended the SECURE Act 2.0 provisions and is required to formally amend the Plan by December 31, 2026. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Contributions

Participants may contribute a percentage of their pretax annual compensation not to exceed Internal Revenue Service (IRS) limitations. In addition, any participant, with the Plan administrator's written consent, may contribute to the trust other than as a voluntary contribution, if the contribution is a rollover contribution from another qualified plan. The Company makes matching contributions equal to 40% of the employees' contribution, up to 6% of compensation.

Eligibility and Participant Accounts

Qualified employees age 21 years of age or older are eligible to become participants in the Plan after one year of employment with the Company. Separate accounts are established for each participant. Participants' accounts are credited with the participants' contributions and allocations of (a) the Company's contribution, (b) Plan earnings, (c) forfeitures of terminated participants' nonvested accounts and (d) charged with an allocation of administrative expenses.

Administrative Expenses

The Company pays substantially all administrative costs for the Plan.

Vesting

Participants vest in the Company contribution in accordance with the following table:

Benefits Paid to Participants

A participant's account balance is paid to the participant or the participant's beneficiary in a lump sum payment, periodic payments or an annuity upon the participant's retirement, death or disability. The vested portion of a participant's account can be withdrawn by the participant upon termination of employment with the Company or upon withdrawal from the Plan. In-service withdrawals of after-tax accounts and hardship withdrawals of pre-tax accounts are also available.

Notes Receivable from Participants

Under the Plan, participants may obtain loans in amounts up to 50% of their vested account balance not to exceed \$50,000. Repayment periods may not exceed five years unless used for the purchase of a residence. Loan interest rates are based on financial institution lending rates for loans of a similar nature. Principal and interest are paid ratably through automatic payroll deductions. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the loan to be a distribution, notes receivable from participants is reduced and a benefit payment is recorded.

Under the Plan, active and terminated participants may obtain loans through the MyPlanLoan (MPL) administration program in amounts up to 50% of their vested account balance not to exceed \$50,000. Repayment periods may not exceed five years unless used for the purchase of a residence. Loan interest rates are based on financial institution lending rates for loans of a similar nature. Principal and interest are paid ratably to MPL eliminating payroll deduction of loan repayments. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the loan to be a distribution, notes receivable from participants is reduced and a benefit payment is recorded.

Termination of the Plan

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, in compliance with the provisions of ERISA. In the event the Plan is terminated, the accounts of all participants would become fully vested. The Company, however, has no intentions to terminate the Plan.

Forfeitures

Forfeited non-vested amounts are used to offset administrative expenses and future Company contributions. At December 31, 2024 and 2023, there were no forfeitures available for future use. During the year ended December 31, 2024, \$9,735 of forfeitures were used to reduce Company matching contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Estimates and Assumptions

Management uses estimates and assumptions in preparing financial statements in accordance with GAAP. Those estimates and assumptions affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could vary from the estimates used in preparing the accompanying financial statements.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. The Plan presents the net change in fair value of investments, which consists of realized gains or losses, unrealized appreciation (depreciation), and any income or capital gain distributions from such investments, in the accompanying statement of changes in net assets available for benefits.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Benefits Paid to Participants

Benefits are recorded when paid.

Risks and Uncertainties

The Plan provides for various investment options in mutual funds and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

3. Fair Value Measurements

Under the Fair Value Measurements and Disclosures topic of the Codification, ASC 820, disclosures are required about how fair value is determined for assets and liabilities and a hierarchy for which these assets and liabilities must be grouped is established, based on significant levels of inputs as follows:

Following is a description of the valuation methodologies used for investments measured at fair value:

Mutual Funds

These investments are public investment vehicles valued using the net asset value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying asset owned by the fund, less its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market.

Collective Investment Trusts

The Plan holds investments in collective investment trusts valued at NAV that invest in assets, typically U.S. securities or bond funds and may include derivative instruments such as futures contracts and swap agreements. The fair values of the units of these investments are based on the fair value of the underlying investments traded in active markets. Income is calculated daily and the amount of income is dependent on contract interest rates, contract maturities, and new investments in the funds.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Tax Status of the Plan

The Plan uses a prototype plan document sponsored by Hand Benefits & Trust Company. The prototype plan sponsor has obtained an opinion letter from the IRS dated June 30, 2020, which states that the prototype plan document satisfies the applicable provisions of the Internal Revenue Code. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRS. Therefore, no provision for income tax has been included in the Plan's financial statements.

The Plan had no significant uncertain tax positions for the year ended December 31, 2024. The Plan's Annual Return/Report of Employee Benefit Plan is subject to examination by the IRS for three years from the date of filing.

7. Related Party Transactions and Party-In-Interest Transactions

Certain Plan investments are managed by Hand Benefits & Trust Company. Hand Benefits & Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing rather than by direct payment.

8. Reconciliation of Financial Statements to Form 5500
