### **Note A - Description of the Plan**

The following description of FMB Bancshares, Inc., ("Company") Retirement Savings Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General.* The Plan is a defined contribution plan sponsored and administered by FMB Bancshares, Inc. The Plan covers substantially all of the Company's full-time salaried employees who have one year of service and who are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Contributions.* The Plan, which adopted CBIZ, LLC prototype as of January 1, 2009, was restated for the Pension Protection Act as of January 1, 2016. Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan Document. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company contributes a matching percentage of 100 percent of the first 3 percent of compensation that a participant contributes to the Plan plus 50 percent of the amount of the participant's matched employee contributions that exceed 3 percent, but do not exceed 5 percent of the participant's compensation. Additional amounts may be contributed at the option of the Company's Board of Directors. Contributions are subject to certain limitations.

*Participant Accounts.* Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution and (b) Plan earnings and charged with transaction costs attributable to specific investment options. Allocations of the Company's contributions are based on participant earnings. Allocations of Plan earnings are made based on the investment options selected by each participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting.* Participants are immediately vested in their voluntary contributions, rollover contributions, and safe harbor matching Company contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

*Investment Options.* Upon enrollment in the Plan, a participant may direct employee contributions in any of the specified investment options, which may be changed on a daily basis.

**Note A - Description of the Plan, continued**

Prior to January 1, 2014, participants were allowed to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Notes fund. Loan terms range from 1-5 years or up to 15 years for the purchase of a primary residence. Loans currently outstanding are secured by the balance in the participant's account and bear interest at a rate commensurate with prevailing rates as determined by the Plan administrator. The loan interest rate is set at 1 percent above the prime rate. Principal and interest are paid ratably through payroll deductions.

*Payment of Benefits.* On termination of service, the participant may elect to receive his or her vested balance in the form of a lump-sum distribution.

*Forfeited Accounts.* As of December 31, 2024 and 2023, there were forfeited nonvested accounts in the amounts of \$81 and \$79, respectively. Forfeitures that may occur in the future will be used to reduce employer contributions.

**Note B - Summary of Significant Accounting Policies**

*Basis of Accounting.* The financial statements of the Plan are prepared using the accrual method of accounting.

*Estimates.* The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Investment Valuation and Income Recognition.* The Plan's investments are stated at fair value. Shares of registered investment companies are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes realized gains and losses on investments sold during the year and unrealized appreciation (depreciation) of investments held at the end of the year.

For fully benefit-responsive investment contracts of a defined contribution plan, contract value is the relevant measurement attributable to that portion of the net assets available for benefits, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

**Note B - Summary of Significant Accounting Policies, continued**

The investment in the group annuity contract is valued at fair value which approximates contract value. Contract value is the relevant measurement attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The contract value of the fully benefit-responsive investment contracts represents contributions plus earnings, less participant withdrawals and administrative expenses.

*Notes Receivable From Participants.* Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. . As of January 1, 2014, the Plan was amended to discontinue the provision for participant loans. Outstanding loans originating prior to this date were paid in full during the year ended December 31, 2018.

*Payment of Benefits.* Benefits are recorded when paid.

**Note C - Parties-in-interest Transactions**

Certain Plan investments are shares of mutual funds managed by Massachusetts Mutual Life Insurance Company. Massachusetts Mutual Life Insurance Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest. Fees for investment management and record keeping were absorbed by FMB Bancshares, Inc. FMB Bancshares, Inc. also remits participant withholdings and employer contributions and matches to the custodian on behalf of the participants. Notes receivable from participants also qualify as party-in-interest transactions.

The Plan auditor provides audit and consulting services to the Plan sponsor. The Plan incurred professional fees during the years ended December 31, 2024 and 2023, respectively, in the amounts of \$21,945 and \$19,945 that were paid by FMB Bancshares, Inc.

**Note D - Plan Termination**

It is the present intention of the Company to maintain the Plan throughout their corporate existence. However, the Company reserves the right to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

**Note E - Costs of Plan Administration**

Costs of Plan administration, including legal, consulting, investment management, administrative, and audit fees are absorbed by FMB Bancshares, Inc. Transaction costs associated with entering certain investment options are charged to the account of the participants electing these options.

**Note F - Tax Status**

The Plan has received a determination letter from the Internal Revenue Service dated October 29, 2008, stating that the Plan is qualified, under the Internal Revenue Code (IRC) and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended and restated since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2017.

**Note G - Information Prepared and Certified by Custodian**

The recordkeeper and custodian, of the Plan, Empower Annuity Insurance Company of America, has certified as complete and accurate information relating to investment income, schedule of investments, and statements of transactions for the years ended December 31, 2024 and 2023.

**Note H - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted observable quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ACS 820 are described follows:

**Note H - Fair Value Measurements, continued**

Level 1 -- Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 -- Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 -- Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Group annuity contract:* Valued at fair value which approximates contract value, because it is fully benefit responsive, by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables present by level, within the fair value hierarchy, the Plan investment assets at fair value, as of December 31, 2024 and 2023. As required by FASB ACS 820, investment assets are classified in their entirety based upon the lowest level of input that is significant to the fair value measurement.

In addition to quoted market prices in active markets, valuation techniques included:

Level 2 -- estimates based on the contractual terms of the underlying assets.

Level 3 -- estimates based on cost which approximates fair value.

**Note I - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note J - Investments**

During 2024 and 2023, the Plan's pooled separate account investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$164,033 and \$451,059, respectively.

**Note K - Group Annuity Contract**

At December 31, 2024 and 2023, the Plan invested in a fully benefit-responsive group annuity contract with Talcott Resolution Life Insurance Company ("Talcott"). Talcott maintains this fixed income account in a general account. The account is credited with participant contributions plus earnings and charged for participant withdrawals and administrative expenses. Talcott is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 3.00%. Such interest rates are reviewed and may be reset on a quarterly basis. The crediting interest rate was 3.00% as of December 31, 2024 and 2023.

Contract termination may occur by either party upon election and notice. Because the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain liquidation events may limit the ability of the Plan to transact at contract value with the issuer. The Plan Sponsor does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.
