Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Carlson Environmental Consultants, PC 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. 1. PLAN DESCRIPTION:

The following description of the Carlson Environmental Consultants, PC 401(K) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is sponsored by Integrity Environmental Solutions, LLC (the Employer). Effective January 1, 2025, the Plan's name was changed from Carlson Environmental Consultants, PC 401(K) Plan to Integrity Environmental Solutions, LLC 401(K).

General – The Plan is a defined contribution retirement savings plan under Section 401(k) of the Internal Revenue Code and covers all employees, except leased employees, union employees, and nonresident aliens, that have attained 18 years of age and have completed six months of service. Plan entry dates are monthly. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan administrator and Trustees are responsible for the oversight of the Plan. The investment advisor assists the Trustees in determining the appropriateness of the Plan's investment offerings and monitoring investment performance. The Plan provides several investment options, all of which are participant directed.

Contributions – Salary deferral contributions may be made by all eligible employees. Salary deferral contributions shall not exceed amounts prescribed by the Secretary of the Treasury. Contributions in excess of allowable amounts are refunded to the participant. Employer matching contributions equal a percentage as determined annually by the Employer. Additional discretionary contributions may be contributed to the Plan at the Employer's discretion. No such contributions were made during the year ended December 31, 2024.

The Company elected to make a safe harbor matching contribution to the Plan in an amount determined by the Company. For the year ended December 31, 2024, the Company contributed 100% of the participants' deferrals up to 3% of their eligible compensation and 50% of the next 2% (maximum match of 4%). Safe harbor matching contributions are determined and remitted annually. Participants are immediately 100% vested in the Company's safe harbor contribution.

The Company may also make an additional discretionary matching contribution. The additional matching contribution is not to exceed 4% of participants' eligible compensation. Participants are immediately 100% vested in the Company's additional matching contribution. The Company did not make an additional discretionary matching contribution for the year ended December 31, 2024.

The Company may also make a discretionary non-elective contribution. The Company's non-elective contribution is based on an allocation formula of participants' compensation, as set forth in the Plan Agreement. The participant will vest in the Company's non-elective contribution in accordance with the vesting schedule made in the Plan. In order to participate in the Company's non-elective contribution, a participant must have completed at least 1,000 hours of service and be employed on the last day of the Plan year. Participants are immediately 100% vested in the Company's

discretionary non-elective contribution. The Company did not make a discretionary non-elective contribution for the year ended December 31, 2024.

Participant accounts – Each participant's account is credited with the participant's contributions, the allocation of the Company's contributions, if any, and plan earnings and charged with benefits payments and allocations of plan losses and administrative expenses. Allocations are based on participant earnings or account balances as defined in the Plan. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Each participant is immediately 100 percent vested in his or her salary deferred contribution, Employer's safe harbor matching contributions, additional matching contributions, and related earnings. Vesting in the Company's discretionary non-elective contribution portion of their accounts, plus actual earnings, is based on years of continuous service. The vesting schedule adopted by the Plan is as follows:

Investment options – Participants direct the investment of their accounts into various investment options offered by the Plan.

Benefit payments – On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or various installment and annuity options as provided by the Plan. If the vested account is not more than \$5,000, the vested account will be paid to the participant in a single lump sum. Hardship distributions are permitted upon demonstration of financial hardship. All fully vested balances are available for distribution after the participant reaches the age of 59 ½.

Forfeited amounts – Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. These amounts can be used to reduce future employer contributions or pay Plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$28,364 and \$55,918, respectively. Employer contributions were reduced by \$19,374 from forfeitures during the year.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of accounting – The financial statements of the Plan have been prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investments – Investments are reported at fair value. See Note 3 for discussion of fair value measurement. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual the ex-dividend date. Net appreciation / depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions – Contributions are reported in the year services are rendered to the Company by the Plan participants.

Payment of benefits – Benefits are recorded when paid.

Administrative expenses – The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to administration of distributions are charged directly to the respective participant's account.

3. FAIR VALUE MEASUREMENTS:

The Fair Value Measurements Topic of the Financial Accounting Standards Board Accounting Standards Codification establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in active markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds: The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stocks are based on the closing price reported on the active market where the individual securities are traded.

4. INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. 5. PLAN TERMINATION:

Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their accounts.

6. INCOME TAXES:

The Plan is adopted from a Prototype Plan. An opinion letter was issued by the National Office of the Internal Revenue Service as evidence of the acceptability of the form of the Prototype Plan under Code Section 401. An employer who accepts the Prototype Plan will be considered to have a qualified plan only if the conditions of the Prototype opinion letter are satisfied.

The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more than likely would not be sustained upon examination. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax

9. CHANGE IN SERVICE PROVIDER:

Effective January 15, 2024, Ascensus Trust Company, successor trustee, holds the Plan's investment assets, provides administration and record-keeping services and executes investment transactions of the Plan. Empower Annuity Insurance Company of America and MassMutual Life Insurance Company held the Plan's investment assets, provided administration and record-keeping services and executed investment transaction from January 1, 2024 through January 14, 2024.

10. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

11. SUBSEQUENT EVENTS:

Events and transactions occurring after December 31, 2024 have been evaluated to determine proper recognition and disclosure in the financial statements. Subsequent events and transactions were evaluated through October 13, 2025, which represents the date the financial statements were available to be issued.
