Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Arbor Realty SR, Inc. 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

Basis for Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at the end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements

Note 1. Description of Plan

The following brief description of the Arbor Realty SR, Inc. 401(k) Retirement Plan (the Plan) is provided for general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all employees of Arbor Management, LLC, Arbor Realty SR, Inc., Arbor Commercial Mortgage, LLC, AMAC Manager, LLC and ArborCrowd (collectively, the Company or the Plan Administrator). The Company adopted the Plan effective January 1, 1995, and the Plan was most recently restated on January 1, 2023. Employees are eligible to participate in the Plan upon the completion of 59 days of service and attainment of age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions: Participants may contribute from 1% to the maximum allowable percentage, not to exceed the limits contained in the Internal Revenue Code (IRC), \$23,000 for 2024 of their annual compensation for the plan year as pre-tax and after-tax Roth contributions. The Plan has automatic enrollment with a 6% automatic deferral rate, effective April 1, 2012. Contribution percentages may be changed at any time. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions of up to \$7,500 in 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan provides for employer matching contributions of a fixed matching contribution of 25% of the first 6% of qualifying compensation and an additional discretionary matching contribution. In general, participants must be employed on the last day of the plan year to be eligible for the employer matching and additional discretionary matching contributions. There was an additional discretionary matching contribution in 2024 of 5% of the first 6% of qualifying compensation. Employer contributions are subject to certain limits.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers shares of 28 registered investment companies and one common collective trust fund as investment options for participants.

Participant accounts: Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in their salary reduction contributions plus actual earnings thereon. Vesting in the Company's matching contributions plus actual earnings thereon are as follows:

Forfeited accounts: At December 31, 2024 and 2023, the forfeited nonvested account balances totaled \$36,465 and \$35,517, respectively. Employer contributions for the year ended December 31, 2024, were reduced by \$101,276 of forfeited nonvested accounts.

Notes receivable from participants: The Plan permits participants to borrow against their respective account balances over a term not to exceed five years, unless the funds are used to purchase a primary residence, in which case the loan may extend up to 15 years. Borrowings are limited to the lesser of \$50,000 or 50% of the participant's account balance. Interest is charged by the Plan at a rate of 1% over the prime rate published in *The Wall Street Journal* on the first business day of the month before the loan is originated. At December 31, 2024 and 2023, notes receivable from participants bore interest at rates ranging from 4.25% to 9.50%. Loans are secured by the participants' account balances, and principal and interest are paid ratably through semimonthly payroll deductions.

Benefit payments: Benefit payments are made to participants or their beneficiaries upon death, retirement, disability or termination of employment. Benefits are payable in lump-sum or by other methods as described in the Plan. Hardship withdrawals and in-service distributions are permitted as described in the Plan agreement. As of December 31, 2024 and 2023, no amounts were payable to participants who had withdrawn from participation in the Plan.

Administrative expenses: The Company paid substantially all of the Plan's administrative expenses for the year ended December 31, 2024.

Subsequent events: The Plan has evaluated subsequent events occurring after the date of the financial statements to consider whether or not the impact of such events needs to be reflected and/or disclosed in the financial statements. Such evaluation is performed through the date the financial statements are available for issuance, which was October 8, 2025.

Note 2. Summary of Accounting Policies

The following are the significant accounting policies followed by the Plan:

Basis of accounting: The accompanying financial statements are prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles (U.S. GAAP).

Use of estimates: The preparation of financial statements in conformity with U.S. GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and assumptions.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Committee determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for discussion of fair value measurements.

Note 2. Summary of Accounting Policies (Continued)

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions: Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent notes receivable from participants are treated as distributions based upon the terms of the Plan agreement.

Payment of benefits: Benefits are recorded when paid.

Note 3. Information Certified or Provided by Empower Trust Company, LLC (Trustee)

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and income information for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedule that was prepared by, or derived from, information provided by Empower Trust Company, LLC (Empower), the trustee of the Plan and furnished to the Plan Administrator. During 2022, Great-West Trust Company, LLC changed its name to Empower Trust Company, LLC. The Plan Administrator has obtained certifications from the trustee that the information provided to the Plan Administrator by the trustee related to the following assets and income is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule related to the investment assets, notes receivable from participants and related income.

Empower, the Plan's trustee, certified to the completeness and accuracy of the investments totaling \$92,571,332 and \$77,092,527 as of December 31, 2024 and 2023, respectively, and certified to the completeness and accuracy of notes receivable from participants as of December 31, 2024 and 2023, totaling \$732,507 and \$510,924, respectively.

The Plan's trustee also certified to the completeness and accuracy of \$8,781,433 of net appreciation in fair value of investments, \$3,271,898 of interest and dividends related to the aforementioned investments, and \$48,951 of interest income on notes receivable from participants for the year ended December 31, 2024.

Note 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Note 4. Fair Value Measurements (Continued)

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023:

Registered investment companies: Valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

Collective trust fund: Valued based on the NAV of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust, less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes that its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different value measurement at the reporting date.

- (a) The investment in the Putnam Stable Value Fund (Putnam), a stable value fund, is designed to provide a diversified group of investments with book value accounting methodology. Putnam seeks to achieve this objective by investing in high-quality guaranteed investment contracts and similar contracts issued by insurance companies, banks and other financial institutions. The fund also invests in security-backed investment contracts, including separate account products of insurance companies.

Note 5. Income Tax Status

The Plan has adopted a prototype plan of Empower. Empower requested that the Internal Revenue Service provide an opinion related to the acceptability of the prototype plan under Section 401 of the IRC and received a favorable opinion dated June 30, 2020. The Plan has been amended since the adoption date. Plan management has operated the Plan and trust in a manner that did not jeopardize this tax status.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the local, state and federal taxing authorities. The Plan Administrator has evaluated the tax positions and concluded that the Plan had taken no uncertain tax positions that required adjustments to the financial statements as of December 31, 2024 and 2023, and for the year ended December 31, 2024. Therefore, no provisions or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6. Party-in-Interest Transactions

Empower is the Plan's trustee and provides various custodial and recordkeeping services to the Plan. As such, transactions with Empower qualify as exempt party-in-interest transactions. Personnel and facilities of the Company have been used to perform administrative functions for the Plan at no charge to the Plan. Notes receivable from participants also qualify as exempt party-in-interest transactions.

Empower may receive revenue sharing payments from the mutual funds in which the Plan's assets are invested. The administrative services agreement between the Plan and Empower provides that to the extent that revenue sharing payments received by Empower exceed administrative fees charged to the Plan by Empower, the excess will be credited to the Plan's forfeiture account. During the year ended December 31, 2024, there was no amount earned by the Plan under this agreement and deposited into the Plan's forfeiture account.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
