## Independent Auditor's Report

To the Plan Administrator of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Fetter Health Care Network, Inc. 403(b) Tax-Sheltered Annuity Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) Audit). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for plan benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**Note 1 - Description of Plan**

The following description of the Fetter Health Care Network, Inc. 403(b) Tax-Sheltered Annuity Plan (“Plan”) provides only general information. Participants should refer to the Plan adoption agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established by Fetter Health Care Network, Inc. (“Company”) effective April 1, 1975 for the benefit of its employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Empower Annuity Insurance Company of America (Empower) is the Plan’s primary recordkeeper and contract administrator. Empower is responsible for the custody and management of the Plan’s assets.

Contributions

Participants may contribute to the Plan via pre-tax and Roth salary deferrals and may change their contribution percentage at their discretion. The Plan includes an automatic deferral feature whereby a participant is treated as electing to defer 3% of eligible compensation unless the participant makes an affirmative election otherwise. The automatic deferral feature provides for an annual increase until the automatic deferral percentage is capped at 6%.

The maximum annual contribution allowed in a calendar year for each participant is prescribed by federal statutes (\$23,000 in 2024 and \$22,500 in 2023). Additional catch-up contributions are permitted for participants who are age 50 or older by the end of the calendar year and with 15 years of service in which the catch-up contributions are made.

Effective July 10, 2020, the Company makes traditional discretionary matching contributions of 100% of the participant contributions up to 6% of the participant’s compensation. From January 1, 2020 through June 30, 2020, the Organization made safe harbor matching contributions of the participant’s contributions up to 6% of the participant’s compensation. From January 1, 2018 through December 31, 2019, the Organization made safe harbor matching contributions of a participant’s elective deferrals calculated as 100% of the first 1% and 50% up to 6% of a participant’s compensation.

Participant Account

Each participant’s account is credited with the participant’s contribution, allocations of the Company’s contributions, investment earnings, and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Upon retirement or termination, a participant is entitled to the vested balance in his/her account. A participant may elect to direct the investment allocation of his/her account and may change the allocation daily.

Vesting

Participants are immediately vested in their voluntary contributions, including rollovers, plus actual earnings thereon. A participant is fully vested in the original discretionary matching contribution after 3 years of credited service, with the 2020 amended matching contributions fully vested after 5 years. A participant is fully vested in the safe harbor matching contributions after 2 years of credited service.

Participants are 100% vested in the event of death, total and permanent disability, or on the later of the date the participant attains normal retirement age while employed by the Company.

Notes Receivable from Participants

The Plan provides that loans to active eligible participants may be made up to \$50,000 or 50% of the participant's vested account balance. The minimum amount of a loan is \$1,000. All loans are covered by demand notes and are repayable over a period not to exceed 5 years (except for loans for the purchase of a principal residence) through payroll deductions unless the participant is paying the loan in full. Interest on the loans is based on prevailing rates as determined by the plan administrator. At December 31, 2024 and 2023, the Plan had loans receivable from participants totaling \$139,024 and \$197,912, respectively.

Forfeited Nonvested Account Balances

Forfeitures of nonvested account balances may be used by the Company towards administrative expenses and future contributions to the Plan. At December 31, 2024 and 2023, forfeited nonvested accounts were \$240,537 and \$155,514. During the Plan years ended December 31, 2024 and 2023, forfeitures of \$0 and \$0 were used to offset employer contributions and Plan expenses.

Administrative Expenses

Certain expenses incurred in the administration of the Plan are paid directly by the Company.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or in installments. For termination of services due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Contributions receivable

Contributions receivable are recorded when determined contributions of the employer and employees are not received by the investment custodian until a subsequent reporting period. An allowance is provided when necessary to recognize potentially uncollectible receivables, and amounts deemed worthless are written off. No allowance for uncollectible receivables was deemed necessary at December 31, 2024 and 2023.

**Note 2 – Summary of Significant Accounting Policies**

Basis of accounting

The accompanying financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (“U.S. GAAP”) using the accrual method of accounting. U.S. GAAP is embodied in the Financial Accounting Standards Board *Accounting Standards Codification* (“FASB ASC”), which is the authoritative source of U.S. accounting and reporting standards for nongovernmental entities.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates, and such differences could be material. Significant estimates used in preparing these financial statements include those used to establish the fair values of investments.

Valuation of investments

The investments in the funds are presented at fair value. Shares of registered investment companies are valued based on quoted market prices, which represent the net asset value of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis of accounting. Dividends are recorded on the ex-dividend date. Unrealized gains and losses are recorded for changes in the fair value of mutual fund investments during the year. Realized gains and losses are recorded when investments are sold. Realized and unrealized gains and losses for each reporting period are combined and presented as net appreciation (depreciation) in fair value of investments in the accompanying statement of changes in net assets available for benefits.

Receivables and Allowance for Uncollectible Amounts:

Receivables are recorded for amounts due from various parties in conjunction with financial transactions. An allowance is provided, when necessary, to recognize potentially uncollectible receivables. There was no allowance for uncollectible amounts considered necessary by the Plan at December 31, 2024 and 2023.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

**Note 3 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participant accounts would continue to be held by the Plan’s trustee until all benefits are distributed to the participants.

**Note 4- Benefits Payable to Former Participants**

The portion of net assets which had been processed for payment to persons who requested withdrawals but had not yet been paid by the Plan was \$0 at both December 31, 2024 and 2023.

**Note 5 – Description of Information Certified by the Plan Trustee**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan’s independent auditor did not perform any auditing procedures with respect to the information certified as complete and accurate by the Plan’s trustee/custodian, except for comparing the information with the information in the accompanying financial statements and supplemental schedule “Schedule of Assets (Held at End of Year).”

**Note 6 – Fair Value Measurements**

The Plan adopted the Fair Value Measurement and Disclosure topic of the FASB ASC, which establishes a framework for measuring value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2            Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by the observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

The investments in registered investment companies are based on quoted market prices. There have been no changes in the methodologies used during the year ended December 31, 2024.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 7 – Income Tax Status**

The Plan has not obtained a determination letter from the Internal Revenue Service (the “IRS”) stating that the Plan was in compliance with the applicable requirement of the IRC. The Plan is relying on the IRS approval of the prototype plan that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated March 31, 2017, that the prototype plan agreement was designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

The Plan adheres to guidance issued by the Codification with respect to accounting for uncertainty in income taxes. This guidance clarifies the accounting for uncertainty in income taxes recognized in an enterprise’s financial statements and prescribes a comprehensive model for recognizing, measuring, presenting, and disclosing in the financial statements tax positions taken or expected to be taken on a tax return including positions that the organization is exempt from income taxes or not subject to income taxes or unrelated business income. With few exceptions, the Plan is no longer subject to income tax examinations by federal, state, or local tax authorities for years prior to the current and two most recent tax years

**Note 9 – Related Party Transactions**

Certain plan investments are shares of mutual funds managed by Empower, the record keeper, as defined by the Plan. These transactions qualify as exempt party-in-interest transactions.

**Note 10 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 11 – Subsequent Events**
