**A. DESCRIPTION OF THE PLAN**

The following brief description of Faust Distributing Company, Inc. (The Company) Employee Benefit Plan (the Plan) provides only general information. Participants should refer to their Plan agreement for a more complete description of the Plan's provisions.

1. **General.** The Plan provides health and death benefits covering substantially all employees of the Company. It is subject to the Employee Retirement Income Security Act of 1974 (ERISA)
2. **Benefits.** The Plan provides group life insurance, medical benefits, dental benefits, short-term disability, prescription drug benefits, stop loss benefits, accidental death & dismemberment benefit and long-term disability benefits covering full-time employees of the Company who have worked for the Company for at least thirty days. The Plan has Stop Loss insurance provided by Meritain Health. The policy gave reimbursement to the plan in the amount exceeding the deductible of \$100,000 per claim. The Stop Loss reimbursement for 2024 and 2023 are \$789,092 and \$348,454, respectively.

Eligibility for this benefit begins upon the first month following completion of the first 30 days of continuous employment.

3. **Contributions.** The Plan agreement provides that funding of the Plan will be achieved through contributions made by the employer described in the Trust Agreement (and by participating employees of the employer who elected to require their employees to share the cost providing benefits) to keep the Plan and the Trust on a sound basis.

**B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The following are the significant accounting policies followed by the Plan:

1. **Date of Management's Review.** Subsequent events were evaluated through October 2, 2025, which is the date the financial statements were available to be issued.
2. **Basis of Accounting.** The financial statements of the Plan are prepared under the accrual basis of accounting.

3. **Use of Estimates.** The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. The estimates included in these financial statements are those for the benefit obligations. Actual results could differ from those estimates. Estimates may change prior to December 31, 2025.
4. **Plan Benefits.** Plan benefits are recorded when they are paid.
5. **Benefit Obligations.** The Plan's Benefit Obligations are those for claims payable and claims incurred but not reported. The benefit obligations, as applicable, were reported at their present value. The benefit obligation for claims payable and claims incurred but not reported are provided by the Plan's consultant.

### **C. INCOME TAX STATUS**

The plan obtained its latest determination letter on December 21, 1992, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan has been amended since receiving the determination letter. However, the plan administrator believes that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the plan's financial statements.

Generally accepted accounting principles require management to evaluate tax positions taken and recognize a tax liability if the entity has taken an uncertain position that more likely than not would be sustained upon examination by the

Internal Revenue Service. Management has evaluated the tax positions taken by the Plan and concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods. Management believes the Plan is no longer subject to income tax examinations for years prior to 2021.

### **D. FUNDING POLICY**

The Plan is funded by employer and employee contributions. The funding policy has not changed since the previous audit report was issued.

**E. PLAN TERMINATION OF PLAN AND TRUST FUND**

Currently there are no intentions to terminate the Plan, but any employer may terminate the Trust with respect to itself by executing and delivering to the Trustee a notice of termination which specifies the date on which the Plan and Trust shall terminate. Likewise, the Trust will automatically terminate with respect to any employer upon the adjudication of that employer as bankrupt, the general assignment by the employer to or for the benefit of its creditors, or the dissolution of that employer without a successor. Upon the termination of the Trust by any employer, the Trustee shall thereupon use and apply the Trust Fund for the payment of all obligations of the Trust, which incurred on behalf of the terminating employer. Except as otherwise provided herein, remaining funds shall be used and applied by the Trustee, as directed by the Committee, to provide additional benefits of the kind and type described in Article II hereof to the members then participating hereunder or for such other similar or related purposes as shall not adversely affect the Trust's then tax exempt status under state and federal law. Notwithstanding any other provision of the Trust, should any employer terminate its participation in the Trust pursuant to this Section 14.4, because the Internal Revenue Service fails to determine that the Plan and Trust initially qualify as a voluntary employees' beneficiary association under Section 501(c)(9) of the Internal Revenue Code of 1986, as amended, all contributions of such employer (to the extent not expended hereunder) shall be returned by the Trustee to the employer which contributed the amounts to be returned as certified by the Committee from its records. The Trustee shall be entitled to rely upon such certification in returning such funds and shall not be under any liability or responsibility.

### **H. PARTY - IN - INTEREST**

Party-in-interest transactions consisted of accounting and auditing services provided by the Plan's auditors and consulting services provided by the Plan's consultant in the ordinary course of business. Transactions with all parties – in – interest are equivalent to those that prevail in arms-length transactions.

### **I. FASB ASC 965 (Formerly SOP 92-6)**

There are no retired employees who are participants of Faust Distributing Company, Inc.'s Employee Benefit Plan; therefore, FASB ASC 965 does not apply to this Plan.

### **J. COMMITMENTS**

There is a significant concentration of credit risk arising from cash deposits in excess of federally insured limits. Cash on deposit which exceeded those insured limits was \$73,699 and \$502,988 or the years ended December 31, 2024 and 2023, respectively.
