1. Description of the Plan

The following description of the Magnetar Capital LLC (the "Company") Profit Sharing and 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions. The Company is the plan sponsor.

General

The Plan is a defined-contribution plan, established January 1, 2006 and amended from time to time, for all employees except union employees, nonresident aliens with no income from a United States of America source, leased employees and independent contractors. The Plan was adopted by the management of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Effective July 1, 2019, the Plan engaged Fidelity Management Trust Company as the Trustee and Fidelity Workplace Services LLC as the Recordkeeper. The Plan Administrator of the Plan is the Company.

Contributions

After an employee, age 21 or over, completes 3 months of service, they are eligible to be a participant in the Plan on the first day of the first month following the completion of the 3-month service requirement. Each year, participants may make basic contributions of 0% to 100% of eligible pretax compensation, as defined in the Plan document, up to \$23,000 for year ended December 31, 2024. Participants age 50 or over are eligible to make catch-up contributions of 0% to 100% of eligible pretax compensation, an additional \$7,500 for year ended December 31, 2024. In addition, participants may also make special deferrals with respect to bonuses up to 100% of the bonus. Participants may also contribute amounts representing distributions from other qualified defined-benefit or defined-contribution plans (rollover contributions). Participants may designate some or all of their contributions as post-tax Roth contributions.

The Company contributes on behalf of the participant a matching contribution of \$1.00 for each \$1.00 contributed by the participant, up to a maximum contribution by the participant of either (i) 4% of the participant's eligible compensation or (ii) the applicable annual IRS limit, whichever is less. At its discretion, the Company may make an additional matching contribution for eligible participants. All contributions are made in cash and are deposited quarterly.

All contributions are subject to annual Internal Revenue Service (IRS) limits.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, and an allocation of the Plan's earnings (losses) related to their investment allocations. Any other Plan earnings (losses) are allocated to the participant based on a pro-rata allocation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in employer contributions.

Investment Options

Investment options for participant contributions consist of selected mutual funds available via the Plan. In addition, participants may elect to use participant-directed brokerage accounts which allows them to make their own investment decisions limited to permissible investments, including mutual funds and money market funds, as specified in the Plan document.

Participants may change their investment options on any business day.

Benefit Payments

In the event of retirement (as defined), death, permanent disability, or termination of employment, the balance in the participant's account will be distributed to the participant or the participant's beneficiary in a single lump-sum cash payment, or as a partial withdrawal only with respect to a required minimum distribution under Code Section 409(a)(9). Should a terminated participant's vested account balance equal less than \$1,000, the respective participant's vested account balance can be automatically distributed without participant consent. In-service withdrawals are available to participants for immediate and heavy financial need (as defined). The Plan also allows for age 59 1/2 withdrawals (as defined).

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan's provisions. Administrative expenses paid by the Plan include recordkeeping and trustee fees. Expenses relating to purchases, sales, or transfers of the Plan's investments are charged to the particular investment fund to which the expenses relate. Expenses that are paid by the Company are excluded from these financial statements.

Notes Receivable from Participants

A participant may borrow an amount up to the lesser of \$50,000 or 50% of their vested account balance. Each participant is only allowed one loan at a time, and the minimum loan is \$1,000. Such loans, which are payable over a term specified by the Plan, bear interest at 4.25% to 6.25% as of December 31, 2023 and December 31, 2024, as established in accordance with the Plan. Interest income is recorded as earned and allocated to borrower accounts. The loans are secured by the participant's account balance in the Plan.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, eligible participants are entitled to the distribution of their account balance.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 5 for further discussion of fair value measurements.

Net appreciation (depreciation) in the fair value of investments consists of gains and losses on investments bought and sold during the year as well as held during the year.

Management fees and operating expenses charged by the advisor of the registered investment funds are included in the calculation of the net asset value of each fund.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Contributions

Participant contributions are made through payroll deductions and are recorded when the contributions are withheld.

Payment of Benefits

Benefit payments are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Fees are charged against individual borrower's plan assets. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. For the year ended December 31, 2024, there were \$0 of deemed distributions due to participant loans in default. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

3. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

4. Information Certified by the Trustee

The investment assets of the Plan at December 31, 2024 and 2023 were held, and all transactions for the plan year ending December 31, 2024 and 2023 were executed, by Fidelity Management Trust Company under the terms of the trust agreement.

Certain information disclosed in the accompanying financial statements and the Schedule H, including investments held and participant notes receivable at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on participant notes receivable for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

5. Fair Value Measurements

The accounting guidance for fair value measurements and disclosures of financial instruments establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2 Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly; and

Level 3 Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

An investment's level within the fair value hierarchy is based on the lowest level of any input, individually or in the aggregate that is significant to the fair value measurement.

Mutual funds, exchange traded funds, and money market funds were valued at quoted market prices on an open exchange or net asset value as computed by the applicable fund company, which represent the fair value of shares held by the Plan at year end, and were classified as Level 1 investments. As of December 31, 2024, included within participant-directed brokerage accounts are \$1,553,409 of mutual funds (2023: 1,322,630), \$115,211 of money market funds (2023: \$440,048), and \$1,192,335 of exchange traded funds (2023: \$1,665,080). The participant-directed brokerage accounts had \$88 of non-interest bearing cash (2023: \$325).

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. There were no transfers between levels in 2024.

6. Income Tax Status

The underlying pre-approved plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the written form of the underlying pre-approved document is qualified under Section 401 of the Internal Revenue Code (the Code). Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the Code, and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Related Party Transactions

Certain Plan investments are shares of registered investment funds managed by an affiliate of the Trustee. The affiliate may receive revenue from those investment funds which they manage. Additionally, certain participants have loans outstanding to the Plan. Transactions involving these investments and notes receivable from participants qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.

8. Subsequent Events

Management has evaluated subsequent events for the Plan through September 11, 2025 the date the financial statements were available to be issued, and has concluded that there are no recognized or non-recognized subsequent events relevant for financial statement recognition or disclosure.
