## Independent Auditor's Report

To the Plan Administrator of  
Reuland Electric 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Reuland Electric 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits Reuland Electric 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.


#### **Other Matter — Supplemental Schedule Required by ERISA**

NOTE A - DESCRIPTION OF PLAN

The following description of Reuland Electric 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering a majority of all full-time employees of Reuland Electric Company (the "Sponsor") who have completed four months of service. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974 ("ERISA"). Participants are automatically enrolled immediately with a 3% deferral rate when eligible unless the participant elects to not participate.

Receivables

Receivables consist of the employer contributions and participant contributions which have been earned as of the end of the year and are required to be paid into the Plan subsequent to the year-end. These receivables have been stated at the amount the Plan expects to collect from the outstanding balance. The receivables were subsequently deposited into the Plan.

Contributions

Each year, participants may contribute up to 92 percent of pretax annual compensation subject to IRS prescribed limits. Participants may also contribute amounts representing distributions from other qualified plans.

The Sponsor make discretionary matching employer contributions based on the participant's contributions. During the year ended December 31, 2024 the employer elected to not make any discretionary matching contributions to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) plan earnings. Allocations are based on participant earnings or account balances, as defined. Forfeited balances of terminated participants' nonvested accounts are used to reduce future Company contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in participant contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants become 100% vested in the sponsor's matching contribution after three years of credited service.

Participants become immediately vested in the Company's discretionary profit sharing contribution plus actual earnings thereon.

Investment Options

Upon enrollment in the Plan, a participant may direct employee and employer discretionary contributions to selected investment options. Participants may change their investment options at any time.

Notes Receivable From Participants

Participants borrowed from their accounts. The notes receivable from participants are secured by the applicable participant's account balance and bear interest at a rate which is commensurate with local prevailing rates as determined quarterly. As of December 31, 2024 and 2023 this rate ranged from 4.25% to 8.25%. Principal and interest are paid through payroll deductions.

Administrative Costs

The Sponsor absorbs significant administrative costs of the Plan.

NOTE B - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Investment Valuation and Income Recognition

The Plan's investments consist of shares of mutual funds which are stated at fair value. Quoted market prices are used to value investments. Shares of registered investment companies are valued at the net asset value of shares held by the Plan at year end.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Payments of Benefits

Benefits are recorded when paid.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balances. Any accrued but unpaid interest is included in the employee's contribution receivable. Interest income is recorded on the accrual basis. Related fees are recorded in the notes receivable from participants and paid out of the participant's account when they are incurred.

Management estimates an allowance for uncollectible notes receivable based on the related participant account balances and historical trends. Management has estimated the allowance for uncollectible notes receivable from participants to be \$-0- as of December 31, 2024 and 2023.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures of contingent assets and liabilities at the date of the financial statements, and the reported revenue and expenses during the reporting period. Accordingly, actual results may differ from those estimates.

Forfeitures

As of both December 31, 2024 and 2023, forfeited non-vested accounts totaled \$-0-. During the year ended December 31, 2024 the Plan did not use any forfeitures to pay administrative fees or to reduce the discretionary employer contribution.

Expenses

A majority of plan expenses of maintaining the Plan are paid by the sponsor and are excluded from these financial statements. Fees related benefits paid are charged directly to the participant's account and are included in plan expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE D – PARTY-IN-INTEREST TRANSACTIONS

During the period December 31, 2024 and 2023, certain plan investments are managed by TransAmerica Trust Company, the custodian and TransAmerica Retirement Solutions third party administrator of the Plan. These transactions qualified as a party-in-interest transaction. The parties-in-interest receive revenue from investment providers for services provided.

NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

NOTE F - TAX STATUS

The Plan has adopted a prototype non-standardized 401(k) profit sharing plan agreement that was sponsored by the Plan's third-party administrator. A determination letter was received by the Plan administrator for the prototype plan and management believes the Plan was qualified as of the financial statement date. Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken any uncertain tax positions that more likely than not would not be sustained upon examination by the Internal Revenue Service ("IRS"). As of December 31, 2024 and 2023, the Plan has not recognized any uncertain tax positions. The Plan is subject to audits by taxing and compliance jurisdictions; however, there are currently no audits for tax periods in process. The Plan is no longer subject to tax examination for years prior to 2019.

NOTE G – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE H – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Codification 820-10 (FASB ASC 820-10), *Fair Value Measurements* (formerly FASB Statement No. 157), establishes a framework for measuring fair value.

That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

*Registered investment companies:* Valued at the daily closing price as reported by the fund. The funds held by the Plan are open-end funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively trade.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
