Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of AVEVA Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section:

- The amounts and disclosures in the accompanying 2024 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying 2024 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of AVEVA Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion on the 2024 financial statements.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about AVEVA Inc. 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the 2024 Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of AVEVA Inc. 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about AVEVA Inc. 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2024 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the 2024 financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

Supplemental Schedule Required by ERISA

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the plan that were certified by a qualified institution. Their report dated September 25, 2024, indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedules, other than the information in the 2023 supplemental schedules that agreed to or is derived from the certified investment information, were presented in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

1. DESCRIPTION OF THE PLAN

The following description of AVEVA Inc. 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan document and trust agreement for a more complete description of the Plan’s provisions.

General

The Plan is intended to be a qualified retirement plan under the Internal Revenue Code (“IRC”). The purpose of the Plan is to enable eligible employees of AVEVA Inc. (“Employer”) to save for retirement. The Plan has been amended as of November 1, 2024, to conform to new tax laws and regulations. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). AVEVA Software, LLC and OSISoft, LLC are participating employers of the Plan.

Plan Trustee, Recordkeeper, and Administrator

Fidelity Management Trust Company is the trustee and is responsible for trusteeing the Plan’s assets in its possession. Fidelity Investments is the recordkeeper for the Plan. The Employer is the Plan administrator and is responsible for the administration of the Plan.

Eligibility and Contributions

Employees are eligible to participate in the Plan upon attaining age 21. However, employees are not eligible to participate if they are a resident of Puerto Rico, covered by a collective bargaining agreement, a leased employee, or a nonresident alien with no income from a U.S. source. Employees will enter the Plan as participants immediately upon meeting the eligibility requirements.

Participants may elect to defer a percentage of their eligible compensation into the Plan after they satisfy the Plan’s eligibility requirements. The Plan also contains an automatic enrollment feature. Upon meeting the eligibility requirements, participants are automatically enrolled in the Plan at 6% of the participant’s eligible compensation. Participants may elect a different percentage or elect not to participate in the Plan. Total contributions in a plan year may not exceed the federal tax law limit. Participants who are projected to be age 50 or older by the end of the taxable year may make additional catch-up contributions. Participants may increase, decrease, suspend, or resume the amount they contribute to the Plan.

The Employer makes nondiscretionary matching contributions in an amount equal to 100% of a participant’s deferral contributions subject to a maximum of 6% of their eligible compensation contributed to the Plan. The Employer also makes a true-up contribution on an annual basis. As of December 31, 2024, the employer contribution receivable balance on the statements of net assets available for benefits included \$1,115,613 in true-up contributions. As of December 31, 2023, the employer contribution receivable balance on the statements of net assets available for benefits included \$209,131, net \$348,705 of forfeitures, in true-up contributions.

Participants can roll over part or all of an eligible rollover distribution they receive from an eligible retirement plan into the Plan as rollover contributions.

Vesting

Participants are always 100% vested in their contributions, employer contributions, rollovers, and actual Plan earnings thereon.

Participant Accounts

Each participant's account is credited with the participant's contributions, employer contributions, rollovers, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants direct the investment of assets in their account under the Plan in any of several investment securities. Participants can change their investment options among the various investment securities either through direct transfers from one security to another or by changing the percentage allocation of future contributions. The Plan also includes a self-directed brokerage program which allows a variety of investments with a diverse fee structure.

Notes Receivable from Participants

Loans have been preapproved by the Employer. The minimum loan is \$1,000 and the maximum amount is the lesser of one-half the participant's vested account balance or \$50,000 reduced by the highest outstanding loan balance in the participant's account the prior twelve-month period. All loans bear a reasonable rate of interest. Loans must be repaid in level payments on at least a quarterly basis over a five-year period unless it is for the purchase of a principal residence.

Participant Withdrawals

Participants are eligible for distributions of their vested account balances upon the event of death, disability, retirement, termination of employment, or retirement. Forms of payments include installment distributions and lump-sum distributions as non-rollover distributions, direct rollover distributions, or a combination non-rollover distribution and direct rollover. If the vested balance of the participant's account is less than \$1,000, the payment will be made in cash in a lump-sum distribution. If the participant's account balance is between \$1,000 and \$7,000 and the participant does not affirmatively consent to receive a distribution, the balance will be rolled into an individual retirement account or annuity established on behalf of the participant.

An active participant may apply to withdraw certain contributions to satisfy specific and heavy financial needs as hardship withdrawals. Participants who have reached age 59½ may also elect to withdraw all or a portion of their vested account balance while still employed by the Employer.

Forfeitures

If a participant terminates employment with the Employer and is less than 100% vested in their employer account, they forfeit the non-vested portion of their employer account. Forfeitures are retained in the Plan and are used to reduce future employer contributions payable under the Plan. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$10,807 and \$330,931, respectively. Also, in 2024, employer contributions were reduced by \$361,100 from forfeited nonvested accounts.

Plan Termination

The Employer has no legal or contractual obligation to make annual contributions to or to continue the Plan. The Employer reserves the right to terminate the Plan at any time. In the event the Plan should terminate, each participant affected by such termination shall have a 100% vested interest in their account. The Employer will facilitate the distribution of participant account balances in single lump-sum payments to each participant in accordance with Plan provisions.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Employer to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.

3. CERTIFIED INVESTMENT INFORMATION

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, interest, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by the Employer and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trusts – Valued at NAV of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the trust less its liability. This practical expedient is not used when it is determined to be probable that the trust will sell the investment for an amount different from the reported NAV.

Self-Directed Brokerage Accounts – Valued at the closing price reported on the active market on which the underlying individual securities are traded. Self-directed brokerage accounts allow participants to invest in mutual funds, certificates of deposit, money market accounts, common stocks, preferred stocks, U.S. government securities, corporate bonds, rights/warrants, and options, which are all registered with the Securities and Exchange Commission. These investments are required to publish their daily fair value and to transact at that price. These investments are deemed to be actively traded.

5. TAX STATUS

The non-standardized pre-approved plan adopted by the Employer received its latest opinion letter dated June 30, 2020, in which the Internal Revenue Service (“IRS”) stated that the pre-approved plan, as then designed, was in compliance with applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Employer believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

GAAP requires the Employer to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Fidelity Investments. Fidelity Investments is the recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. In addition, the Plan provides for notes receivable from participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. TRANSFERS OF ASSETS TO THE PLAN

Effective May 1, 2024, the OSIsoft, LLC Section 401(k) Plan was merged into the Plan. Assets of \$252,112,149 were transferred into the Plan in accordance with the provisions of ERISA. The Plan received additional transfers of \$174,868 related to notes receivable from participants associated with the OSIsoft LLC Section 401(k) Plan.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of AVEVA Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1. DESCRIPTION OF THE PLAN

The following description of AVEVA Inc. 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan document and trust agreement for a more complete description of the Plan’s provisions.

General

The Plan is intended to be a qualified retirement plan under the Internal Revenue Code (“IRC”). The purpose of the Plan is to enable eligible employees of AVEVA Inc. (“Employer”) to save for retirement. The Plan has been amended as of November 1, 2024, to conform to new tax laws and regulations. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). AVEVA Software, LLC and OSISoft, LLC are participating employers of the Plan.

Plan Trustee, Recordkeeper, and Administrator

Fidelity Management Trust Company is the trustee and is responsible for trusteeing the Plan’s assets in its possession. Fidelity Investments is the recordkeeper for the Plan. The Employer is the Plan administrator and is responsible for the administration of the Plan.

Eligibility and Contributions

Employees are eligible to participate in the Plan upon attaining age 21. However, employees are not eligible to participate if they are a resident of Puerto Rico, covered by a collective bargaining agreement, a leased employee, or a nonresident alien with no income from a U.S. source. Employees will enter the Plan as participants immediately upon meeting the eligibility requirements.

Participants may elect to defer a percentage of their eligible compensation into the Plan after they satisfy the Plan’s eligibility requirements. The Plan also contains an automatic enrollment feature. Upon meeting the eligibility requirements, participants are automatically enrolled in the Plan at 6% of the participant’s eligible compensation. Participants may elect a different percentage or elect not to participate in the Plan. Total contributions in a plan year may not exceed the federal tax law limit. Participants who are projected to be age 50 or older by the end of the taxable year may make additional catch-up contributions. Participants may increase, decrease, suspend, or resume the amount they contribute to the Plan.

The Employer makes nondiscretionary matching contributions in an amount equal to 100% of a participant’s deferral contributions subject to a maximum of 6% of their eligible compensation contributed to the Plan. The Employer also makes a true-up contribution on an annual basis. As of December 31, 2024, the employer contribution receivable balance on the statements of net assets available for benefits included \$1,115,613 in true-up contributions. As of December 31, 2023, the employer contribution receivable balance on the statements of net assets available for benefits included \$209,131, net \$348,705 of forfeitures, in true-up contributions.

Participants can roll over part or all of an eligible rollover distribution they receive from an eligible retirement plan into the Plan as rollover contributions.

Vesting

Participants are always 100% vested in their contributions, employer contributions, rollovers, and actual Plan earnings thereon.

Participant Accounts

Each participant's account is credited with the participant's contributions, employer contributions, rollovers, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants direct the investment of assets in their account under the Plan in any of several investment securities. Participants can change their investment options among the various investment securities either through direct transfers from one security to another or by changing the percentage allocation of future contributions. The Plan also includes a self-directed brokerage program which allows a variety of investments with a diverse fee structure.

Notes Receivable from Participants

Loans have been preapproved by the Employer. The minimum loan is \$1,000 and the maximum amount is the lesser of one-half the participant's vested account balance or \$50,000 reduced by the highest outstanding loan balance in the participant's account the prior twelve-month period. All loans bear a reasonable rate of interest. Loans must be repaid in level payments on at least a quarterly basis over a five-year period unless it is for the purchase of a principal residence.

Participant Withdrawals

Participants are eligible for distributions of their vested account balances upon the event of death, disability, retirement, termination of employment, or retirement. Forms of payments include installment distributions and lump-sum distributions as non-rollover distributions, direct rollover distributions, or a combination non-rollover distribution and direct rollover. If the vested balance of the participant's account is less than \$1,000, the payment will be made in cash in a lump-sum distribution. If the participant's account balance is between \$1,000 and \$7,000 and the participant does not affirmatively consent to receive a distribution, the balance will be rolled into an individual retirement account or annuity established on behalf of the participant.

An active participant may apply to withdraw certain contributions to satisfy specific and heavy financial needs as hardship withdrawals. Participants who have reached age 59½ may also elect to withdraw all or a portion of their vested account balance while still employed by the Employer.

Forfeitures

If a participant terminates employment with the Employer and is less than 100% vested in their employer account, they forfeit the non-vested portion of their employer account. Forfeitures are retained in the Plan and are used to reduce future employer contributions payable under the Plan. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$10,807 and \$330,931, respectively. Also, in 2024, employer contributions were reduced by \$361,100 from forfeited nonvested accounts.

Plan Termination

The Employer has no legal or contractual obligation to make annual contributions to or to continue the Plan. The Employer reserves the right to terminate the Plan at any time. In the event the Plan should terminate, each participant affected by such termination shall have a 100% vested interest in their account. The Employer will facilitate the distribution of participant account balances in single lump-sum payments to each participant in accordance with Plan provisions.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the Employer to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.

3. CERTIFIED INVESTMENT INFORMATION

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, interest, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by the Employer and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trusts – Valued at NAV of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the trust less its liability. This practical expedient is not used when it is determined to be probable that the trust will sell the investment for an amount different from the reported NAV.

Self-Directed Brokerage Accounts – Valued at the closing price reported on the active market on which the underlying individual securities are traded. Self-directed brokerage accounts allow participants to invest in mutual funds, certificates of deposit, money market accounts, common stocks, preferred stocks, U.S. government securities, corporate bonds, rights/warrants, and options, which are all registered with the Securities and Exchange Commission. These investments are required to publish their daily fair value and to transact at that price. These investments are deemed to be actively traded.

5. TAX STATUS

The non-standardized pre-approved plan adopted by the Employer received its latest opinion letter dated June 30, 2020, in which the Internal Revenue Service (“IRS”) stated that the pre-approved plan, as then designed, was in compliance with applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Employer believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

GAAP requires the Employer to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Fidelity Investments. Fidelity Investments is the recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. In addition, the Plan provides for notes receivable from participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules.

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. TRANSFERS OF ASSETS TO THE PLAN

Effective May 1, 2024, the OSIsoft, LLC Section 401(k) Plan was merged into the Plan. Assets of \$252,112,149 were transferred into the Plan in accordance with the provisions of ERISA. The Plan received additional transfers of \$174,868 related to notes receivable from participants associated with the OSIsoft LLC Section 401(k) Plan.
