Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Hodges Management Company, Inc. 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the related Statements of Changes in Net Assets Available for Benefits for the years then ended, and the related notes to the financial statements.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Hodges Management Company, Inc. 401(k) Retirement Plan (the Plan) provides only general information. The Plan Sponsor is Hodges Management Company, Inc. (the Company or Plan Sponsor). Participants should refer to the Summary Plan Description for a more complete description of the Plan’s provisions.

General

The Plan, which was established January 1, 1994, amended January 1, 2023, is a defined contribution plan covering employees of the Company who have met the eligibility requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Voya Life Insurance and Annuity Company (VOYA) is the appointed trustee and record keeper of the Plan. Prior to the January 1, 2023 amendment, employees are eligible upon completing one year of service (at least 1,000 hours of service during an eligibility computation period) and attaining the age of 21. Beginning January 1, 2023, employees are eligible upon completing six months of service (at least 500 hours of service during an eligibility computation period) and attaining the age of 21. Upon meeting participant eligibility requirements, all employees are eligible to receive employer contributions.

Contributions

Participants are not required to contribute, but they may contribute a maximum of 100 percent of their compensation on a tax-deferred basis, as defined in the Plan. Contributions are subject to certain limitations. The Company matches 10 percent of the employee’s elective deferral. In addition, the Company at its sole discretion may make a profit-sharing contribution on behalf of its eligible participants. There were no profit-sharing contributions made for the years ended December 31, 2024 and 2023. Elective deferral limits were \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively, with additional pre-tax “catch-up” contributions of up to \$7,500 for participants who had attained the age of 50 at December 31, 2024 and 2023.

Upon enrollment in the Plan, participants may designate how their contributions and those of the Company are to be apportioned among investment options. The participants may change their investment options at any time.

Participant accounts

Each participant’s account is credited with the participant’s contribution, employer contributions, and Plan earnings, and charged with Plan losses and an allocation of administrative expenses. Allocations are based on the participant’s compensation or account balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100 percent vested after five years of credited service. A participant becomes 100 percent vested upon death, disability, or retirement.

Payment of benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account, or leave the balance invested if it is greater than \$5,000. Hardship distributions and in-service distributions are allowed subject to applicable limitations. Benefits are recorded when paid.

Notes receivable from participants

Participants may borrow up to 50 percent of their vested account balance, with a minimum of \$1,000 up to a maximum of \$50,000. The loans are secured by the balance of the participant's account and bear interest at the prime rate plus 1 percent per year. Principal and interest are paid ratably through payroll deductions.

Forfeited accounts

Forfeited non-vested accounts are to be used to reduce future employer contributions for the current year. As of December 31, 2024 and 2023, total forfeited accounts totaled \$943 and \$333, respectively.

Investment expenses

Certain administrative expenses are paid by the Plan, as allowed by the Plan document. All other expenses associated with maintaining the Plan are paid by the Company.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The Plan's financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investment advisers, trustees and insurance company. See Note 4 for disclosure of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains on investments bought and sold as well as held during the year.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks, including a concentration of investment in a single entity risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses have been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

NOTE 3 – INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under (ERISA). The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified as complete and accurate by VOYA, the trustee. All investments are participant-directed.

NOTE 4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Separate accounts: Valued at the net asset value (NAV) of the custodial account that the insurance company holds. The custodial account is valued based on the value of underlying mutual funds traded in an active market and other investments it holds with adjustments made for contract expenses incurred to manage the account. Separate accounts are valued based on inputs that are derived principally from or corroborated by observable market data by correlation or other means.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – INVESTMENT CONTRACTS WITH INSURANCE COMPANY

In 2024 and 2023, the Plan entered into a guaranteed contract with VOYA. VOYA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula agreed upon with the issuer but may not be less than 1 percent. Such interest rates are reviewed on an annual basis for resetting.

Contract value is the relevant measure for guaranteed investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by VOYA, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the Plan's ability to transact at contract value with VOYA. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include: (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The group annuity contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE 6 – RELATED PARTY TRANSACTIONS

Certain plan investments are managed by VOYA. VOYA is the trustee and recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

VOYA provides certain administrative services to the Plan pursuant to a service agreement between the Company and VOYA. VOYA receives revenue from mutual fund service providers for services VOYA provides to the funds. This revenue is used to offset certain amounts owed to VOYA for administrative services to the Plan.

NOTE 6 – RELATED PARTY TRANSACTIONS (continued)

If the revenue received by VOYA from such mutual fund service providers exceeds the amount owed under the service agreement, VOYA remits the excess to the Plan's trust. Such amounts may be applied to pay plan administrative expenses or allocated to the accounts of the participants. During 2024 and 2023, there were no excess amounts. The Plan or Company may make a payment to VOYA for administrative expenses not covered by revenue sharing.

The Company-designated individual trustee of the Plan is currently a participant in the Plan and also an owner and officer within the Plan Sponsor's business. The authorized signor and financial advisor of the Plan representing the Plan Sponsor is also a current participant of the plan.

All of the party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 7 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants are 100 percent vested in all amounts credited to their accounts as stated in the Summary Plan Document.

NOTE 8 – TAX STATUS

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

The Plan evaluates all significant tax positions as required by generally accepted accounting principles in the United States of America. As of December 31, 2024, the Plan does not believe that it has taken any tax positions that would require the recording of any additional tax liability nor does it believe that there are any unrealized tax benefits that would either increase or decrease within the next twelve months. The Plan's income tax returns are subject to examination by the appropriate regulatory authorities. The Plan's federal income tax returns generally remain open for three years.

NOTE 9 – SUBSEQUENT EVENTS

Subsequent events were evaluated through October 10, 2025, the financial statement issuance date.
