Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

I have performed audits of the accompanying financial statements of **Miles Sand & Gravel Company Profit Sharing Retirement Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of **Miles Sand & Gravel Company Profit Sharing Plan's** financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of and for the year ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In my opinion, based on my audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements, referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and

certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

NOTE 1 - DESCRIPTION OF PLAN:

The following description of the Miles Sand & Gravel Company Profit Sharing Retirement Plan provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

A. General:

The Plan is a defined contribution plan covering all employees of Miles Sand & Gravel Company and Port Orchard Sand & Gravel Company (except employees covered by a collective bargaining agreement, non resident aliens, leased and reclassified employees) and are age 18 or older. To participate in 401(K) elective deferral contributions an employee must have 60 days of entry service. To receive a discretionary contribution an employee must have 1,000 hours of service. It is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2023 the Plan was amended and restated to Principals prototype 401(K) plan. Also effective January 1, 2023 the participant accounts became participant directed. Principal Trust Company currently serves as the Plan trustee.

On December 29, 2022, President Biden signed into law the Consolidated Appropriations Act of 2023, which includes the package of retirement provisions referred to as "SECURE 2.0". These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system, finding ways for them to accumulate more assets, and then ensuring they get connected with those assets when retirement comes.

Many of the provisions of the SECURE 2.0 are effective on January 1, 2023, and beyond and will require significant changes to plan administration and recordkeeping.

B. Contributions:

Each year participants may contribute up to 100% of their annual compensation as pre-tax elective contributions or Roth elective contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes 100% of the first 3% of compensation that a participant contributes and 50% of a participants contributions that are over 3% up to 5% of compensation. Each year the Company can make a discretionary contribution. Contributions are subject to certain IRS limitations.

C. Participants Accounts:

All Plan investments are participant directed. Plan participants have the option of having their contributions invested in a variety of mutual funds, pooled separate accounts and a guaranteed investment contract. Each participant's account is credited with the participants contributions and allocations of (a) the Company's contributions, (b) Plan earnings or losses and (c) charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earnings account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participants vested account.

D. Vesting:

Participants are immediately vested in their contributions and in the matching contributions by the employer. For the discretionary contribution made by the employer vesting is based on years of continuous service, a participant is 100% percent vested after six or more years of credited service.

NOTE 1 - DESCRIPTION OF PLAN: (Continued)

E. Notes Receivable from Participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 8.75% to 9.5%, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

F. Payment of Benefits:

On termination of service due to death or retirement a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. Participants electing to receive benefits after the normal retirement age of 65 may choose either a lump-sum amount or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan permits in-service and hardship withdrawals under certain conditions.

G. Forfeited Accounts:

Forfeited nonvested accounts of terminated participants can be used to pay plan expenses, offset employer contributions or reallocate the amounts to participant accounts. As of December 31, 2024 and 2023 forfeited nonvested accounts totaled \$137,611 and \$76,036 respectively. During the years ended December 31, 2024 and 2023 forfeitures of \$150,148 and \$88,903 respectively, were used to reduce the Employers discretionary contribution.

H. Investment Elections:

The participant contributions and Company contributions are allocated to the various investment options offered by the Plan as directed by participants.

I. Tax Status:

The prototype plan sponsor has obtained an opinion letter dated June 30, 2020 in which the IRS stated that the restated prototype plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The plan administrator timely adopted the restated prototype plan. The plan administrator believes that the plan is currently being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would be sustained upon examination by the applicable authorities. The plan is subject to routine audits by taxing jurisdictions; however there are currently no audits for any tax periods in progress.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES:

Basis of Accounting:

The financial statements of the Plan are prepared under the accrual basis of accounting.

Investments Valuation and Income Recognition:

Investments are recorded at fair value, except for fully benefit - responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 7 for discussion of fair value measurements.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES: (CONTINUED)

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The change in net unrealized appreciation/depreciation of investments held from the beginning of the plan year to the end of the plan year is included with realized gains/losses as net appreciation (depreciation) reported in the accompanying statements of changes in net assets available for benefits.

Use of Estimates:

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits:

Benefits are recorded when paid.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Expenses:

Certain expenses of maintaining the Plan are paid by the Employer and are therefore excluded from these financial statements. Included in administrative expenses are fees paid by the Plan for investment advisory and investment record keeping services including administration of notes receivable from participants. Investment related expenses are included in net appreciation in fair value of investments.

NOTE 3 - PLAN TERMINATION:

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants become 100 percent vested in their accounts.

NOTE 4 - PARTY IN INTEREST TRANSACTIONS:

The Plan was invested in pooled separate accounts and a guaranteed investment contract sponsored by Principal Life Insurance Company. These transactions qualify as party-in-interest transactions in addition to the participant loans. They are denoted as such on the supplemental schedule of assets (held at end of year). Principal Trust Company, trustee of the Plan is the custodian, record keeper and manages the assets. These transactions qualify as party-in-interest transactions. These transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 5 - RISK AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 7 - FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
 - *Quoted prices for similar assets or liabilities in active markets;
 - *Quoted prices for identical or similar assets or liabilities in inactive markets;
 - *Inputs other than quoted prices that are observable for the asset or liability;

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and December 31, 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts: Valued at the daily net asset value (NAV) of the fund. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The funds investments are invested directly in marketable securities that are valued at current market prices daily.

NOTE 8 - CERTIFIED INVESTMENTS:

The Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Trust Company, the trustee of the plan has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024; the related investment activity reflected in the statements of changes in net assets available for benefits for the year ended December 31, 2024 and 2023.

NOTE 9 - GROUP ANNUITY CONTRACT WITH PRINCIPAL INSURANCE COMPANY:

In December 2022 the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company totaling \$14,142,671 at December 31, 2024 and \$11,907,308 at December 31, 2023. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer and is 4.75% effective annual rate at December 31, 2024. The rate is reset semi annually. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability to the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from the contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

NOTE 10 - ROLLOVERS:

With the January 1, 2023 Plan restatement and amendment to Principals prototype 401(k) plan rollovers from qualified plans were allowed as an option to participants effective January 1, 2023. During the years ended December 31, 2024 and 2023 an aggregate of \$660,411 and \$808,349 respectively were rolled into the plan, and is included in rollovers on the Statement of Changes in Net Assets available for benefits.
