## **Municipal District Services, LLC 401(k) Plan**

### **NOTES TO THE FINANCIAL STATEMENTS**

#### **Note A - Description of the Plan**

The following description of the Municipal District Services, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### **General**

The Plan was established effective January 1, 2021, as a defined contribution plan for the benefit of eligible employees of Municipal District Services, LLC (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

#### **Administration**

Mid Atlantic Trust Company has been appointed the custodian of the Plan. PB&H Benefits, LLC has been appointed Third Party Administrator (“TPA”) of the Plan.

#### **Eligibility**

Employees of the Company, who have attained the age of 18, are generally eligible to participate in the Plan after one year of service. The entry date of the Plan for eligible participants is on the first day of the Plan Year quarter coinciding with or next following date requirements are met.

The plan excludes from participation union employees and non-resident aliens.

#### **Contributions**

Each year participants may contribute a percentage of their pre-tax annual compensation not to exceed the limitation (\$23,000 and \$22,500 in 2024 and 2023 respectively) set forth in Section 402(g) of the Internal Revenue Code (“IRC”). Participants who are (or will be) age 50 or older by the end of the calendar year may make pre-tax or after-tax catch-up contributions that exceed the annual elective deferral limit. Participants’ total catch-up contributions during 2024 and 2023 cannot exceed \$7,500 and \$7,500, respectively. Participants may also make rollover contributions from other plans.

The Company is required to make a qualified non-elective contribution to the Plan equal to the sum of 100% of the amount of the participant's elective deferrals that do not exceed 3% of the participant's compensation, plus 50% of the amount of the participant's elective deferrals that exceed 3% of the participant's

### **Note A - Description of the Plan, continued**

compensation but does not exceed 5% of the participant's compensation, as defined by the Plan's document. The Company made safe harbor contributions of \$491,657 in 2024.

The Plan also provides for discretionary Company profit sharing contributions. During 2024, the Company made no discretionary employer profit sharing contributions.

### **Participant Accounts**

Each participant's account is credited with the participant's contribution, the Company's matching contribution and an allocation of any non-elective contribution and earnings (losses) on the investments selected by the participant. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested interest in his or her account.

### **Investment Options**

Upon enrollment in the Plan, participants may direct the investment of their contributions and the Company's contributions into various investments offered by the Plan.

### **Vesting**

Participants are vested immediately in their elective contributions, rollover contributions and safe harbor contributions plus any earnings on such contributions. The vesting of discretionary Company contributions plus any earnings thereon is based on years of continuous service (as defined) accrued by the participant while in covered employment. Participants become 100% vested on a five-year graded vesting schedule.

### **Participant Loans**

Participants may borrow from their accounts on a pro-rata basis from all contribution sources up to a maximum equal to the lesser of \$50,000.00 or 50% of the participant's vested account balance. The minimum loan amount is \$1,000 and loan terms must not exceed five (5) years unless the loan is to be used in the financing of the participant's homestead in which case the loan may be payable in terms of similar length provided by conventional lending institutions. The loans are secured by the vested balance in the participant's account and bear an interest rate at the local prevailing rates as determined by the Plan Administrator. Principal and interest payments are made by means of payroll withholdings according to the terms of the promissory note and the Plan document. A participant may have only one loan outstanding at any time and loan refinancing is permitted.

### **Payment of Benefits**

Upon termination of employment due to death, disability, attainment of age 59 ½ or retirement, a participant (or his/her designated beneficiary in the event of death) may elect to receive a lump-sum amount. For

#### **Note A - Description of the Plan, continued**

termination of employment due to other reasons, the vested interest in his or her account may be distributed as rollover to another plan, a lump-sum distribution or it may be left in the Plan if the account balance is greater than \$5,000.

#### **Forfeited Accounts**

All employer contributions credited to a participant's account, but not vested, are forfeited by the participant upon his/her termination from the Plan. Per the Plan document forfeitures may be used to first reduce the Company's contributions and then to offset future employer contributions. In addition, forfeitures may also be used to pay plan expenses. As of December 31, 2024, there were no forfeitures that have not yet been applied.

#### **Administrative Expenses**

In 2024 the plan was primarily responsible for payment of fees. Such expenses paid by the participants during the year ended December 31, 2024 were approximately \$4,450.

#### **Note B - Summary of Significant Accounting Policies**

##### **Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

##### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amount of net assets available for the benefits and changes therein. Actual results could differ from those estimates.

##### **Risk and Uncertainties**

The Plan provides for various investment options. These investment options are exposed to market risk, which generally means the risk of loss in the value to certain investment securities due to changes in interest rates, commodity prices and general market conditions. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

## **Note B - Summary of Significant Accounting Policies, continued**

### **Investment Valuation and Income Recognition**

Investments are stated at fair value, which is determined using quoted market prices. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements. Net appreciation (depreciation) in fair value of investments includes realized gains and losses on investments bought and sold during the year and unrealized appreciation (depreciation) of investments held at the end of the year. The Plan offers investments in mutual funds, and guaranteed investments contracts (GIC's). Mutual funds are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The guaranteed investment contract is equal to participant deposits minus participant withdrawals plus credited interest. Interest credited is net of expenses. Contract value may be subject to market value adjustments in connection with contract holder directed withdrawals or under limited circumstances for certain in-service participant withdrawals. See Note C for a discussion of investments in fully-benefit responsive investment contracts

### **Subsequent Events**

The Plan has evaluated subsequent events through October 9, 2025 the date which the financial statements were available to be issued. No events have occurred subsequent to the date of the statement of net assets available for benefits that would require adjustment to, or disclosure in, the financial statements.

### **Contributions**

Contributions from employees and the Company are recorded in the period in which the Company makes the payroll deductions from participant accounts.

### **Benefit Payments**

Benefits are recorded when paid.

## **Note C - Guaranteed Investment Contract**

On December 31, 2024, the Plan had a traditional fully benefit-responsive guaranteed investment contract, in the amount of \$295,930, with Reliance Trust Company ("RTC"). RTC Stable Value Fund Collective Investment Trust, Series 25053 was formed for the purpose of allowing participating plan sponsors, who maintained defined contribution plans qualified under Sections 401(a) and 501(a) of the IRC, to invest in MetLife Group Annuity Contract 25053 and MetLife Group Annuity Contract 37000 ("Contracts") issued by Metropolitan Life Insurance Company to RTC, for use as the primary underlying investments for their stable value collective investment trust fund. RTC is a wholly owned subsidiary of Reliance Financial Corporation. Reliance Financial

### **Note C - Guaranteed Investment Contract, continued**

Corporation is an indirect wholly owned subsidiary of Fidelity National Information Services, Inc. Units are issued and redeemed daily at contract value. Contract value represents contributions, plus interest, less participant-initiated withdrawals, or transfers.

The Stable Value Fund is stated at contract value and invests in an actively managed, highly diversified portfolio of fixed and floating rate securities. MetLife, an AA-rated company, guarantees the contract value of the SVF and is the sole wrap provider. The fair value of the underlying Contracts is determined by MetLife based on quoted market prices of the underlying investments owned by MetLife.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

### **Note D - Fair Value Measurements**

FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted process for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical assets or liabilities in inactive markets.
- Inputs other than quoted process that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset of liability.

**Note D - Fair Value Measurements, continued**

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use to unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024.

*Mutual Funds:* These investments are valued daily at the net asset value of shares or units held by the Plan based on the quoted market value of the underlying assets. All investments in this category can be redeemed daily, have a daily redemption notice period, and have no unfunded commitments. The investments underlying the accounts primarily include domestic and global equities, domestic and global fixed income securities, real estate and cash or cash equivalents. The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The following tables set forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2024.

**Note F – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note G – Tax Status**

The IRS has determined and informed the Company’s document provider by an opinion letter dated March 31, 2014, that the Volume Submitter Profit Sharing Plan with CODA is acceptable under section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. Although the Plan has not received a determination letter and has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been made in the financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note H –Related-Party and Party-in-Interest Transactions**

The Plan allows participant loans. These transactions qualify as party-in-interest transactions. However, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

Certain Plan investments are funds managed by the Trustee and the Custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment

management services and certain administrative fees related to the related to the administration of the Plan were paid by the Plan or by the Company. These transactions qualify as party-in-interest transactions.

**Note I – Benefit Claims Payable**

On December 31, 2024, there were no benefit claims payable for distributions requests made prior to year-end.

**Note J– Recent Accounting Pronouncements**

Recent accounting pronouncements issued by the FASB did not or are not believed by management to have a material impact on the Plan’s present or future financial statements.
