## INDEPENDENT AUDITORS' REPORT

To the Participants and 401(k) Committee of the  
American Public Education Retirement Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of American Public Education Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the American Public Education Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Fidelity Management Trust Company, the Trustee, as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

### 1. DESCRIPTION OF THE PLAN

The following description of the American Public Education Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### **General**

American Public Education Retirement Plan is a 401(k) profit sharing plan covering all eligible employees of American Public Education, Inc. (“APEI” or the “Company”) under the Plan’s provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

#### **Eligibility**

All employees of the Company and its participating subsidiaries are eligible to participate in the Plan except for employees covered by a collective bargaining agreement, non-resident aliens who do not receive income from the Company or its subsidiaries which constitutes United States income, leased employees, work study employees and residents of Puerto Rico. Employees are eligible to participate in the Plan immediately upon hire. Employees are eligible to receive Company contributions after one year of service with at least 1000 service hours.

#### **Contributions**

Each year, participants may contribute a specified dollar amount or percentage of their eligible compensation (as defined in the Plan and up to the annual Internal Revenue Service (“IRS”) maximum) on a pre-tax basis not to exceed the lesser of 60% of compensation or IRS limits, which totaled \$23,000 for the year ended December 31, 2024. Participants who have attained or are expected to attain the age of 50 before the end of the Plan year are eligible to make additional pre-tax catch-up contributions. For the year ended December 31, 2024, the maximum allowable amount for catch-up contributions totaled \$7,500. Participants may also make Roth elective contributions to the Plan. The participants’ Roth elective contributions are allocated to a separate account maintained for such contributions. Roth elective contributions are treated as elective contributions for all purposes under the Plan. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

### 1. DESCRIPTION OF THE PLAN – cont’d.

#### Contributions – cont’d.

The Plan allows for automatic enrollment whereby employees are automatically enrolled in the Plan within 30 days of hire at a contribution rate of 5% of eligible compensation, unless the employee affirmatively elects not to contribute or to contribute a different amount. All contributions made under the Plan are subject to all applicable IRS limits.

With respect to each eligible participant, the Company makes an annual non-elective discretionary contribution equal to 50% of the first 8% of eligible compensation contributed to the Plan. Additional amounts may be contributed by the Company in its sole discretion.

The Company made discretionary non-elective Company contributions totaling \$6,288,977 for the year ended December 31, 2024.

#### Participant Accounts

Each participant’s account is credited with the participant’s contributions and allocations of (a) the Company’s contribution (as described above) and (b) Plan earnings/losses, and charged with administrative expenses, if applicable. Allocations of earnings and losses are based on the investment options elected by a participant and the amounts contributed to those elections. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account in the Plan. The Plan is intended to comply with Section 404(c) of ERISA.

#### Vesting

Participants are immediately vested in their pre-tax contributions, any rollover contributions, and any discretionary non-elective Company contributions to the Plan, plus actual earnings thereon. Effective January 1, 2022, the Plan was amended and restated to include the following additional vesting schedules for Company matching contributions, discretionary and non-elective discretionary contributions of termed participants that merged from the Rasmussen, LLC 401(k) Employee Retirement Savings Plan and Trust.

#### Payment of Benefits

Upon termination of service, death, disability, retirement, or the attainment of age 59 ½, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installment payments. If a participant's account balance is \$1,000 or less upon termination of service, the Plan administrator will direct the Trustee (as defined by the Plan) to make a lump-sum distribution. If a participant's account balance is more than \$1,000 but less than \$5,000 upon termination of service, the Plan administrator may direct the Trustee to distribute the amount from the Plan without the participant's consent by rolling it over to an individual retirement plan. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed may be withdrawn for a hardship purpose, subject to a \$500 minimum. Certain income tax penalties may apply to withdrawals or distributions prior to age 59 ½. As of December 31, 2024 and 2023, there were no net assets of the Plan allocated to participants who had elected to withdraw from the Plan but had not been paid by year-end.

#### Notes Receivable from Participants

Participants may borrow up to 50% of their vested account balance, not to exceed \$50,000, without regard to the intended use of the funds. The minimum note amount is \$1,000 and a participant may hold only one outstanding note at any given time. The notes are collateralized by the participant's vested account balance. Note repayments are to be made each pay period through payroll deductions. The interest rate for the duration of the note is comparable to those offered for comparable borrowings by financial institutions at the time of note origination. Participants are assessed an annual fee of \$25 for each outstanding note. Notes taken for the purchase of a primary residence are required to be paid within ten years. All other notes must be paid within five years.

#### Plan Expenses

The Plan's direct administrative expenses are paid by either the Plan or the Company as provided by the Plan. Expenses that are paid directly by the Company are excluded from the Plan's financial statements. During the year ended December 31, 2024, there were on administrative expenses paid by the Company.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements are prepared under the accrual method of accounting whereby income is recognized when earned and expenses are recognized when incurred.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Use of Estimates**

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought, sold, and held during the year.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – cont'd.

#### Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement*, defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

- *Interest bearing cash*: Valued at amortized cost plus accrued interest, which approximates fair value.
- *Interest in registered investment companies*: Valued at the closing price of shares held by the Plan at year-end. Shares are traded on an active market.

**Fair Value Measurement – cont’d.**

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

**Notes Receivable from Participants**

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes are treated as deemed distributions based on the terms of the Plan agreement.

**Payment of Benefits**

Benefits are recorded when paid.

**Subsequent Events**

The Plan evaluated for disclosure any subsequent events through October 9, 2025, the date the financial statements were available to be issued, and determined there were no material events that warrant disclosure.

### 3. INVESTMENTS

All investment information disclosed in the accompanying financial statements and supplemental schedule, including assets held at December 31, 2024 and 2023, and interest and dividend income and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Trustee of the Plan, Fidelity Management Trust Company (“FMTC” or the “Trustee”).

### 4. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Fidelity Investments. The Trustee is a subsidiary of Fidelity Investments (collectively “Fidelity”). The Company provides certain accounting and administrative services to the Plan for which no fees are charged. The Plan allows participants to borrow against their vested account balances. All such transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules.

### 5. INCOME TAX STATUS

The Plan adopted a standardized prototype plan with a deferral arrangement, which received an opinion letter from the Internal Revenue Service dated June 30, 2020. The opinion letter states that the Plan document is acceptable and may be relied on by an adopting employer with respect to the qualification of the Plan under Section 401(a) of the Internal Revenue Code of 1986, as amended (“IRC”), as provided in Revenue Procedure 2011-49. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan continues to be qualified, and the related trust tax-exempt.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. Given the Plan is tax exempt and has no unrelated business income, the provisions of ASC 740 do not have an impact on the Plan’s financial statements. The Plan recognizes interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of December 31, 2024 and 2023.

The Plan is subject to routine audits by the IRS and Department of Labor; however, no reporting periods are currently under audit.

**6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, affected participants will become 100% vested in their accounts and the net assets of the plan will be distributed to participants based upon individual account balances.

**8. EXCESS CONTRIBUTIONS PAYABLE**

The Plan refunded these excess contributions to affected participants in February 2025.
