## INDEPENDENT AUDITOR'S REPORT

To The Albertsons Companies Retirement Benefit Plan Committee

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Albertsons Companies 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

## NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

### 1. DESCRIPTION OF THE PLAN

The following description of the Albertsons Companies 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Summary Plan Description for more complete information about the Plan's provisions. The following description reflects all Plan amendments through December 31, 2024.

**General** - The Plan is a defined contribution plan which generally covers employees of Albertsons Companies, Inc. (the "Company" or "Plan Sponsor") who are age 21 or older, excluding those employees who are eligible to participate in the Vons Companies, Inc. Pharmacists' 401(k) Plan and leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Albertsons Companies Retirement Benefit Plans Committee (the "Committee") controls and manages the operation and administration of the Plan. The Plan uses Fidelity Management Trust Company (Fidelity) as trustee and Fidelity Workplace Services, LLC as recordkeeper.

The Plan document was restated effective January 1, 2024 to include all prior amendments made to the 2018 restatement, delete certain collectively bargained provisions no longer applicable, and make additional changes required by the Setting Every Community Up for Retirement Enhancement 2.0 Act of 2022 ("SECURE 2.0").

**Plan Mergers** - Effective January 1, 2018, the Albertson's LLC 401(k) Plan, the New Albertson's, Inc. 401(k) Plan, the United Supermarkets LLC 401(k) Retirement and Savings Plan and the Llano Logistics, Inc. 401(k) Retirement Savings Plan (the "Merged-In Plans") were merged into and with the Safeway 401(k) Plan. At such time, the Plan Sponsor changed to Albertsons Companies LLC and the Plan name changed from the Safeway 401(k) Plan to the Albertsons Companies 401(k) Plan. All of the Merged-In Plans net assets were transferred to the Plan on December 29, 2017.

**Contributions** - Contributions to the Plan include (i) pre-tax and Roth salary reduction contributions authorized by participants, (ii) matching contributions made by the Company, (iii) discretionary contributions made by the Company; and (iv) participant rollovers from other qualified retirement plans.

Participants may elect to contribute between 1% and 75% of their eligible pay in the form of pre-tax and/or Roth salary reduction contributions, up to a maximum contribution of \$23,000 for 2024 and \$22,500 for 2023, according to limitations under the Internal Revenue Code (the "Code"). Participants may also elect an automatic increase in their deferral contributions from 1% to 3%. Participant pre-tax contributions are not currently taxable to participants pursuant to Section 401(k) of the Code.

Participants age 50 or over by the end of the applicable Plan year are eligible to contribute additional catch-up contributions of \$7,500 for 2024 and 2023 to their 401(k) account before the end of the Plan year. Catch-up contributions may be in the form of pre-tax and/or Roth salary reduction contributions.

The Company may make a matching contribution to eligible non-union employees equal to a percentage of regular 401(k) contributions (not "catch up" contributions) up to 7% of eligible compensation for that Plan year. In order to be eligible to receive a matching contribution, employees generally must be employed for one year, complete 1,000 hours of service within a year, employed by the Company on the last day of the year and may not be an active participant in the Employee Retirement Plan of Safeway Inc. and its Domestic Subsidiaries ("ERP"). Certain union represented employees are eligible for the same discretionary matching contribution described above if provided for in their collective bargaining agreement. Certain other union

represented employees may have different eligibility criteria and/or contribution formulas for the Company matching contributions as provided in their collective bargaining agreement.

**Investment Options** - Participants may direct their Plan accounts in any one or combination of investment funds. The Plan's current investment offerings include registered investment companies, common collective trusts, separately managed accounts and the Interest Income Fund. Participants may change their investment options on a daily basis.

**Allocations and Vesting** - Earnings on amounts held in the investment funds are allocated to individual accounts daily, based on the proportion each account bears to the total of all account balances in the specific investment fund. Participants are 100% vested in their elective deferrals and earnings, and the amounts credited to their Haggen Union Matching Account (if applicable). Participants vest in the Company's matching and prior contributions, as follows:

**Participant Accounts** - Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, an allocation of the Company's matching contributions (as applicable), an allocation of Plan earnings, and charged with administrative expenses and investment and management fees as outlined within the Plan document. Allocations are based on participant earnings or contributions as defined. The benefit to which a participant is entitled is the value of the participant's vested account.

**Notes Receivable from Participants** - Participants may borrow a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. The loan term cannot exceed five years, except where the loan is issued to purchase a primary residence, in which case the loan period may extend to 15 years. Loans are secured by the balance in the participant's account. The interest rate charged on participant loans shall be a fixed reasonable rate of interest, determined from time to time by the Committee, which provides the Plan with a return commensurate with the prevailing interest rate charged by persons in the business of lending money for loans which would be made under similar circumstances. Principal and interest payments are made through payroll deductions. Participants may make loan payments directly to the recordkeeper after termination of employment, after transfer to another plan within the Company's control group or when paying off the loan outside of the payroll system. Participants may have a maximum of two outstanding loans, one general purpose and one principal residence, and are charged a loan application fee of \$75.00. As of December 31, 2024, participant loans have maturities through 2039, with interest rates ranging from 3.25% to 9.5%. Participant loans are held by the Plan outside of the Albertsons Companies Master Trust (the "Master Trust").

**In-Service Withdrawals** - An active or inactive participant may withdraw all or any portion of their rollover account or certain prior accounts, if applicable, at any time. The Plan also provides for in-service withdrawals for participants who are age 59 1/2. In addition, certain participants on military service may take an in-service qualified reservist distribution of all or any portion of their 401(k) account, in accordance with guidance from the Internal Revenue Service ("IRS"). An active or inactive participant may take a hardship withdrawal if there is an immediate and significant financial need.

**Payment of Benefits** - Upon termination of employment, a participant may elect (a) to leave the balance of his or her account in the Plan until April 1 of the year following the year in which the participant turns age 73, (b) to receive an immediate lump sum distribution as cash, or as a rollover to another qualified plan or Individual Retirement Account ("IRA"), (c) to receive a portion in an immediate lump sum and the remainder to be distributed later, or (d) to receive a series of payments over a period not to exceed the joint life expectancy of the participant and his or her beneficiary. If a participant's balance is \$1,000 or less, and the participant does not elect a distribution of funds as a direct rollover or to be payable to the participant, the account will be distributed in accordance with Plan provisions to be payable to the participant, subject to income tax withholding. If the participant's balance is \$7,000 or less, but greater than \$1,000, and the participant does not elect a distribution of funds as a direct rollover or to be payable to the participant, the account will be automatically rolled over into an IRA designated by the Plan Administrator in accordance with Plan provisions.

**Plan Termination** - Although the Company has not expressed any intent to terminate the Plan, it may do so at any time, subject to the provisions set forth in ERISA. In the event of termination of the Plan, the assets of the Plan would be distributed to the participants in accordance with the value of their individual investment accounts.

**Forfeited Accounts** - When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. The Plan document permits the use of forfeitures to either reduce future Company contributions or pay Plan Administrative expenses for the Plan year. However, if a participant is reemployed and fulfills certain requirements, as defined in the Plan document, the account will be reinstated using forfeitures (if any). At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$13,328,271 and \$11,180,708, respectively. During 2024, Company contributions were reduced by \$8,470,413 from forfeited nonvested accounts.

**Subsequent Events** - Subsequent events were evaluated through October 10, 2025, the date the financial statements were available to be issued. The Plan was amended in 2025 to reflect certain optional distribution provisions under SECURE 2.0, including federal disaster distributions and domestic abuse distributions. No other events occurred that require additional disclosure or adjustments to the Plan's financial statements.

## 2. SUMMARY OF ACCOUNTING POLICIES

**Basis of Accounting** - The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Investment Valuation and Income Recognition** - A portion of the Plan's investments are held in a Master Trust that was established for the investment of assets of the Plan and another Albertsons Companies, Inc sponsored retirement plan. Each participating retirement plan has an undivided interest in the master trust. The Master Trust's investments are stated at fair value, except for fully benefit-responsive synthetic guaranteed investment contracts (GICs), which are reported at contract value. The fair value of the Plan's interest in the Master Trust is based on the beginning of year value of the Plan's interest in the Master Trust, plus actual contributions and allocated investment income, less actual distributions and allocated administrative expenses, plus or minus changes in unrealized gains and losses. As of December 31, 2024 and 2023, the Plan's interest in the net assets of the Master Trust were approximately 98.3% and 98.4%, respectively.

Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). Contract value is the amount Plan participants would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 4 for discussion on master trust financial information.

Purchases and sales of securities are recorded on the trade date. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in mutual funds, common collective trusts and the Interest Income Fund are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment returns for such investments.

**Contributions** - Employee contributions are recorded when withheld and employer matching contributions are recorded when the associated employee contributions are recorded.

**Payment of Benefits** - Benefit payments to participants are recorded upon distribution. There were no amounts allocated to accounts of participants who have elected to withdraw from the Plan, but have not yet been paid, at December 31, 2024 and 2023.

**Notes Receivable from Participants** - Participant loans are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

**Excess Contributions Payable** - The Plan is required to return contributions received during the Plan year in excess of the Code's limits.

**Administrative Expenses** - Administrative expenses of the Plan are paid by the Plan or the Plan Sponsor, as provided in the Plan document. Investment management fees for investments are included as a reduction of investment return and not reflected separately in the statement of changes in net assets available for benefits.

Administrative expenses per annum per participant are deducted from participant accounts. Administrative expenses per annum per participant limits were \$33 effective January 1, 2024 through June 30, 2024 and changed to \$31 per annum per participant effective July 1, 2024. Participants also pay administrative costs for loans, distributions, and qualified domestic relation orders. The remaining expense is paid by the Company and through credits provided by the recordkeeper for Plan investments.

**Use of Estimates** - The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

**Risks and Uncertainties** - The Plan invests in the Master Trust which utilizes various investment instruments, including registered investment companies, common collective trusts, separately managed accounts and the Interest Income Fund. Investment securities, in general, are exposed to various risks, such as interest rate, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the value of the participants' account balances and the amounts reported in the financial statements.

### 3. CERTIFIED INVESTMENT INFORMATION

The following is a summary of the certified investment information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedules, that was prepared by or derived from information certified by the trustee of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained certification from the trustee that such information is complete and accurate.

#### 4. MASTER TRUST FINANCIAL INFORMATION

The trustee holds the Master Trust's investment assets, provides administrative functions for each of the Plans participating in the Master Trust, and executes investment transactions as directed by participants. Use of the Master Trust permits the commingling of Plan assets with the Vons Companies, Inc. Pharmacists' 401(k) Plan. Although assets of each of the plans are commingled in the Master Trust, the trustee maintains supporting records for each participating plan. The net investment income or loss of the investment assets is allocated daily by the trustee to each participating plan based on the relationship of the interest in each plan to the total of the interests of all participating plans.

*Fair Value Measurements* - The accounting guidance for fair value measurements defines fair value, established a framework for measuring fair value, and requires disclosures about fair value measurements. The guidance prioritizes the inputs for measuring fair value into the following hierarchy:

*Level 1* - Quoted prices (unadjusted) in active markets for identical assets or liabilities;

*Level 2* - Inputs other than quoted prices included within Level 1 that are either directly or indirectly observable; and

*Level 3* - Unobservable inputs in which little or no market activity exists, therefore requiring an entity to develop its own assumptions about the assumptions that market participants would use in pricing.

The level within the fair value hierarchy is based on the lowest level of any input which is deemed significant to the fair value measurement. The Plan's policy is to recognize significant transfers between levels at the end of the reporting period. In accordance with the accounting guidance for fair value measurements, the table below includes the major categorization for debt and equity securities on the basis of nature and risk.

**Transfers between Levels** - The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

The significance of transfers between levels is evaluated based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the years ended, December 31, 2024 and 2023, there were no transfers between levels.

**Asset Valuation Techniques** - Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value.

*Registered Investment Companies (mutual funds)* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Separately Managed Accounts* - This is a portfolio of individual securities, such as stocks or bonds, that is managed on the participant's behalf. Unlike a mutual fund or exchange-traded fund, the plan directly owns the individual securities instead of pooling his/her assets with other investors. The individual assets of a separately managed account/fund are held in the name of the plan (the plan owns the underlying securities) and are generally considered separately as individual investments for accounting, auditing and financial statement reporting purposes.

*Common/Collective Trusts* - Common/collective trusts invest primarily in a pool of investments, including equity securities, fixed income securities, and commodities. Common/collective trusts are valued at the net asset value of units of a bank collective trust. The net asset value, as provided by the trustee, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in

order to ensure that securities liquidations will be carried out in an orderly business manner. There were no unfunded commitments, normal course of business redemption restrictions, or other redemption restrictions on these funds at December 31, 2024 or 2023.

*Interest Income Fund* - The Master Trust holds a portfolio of synthetic investment contracts. These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The Master Trust owns the underlying assets of the synthetic investment contract. A synthetic investment contract includes a wrapper contract, which is an agreement for the wrap issuer, such as a bank or insurance company, to make payments to the Plan in certain circumstances. The wrapper contract typically includes certain conditions and limitations on the underlying assets owned by the Master Trust.

The synthetic investment contracts held by the Plan include wrapper contracts that provide a guarantee that the credit rate will not fall below 0%. Cash flow volatility (for example, timing of benefit payments) as well as asset underperformance can be passed through to the Plan through adjustments to future contract crediting rates. Formulas are provided in each contract that adjusts renewal crediting rates to recognize the difference between the fair value and the book value of the underlying assets. Crediting rates are reviewed monthly for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code
- Premature termination of the contracts
- Plan termination or merger
- Changes to the Plan's prohibition on competing investment options
- Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines
- A breach of material obligation under the contract
- A material misrepresentation
- A material amendment to the agreements without the consent of the issuer

## **5. EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by Fidelity. Fidelity is the trustee as defined by the Plan, and these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were paid from a Fee Account funded by quarterly fees charged to each participant with a balance.

## **6. NONEXEMPT PARTY-IN-INTEREST TRANSACTIONS**

The Company remitted certain participant contributions during the year ended December 31, 2023, totaling approximately \$582,433, to the trustee later than required by Department of Labor (DOL) Regulation 2510.3 102. The company fully corrected the late deposits in 2024 and has filed the Form 5330 in 2024 with the IRS and paid the required excise tax on the transactions. The correction included crediting participant accounts with the amount of investment income that would have been earned had the participant contribution been remitted on a timely basis.

## **7. FEDERAL INCOME TAX STATUS**

The IRS has determined and informed the Company by a letter dated February 16, 2017, that the Plan and related trust were designed in accordance with the applicable regulations of the Code. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the Code, and the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.
