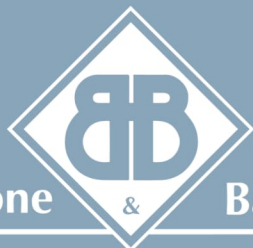

## INDEPENDENT AUDITORS' REPORT

To the Trustees  
MLT 401(K) and Profit Sharing Plan

### Opinion

We have audited the accompanying financial statements of MLT 401(K) and Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of MLT 401(K) and Profit Sharing Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**GENERAL**

The Plan is a defined contribution plan covering all employees of MLT Transport, LLC (the Company), who have attained six months of service as defined by the Plan and attained the age of 20. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**EMPLOYER AND EMPLOYEE CONTRIBUTIONS**

Contributions to the Plan are made as follows:

**EMPLOYEE SALARY DEFERRAL** - Employees may enter into a compensation deferral agreement with the Company to designate the amount to be deferred. An employee may defer not less than 1% and not more than 90% of his or her compensation up to the statutory limit. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and money market accounts as investment options for participants.

**EMPLOYER SAFE HARBOR CONTRIBUTION** - The Company is required to make a safe harbor contribution to the Plan on behalf of each eligible employee. The required contribution is equal to 3% of the employee's eligible compensation for the year. The safe harbor contribution was \$198,620 and \$198,359 for the years ended December 31, 2024 and 2023, respectively.

**EMPLOYER DISCRETIONARY CONTRIBUTIONS** - The Company may make a discretionary contribution to the Plan in an amount determined by management. Contributions are allocated on a ratio of each participant's compensation to total compensation. The discretionary contribution was \$0 for each of the years ended December 31, 2024 and 2023, respectively.

**PARTICIPANT ACCOUNTS**

Participants have segregated accounts which are credited with the participant's contributions and the respective investment earnings and charged with an allocation of any investment administrative expenses paid by the Plan. Allocations are based on investment earnings on account balances, as defined. The participant is entitled to the balance in the participant's vested account.

**VESTING**

Participants are 100% vested in salary deferrals, employer profit-sharing contributions, and employer safe harbor contributions plus earnings thereon at all times.

**PAYMENT OF BENEFITS**

Upon termination of services, a participant may elect to receive his vested interest as a lump sum payment or in installments. If the vested account balance does not exceed \$5,000, the payment must be in a lump sum. In-service distributions are permitted pursuant to the terms of the Plan.

**RECLASSIFICATIONS**

Certain reclassifications have been made to the prior year financial statements to conform to the classifications used in the current year. Prior year net income was unchanged due to the reclassifications.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**DATE OF MANAGEMENT'S REVIEW**

Subsequent events were evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

**BASIS OF ACCOUNTING**

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**USE OF ESTIMATES**

The process of preparing financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of Plan assets, liabilities, additions, and deductions at the date of the financial statements. Such estimates primarily relate to unsettled transactions and events as of the date of the financial statements. Accordingly, upon settlement, actual results could differ from estimated amounts.

**INVESTMENT VALUATION AND INCOME RECOGNITION**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Appreciation (depreciation) represents the difference between the values of the investments at the end of the Plan years plus any gains or losses from sales of investments during the Plan year.

**PAYMENT OF BENEFITS**

Benefits are recorded when paid.

**EXPENSES**

All operating expenses of the Plan are paid by the Company and are therefore excluded from these financial statements. Investment administrative fees are paid by the Plan.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of inputs of the fair value hierarchy are: Level 1 - quoted prices in active markets for identical assets; Level 2 - significant other observable inputs; and Level 3 - significant unobservable inputs. As of December 31, 2024 and 2023, the Plan had no assets which were required to be measured using Level 2 or Level 3 inputs.

**NOTE 4 – RELATED PARTY TRANSACTIONS**

The administrative expenses recorded were charged by RFM Financial Solutions, LLC, for investment management, and by The Retirement Advantage for plan administration. Both RFM Financial Solutions, LLC, as the investment manager, and The Retirement Advantage as the third-party administrator, qualify as a parties-in-interest.

All other Plan expenses were paid by the Company. As the Company is the Plan sponsor, the Company qualifies as a party-in-interest.

Charles Schwab & Co. is the custodian of the Plan's assets, who qualifies as a party-in-interest.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 5 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan sponsor has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants would become 100% vested in any unvested employer contributions.

**NOTE 6 – TAX STATUS**

The Plan has been determined to be acceptable for the Plan under the Internal Revenue Code by a letter dated June 30, 2020. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt.

**NOTE 6 – TAX STATUS (Continued)**

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. Generally, the Plan's tax filings remain open for three years for Federal income tax examination.

**NOTE 7 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 8 – PLAN AMENDMENTS**

Effective May 1, 2023, the Plan was amended to allow the employees to designate some or all of their elective deferrals as ROTH contributions.

**NOTE 9 – SECURE ACT 2.0**

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023, which included the SECURE Act 2.0. This act contains over 90 new retirement provisions with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Most of the significant provisions will become effective in 2024 and thereafter. Accordingly, there is no material impact on the Plan's 2024 and 2023 financial statements.
